our revenues fall, similarly. The Board will be reviewing
the budget quarterly to closely monitor these factors and

Administrative Items

Item 3: Authorized advertisement of a Public Hearing on **Amendments to Motor Vehicle and Traffic County Code 82** to align with changes made by the Virginia General Assembly. The Public Hearing will be **June 9 at 4 p.m.** The full item can be read on pages 13 - 23 of the Board Package.

Item 4: Authorized the **Department of Neighborhood and Community Services** to apply for a **Preschool Development Grant Birth to Five** from the Virginia Early Childhood Foundation. *The full item can be read on pages 24 - 38 of the Board Package.*

Item 5: Authorized the **Fairfax-Falls Church Community Services Board** to apply for grant funding for **Behavioral Health Docket Diversion Programs**. This funding will enhance identification, diversion, and connection of **persons with mental illness** or cooccurring substance abuse disorders at the **earliest possible point** of contact with the criminal justice system. *The full item can be read on pages 39 - 42 of the Board Package.*

Item 6: Approved RTAP Traffic Calming Measures consisting of **four speed humps on Quander Road between Fort Hunt Road and Beacon Hill**. The full item can be read on pages 43 - 48 of the Board Package.

Action Items

Item 3: Amended Fairfax County's Citizen Participation Plan and Consolidated Plan One-Year Action Plan for FY 2020. The amendments establish expedited procedures for drafting, proposing or amending the Action Plan, to include: virtual public hearings, changes in advertisement of meetings and incorporation of new federal coronavirus response funding in its planned uses. The full item can be read on pages 249 - 264 of the Board Package.

Item 4: Authorized the Fairfax Relief Initiative to Support Employers (Fairfax RISE). The Grant Program is available to small businesses and "non-safety net" non-profit organizations to subsidize the cost of business interruptions caused by closures. It expands eligibility to certain entities that were restricted in the Microloan Program, such as, home-based businesses, sole proprietary businesses and age-restriction businesses (such as breweries and wineries). Eligible entities can apply for up to \$20,000. In additional, a separate \$5 million 'Non-profit Sustainability Program' is being established to provide grants for safety-net non-profits. Public Hearings

Adoption of an Uncodified Ordinance to Establish Methods to Assure Continuity in Fairfax County Government and Conduct of Meetings of Boards, Authorities, and Commissions Within Fairfax County Government During the Novel Coronavirus Disease 2019 (COVID-19) Emergency, and to Repeal the Emergency Ordinance Adopted on April 14, 2020, Which is Hereby Replaced

Approved an uncodified ordinance to **establish methods to ensure continuity** in the conduct of **Boards, Authorities and Commissions (BACs) meetings during the COVID-19 emergency** and to repeal the emergency ordinance adopted on April 14. This allows the **BACs to meet entirely electronically**, at times that it is **unsafe or impractical to meet in-person**. The full item can be read on pages 274 - 288 of the Board Package.

Adoption of an Uncodified Ordinance to Extend the Validity of Certain Development Approvals to Assure Continuity in Fairfax County Government During the Novel Coronavirus Disease 2019 (COVID-19) Emergency, and to Repeal the Emergency Uncodified Ordinance on the Same Subject, Which Was Adopted on April 14, 2020, and Is Hereby Replaced

Approved the extension of the **validity of all expiring Director-approved land development items until 60 days following** the Board mandated COVID-19 emergency ends. Our office and County staff have **received requests from homeowners and**

professional organizations to extend the validity of plans and permits already approved by the Department of Land Development Services(LDS). LDS finds many of these permits are set to expire. While the LDS Director is able to extend approvals on a case by case basis, the Board streamlined this process by extending all approveditems. Update from the Governor's Office

Yesterday, Governor Northam announced that **Northern Virginia will delay a gradual reopening into Phase I** of Forward Virginia **until May 29**. Northern Virginia's health data is **significantly different** than the rest of the Commonwealth as is the **population and density** of our region. The population of Fairfax County alone is greater than eight states.

The Governor's plan suggests **certain data benchmarks** should be met ahead of reopening. Northern Virginia Health Directors report that **we don't meet those health criteria** needed to move forward. That data includes:

- A downward trend of **positive tests** for over 14 days
- A downward trend of **hospitalizations** for over 14 days
- An **increased capacity** for both testing and contact testing
- Sufficient hospital beds and ICU capacity
- A sustained supply of personal protective equipment

Although **social distancing and access to PPE is working** to flatten the curve, we are still in the **exponential growth cycle** of our epidemic curve. That means for now **cases are still increasing**. In Northern Virginia as a whole, the **percentage of positive cases** of those tested is 25%, while the rest of the state is at 10%. You can see the **data laid out by our Health Directors** here and Fairfax County's case data here.

NEW! COVID-19 Case Dashboard

The Fairfax County Health Department has added **new data points** to its COVID-19 Case Data Dashboard in an effort to keep the public informed during the COVID-19 emergency. The dashboard now includes: **probable cases, deceased cases by age group and COVID-19 testing by week**. The case rates are now presented by **5-digit zip codes**.

Happening in the District

Mount Vernon Athletic Club

Fairfax County has purchased the **closed Mount Vernon Athletic Club** with plans to establish a **multi-service center** to meet the immediate needs of **neighborhoods in the Buckman Road area** on the west side of Richmond Highway in Alexandria. When complete, the center will provide **recreation**, **youth programs and other equitable**, **accessible and effective resources** for the community. The Mount Vernon Athletic Club has been a **beloved recreation center** for many in our area, and its acquisition **creates new opportunities** for the surrounding neighborhoods. I look forward to engaging with the community to **envision and create** the new and much desired **recreation and human development opportunities** long needed in this area. Learn more...

Floating Litter Trap Installed in Little Hunting Creek

Although **stream litter** is a **problem** throughout the County, **Little Hunting Creek** has a reputation for being **one of the worst**. For years, volunteer organizations have worked together with county staff to **remove litter and debris** from the stream located near the **Richmond Highway corridor**. For example, a 2016 watershed cleanup event led by the Friends of Little Hunting Creek collected 423 bags of trash, 29 tires, and 10 shopping carts. In April, a Bandalong **floating litter trap was placed in the stream** and anchored in place. Learn more...
