

At Tuesday's Board meeting, we designated **June 3 as Gun Violence Awareness Day** in the County, as requested by Mom's Demanding Action and led by **Mount Vernon resident Brooke Glisson**. This day will bring awareness to the tragedy that gun violence brings to our neighborhoods and will honor victims and survivors. **Moms Demand Action invites everyone to join them for the Wear Orange Rally on June 3 at 7 p.m., at Market Square, 301 King Street, Alexandria.**

I also recognized **Cathy Ledec's tremendous contributions** to our community as the Mount Vernon Tree Commissioner, among other service and accolades. Other meeting highlights:

- Recognized FCPS Superintendent Dr. Scott Brabrand for his decades of service to our community. As a School Board Member, it was a pleasure to work closely with him, as a then Regional Superintendent, to make academic strides to improve our student performance.
- Approved the abandonment of unused right-of-way of Quander Road.
- Approved two "Watch for Children" signs for Belle View Boulevard.
- Authorized issuance of Revenue Bonds to provide supplemental financing for affordable housing at the **Residences at North Hill**.

We all know **homelessness is a challenge** in our community and across the County. The Board directed County staff to **evaluate the successes and challenges of the County's Homeless Program** and bring back recommendations and additional partnership opportunities.

At the meeting, I also **recognized Diane Eckert** who passed away in March. Diane's passion for service to our community led her to be a **strong locally and nationally recognized leader in youth drug abuse prevention**. Diane co-founded the non-profit, "**Unified Prevention Coalition,"** that was funded through government grants from which she wrote and where she served as **Executive Director for seven years**. She was known for her intellect, integrity, compassion and good humor as she showed us all how to **work with young people** to help develop them into the leaders of tomorrow.

Administrative Items

Item 3: Approved the installation of **two "Watch for Children" signs on Belle View Boulevard**, as part of the Residential Traffic Administration Program (RTAP). *The full item can be read on pages 36 - 37 of the Board Package.*

Item 5: Authorized the Department of Family Services to accept grant funding from the Virginia Department for Aging and Rehabilitative Services (DARS) in the **amount of \$2,392,256**. Funding will be used to support **services for older adults and their caregivers** administered by the **Fairfax Area Agency on Aging** in service categories aligned with Supportive Services, Congregate Meals, Home Delivered Meals, Preventative Health, Family Caregiver, and Ombudsman. *The full item can be read on pages 70 - 74 of the Board Package*.

Authorized public hearings on:

- Moving the Lorton precinct polling location from Lorton Station Elementary School back to its original location at Lorton Library. Public hearing will be held on June 7 at 4:00 p.m. The full item can be read on pages 38 - 61 of the Board Package.
- Establish an additional satellite voting office at the Lorton Community Center

and removing the satellite voting office at the Laurel Hill Golf Club, where it was temporarily moved during the Lorton Library construction. Public hearing will be held on **June 7 at 4:00 p.m.** The full item can be read on pages 62 - 69 of the Board Package.

Action Items

Item 2: Authorized the **County Redevelopment and Housing Authority (RHA)** to issue Multifamily **Housing Revenue Bonds** or Notes, not to exceed \$515,000, to provide supplemental financing for the **affordable housing at the Residences at North Hill** This is another planned funding source for the project. *The full item can be read on pages 91 - 103 of the Board Package.*

Item 4: Authorized an agreement with the **Department of Rail and Public Transportation (DRPT)** for the **Transit Ridership Incentive Program (TRIP)** in the amount of \$9,696,940. The full item can be read on pages 197 - 204 of the Board Package.

Jeffery K. Platenberg has been with Fairfax County Public Schools (FCPS) for twenty years, serving as a valuable partner to both the Fairfax County Board and our School Board with his record of successful and innovative leadership working with us and local agencies, other governing bodies, and diverse constituencies. As the assistant superintendent of facilities and transportation services, he has successfully worked to resolve conflicts in creative ways that best support the needs of our students, educators, and the community. Action

Directed staff to prepare a resolution recognizing Mr. Platenberg's service to our community and Fairfax County Public Schools to be presented at an upcoming Board meeting.

FCPS Field Facilities

I supported Chairman Jeff McKay's Board Matter to enter into a **partnership with FCPS** to fund the development of **permanent bathroom facilities** at 15 of our FCPS high school stadiums.

- These 15 high schools **currently lack permanent restrooms** at their stadiums, relying upon port-a-potties for both student, athlete, and community use.
- Through a **cost-share agreement**, Fairfax County will partner with FCPS to fund the installation of these permanent facilities.

In the Mount Vernon area:

- Hayfield High School
- Mount Vernon High School
- West Potomac High School

This is an issue of equity. No matter which school a child goes to in Fairfax County, it should be expected that they receive not only a high-quality education, but that they are provided high quality facilities as well. **Permanent bathroom facilities at stadiums should be a standard**, not a matter of where you live.

I would like to thank my partner in the **Mount Vernon District, School Board Member Karen Corbett Sanders for initiating this effort** and guiding us through months of meetings with myself, the Chairman and County staff to get to this point.

Quander Road

Authorized vacation of **abandoned portions of Quander Road**. In the 1980's, the realignment of Quander Road was completed, creating areas of **surplus right of way**, leftover from the previous alignment. These portions are now surplus and **no longer needed for public street purposes**. This does **not impact the property recently purchased** by the Board of Supervisors to create a **new park on Quander Road**.

Coastal Storm Risk Management (CSRM) Feasibility Study

The U.S. Army Corps of Engineers and the Metropolitan Washington Council of Governments are working together on the **Metropolitan Washington District of Columbia Coastal Storm Risk Management (CSRM) Feasibility Study**. The purpose of the study is to **investigate coastal flooding** in Northern Virginia and evaluate potential measures to reduce coastal flood risk to vulnerable populations, properties, infrastructure and resources to support resilient communities. The study includes **flood mitigation measures for the Belle Haven watershed**. That project is being considered as part of the study for further design.

The **Draft Integrated Feasibility Report and Environmental Assessment** for the study will be **released for public review on May 27, 2022**. The report will be available online on the project website for a 30 day review period. **A public meeting will be held on Tuesday, June 14, from 6 - 8 p.m. Belle View Elementary School cafeteria** (6701 Fort Hunt Road).

Public comments will be compiled, shared and evaluated by the entire USACE team. The **comments and suggestions from residents are greatly valued** and are an integral part of the process.

Children 5 to 11 Years of Age Now Eligible for a Pfizer-BioNTech Vaccine Booster

The U.S. Food and Drug Administration (FDA) met on May 17 and amended the emergency use authorization (EUA) for the Pfizer COVID-19 vaccine, **authorizing use of a single booster for children ages 5 through 11 years of age**, at least five months after completing a primary series with the Pfizer vaccine.
