

Recent trends suggest a rise in cases of interpersonal violence,

including more severe cases like those involving strangulation and weapons, **particularly over the past two years** while the County has been living through the COVID-19 pandemic. During the first quarter of 2022, our Department of Family Services' Domestic and Sexual Violence Services (DSVS) division has seen this trend in real time through its **Domestic and Sexual Violence 24-Hour Hotline**, which has recorded an uptick in the number of domestic violence calls it receives. #### Meet the Captain!




### **National Night Out is Back!**

### **Resilient Fairfax Draft Plan Public Comment Open**

All Fairfax County residents are invited to comment on the **County's first-ever climate adaptation and resilience plan, now through June 15**. The plan includes information on **expected climate impacts** in the County in the decades to come, an audit of existing County policies, plans, and programs, a comprehensive vulnerability and risk assessment, and **recommended strategies** to address known and expected risks. Climate change is already impacting Fairfax County with

### **Lorton Landfill Overlook Park Project**

As many of you in South County may know, my office has

been collaborating with an interdepartmental project team and Waste Management Inc, the current property owners of the closed Construction Debris Landfill, with input and engagement from the surrounding community, to develop a plan for the park amenities to be built on Overlook Ridge Park. The park is expected to be open to the public in 2025.

### **Thermalize Program Deadline is June 30**

Fairfax County is participating in Thermalize, a new program to assist residents electrify and improve the energy efficiency of your home. Modeled on the popular Solarize program (also running through June 30), Thermalize is run by the Local Energy Alliance Program (LEAP). County residents can sign up to receive a discounted home energy assessment and access to vetted contractors to upgrade or replace an existing HVAC system or gas appliances. The prequalified contractors will offer fair and competitive pricing to program participants, and the experts at LEAP will provide participants with dedicated guidance and support throughout the process of assessing their home's electrification and efficiency needs. In addition, participants can receive recommendations on home energy efficiency projects including insulation and air sealing. Altogether, these electrification and efficiency measures can help Fairfax County residents make their homes healthier, safer, more comfortable, cost-effective and greener. Learn more...

### Fort Hunt Named Healthiest House Market In Virginia

Fort Hunt, Mount Vernon and Belle Haven made the top 10 in SmartAsset's study of healthiest housing markets. SmartAsset, an online personal finance tool, based the ranking of housing markets in Virginia on four factors: stability, affordability, fluidity and risk of loss. ### **Virginia Reports First Presumed Case of Monkeypox**

Virginia Department of Health (VDH) announced the **first presumed monkeypox case** in a Virginia resident and is awaiting confirmatory test results from the Centers for Disease Control and Prevention. The patient is an adult female resident of the **Northern region of Virginia** with **recent international travel history** to an African country where the disease is known to occur. She was not infectious during travel. She **did not require hospitalization** and is isolating at home to monitor her health. To protect patient privacy, no further information will be provided. Early voting began Friday, May 6, for the June 21 Democratic primary for the 8th Congressional District. Voters can cast their ballot at the main Fairfax County Government Center (12000 Government Center Parkway, Fairfax) on weekdays from 8 a.m. to 4:30 p.m., and this



location also will be open on two Saturdays: June 11 and June 18 from 9 a.m. to 5 p.m. The main Fairfax County Government Center will be the only location available for early voting until June 11.

# Children 5 to 11 Years of Age Now Eligible for a Pfizer-BioNTech Vaccine Booster

### **Grass Height**

As warmer weather and longer daylight hours have arrived, grass is beginning to grow faster and residents may notice **tall grass that has not been regularly mowed** on properties in their neighborhoods. Chapter 119 of the Fairfax County Code regulates grass height, which **must not be taller than 12 inches** on any residentially developed property that is **less than a half-acre** (21,780 square feet) in size. **Additional information**, including the grass height regulations for vacant lots and nonresidential properties, is available on DCC's website, as well as on the attached DCC Grass Height Flyer. Grass height complaints and concerns to DCC are common from **mid-April to the mid-October**, which is the time of year during which DCC enforces grass height regulations.

### **Citizen Corps Council**

To harness the power of every individual through education, training and volunteer service to make communities safer, stronger and better prepared to respond to the threats of terrorism, crime, public health issues and disasters of all kinds. To build on community strengths to develop action plans to involve the whole community, including special needs groups. To focus on public education, training and volunteer opportunities for community and family safety. To promote and oversee Citizen Corps programs. To provide opportunities for special skills and interests. To Identify best practices and report accomplishments.

#### **Human Services Council**
