Carbon Neutral Counties Declaration Joint with Chairman Jeff McKay and Supervisor Penny Gross July 13, 2021

With this Board Matter, I am introducing a Carbon Neutral Counties Declaration to commit Fairfax County Government to be carbon neutral by 2040, to work with state and federal lawmakers to advance this goal and to ensure it is implemented equitably.

Furthermore, the Declaration provides an opportunity for Fairfax County and other counties across the U.S. to announce their support for significantly reducing carbon emissions by transforming government operations. While carbon neutrality alliances have been established for U.S. cities, there is no organized alliance for counties. By adopting this commitment today, we can work with and encourage our fellow local governments at the regional, state and national levels to tackle the carbon emissions driving climate change.

The Carbon Neutral Counties Declaration builds on previous actions by the Board of Supervisors, including the 2007 adoption of the Cool Counties Climate Stabilization Declaration, the goals of which have been met, as well as Board action regarding the Joint Environmental Task Force, or JET, which in October 2020 issued emissions- reduction goals for county government and schools operations.

Later today, we will consider the updated Operational Energy Strategy and the specific goals, targets, and actions that will help us meet the carbon neutrality goal.

Setting these operational goals allows us to do our part to address climate change and encourage stakeholders and partners both within and outside of the County to do the same. Climate change is here. It is imperative that we all, Fairfax County Government included, take bold and immediate steps to address it.

THEREFORE, Mr. Chairman, I MOVE THAT THE BOARD support and sign on to the following Carbon Neutral Counties Declaration and FURTHER MOVE that the Board direct the County Executive to charge the Office of Environmental and Energy Coordination (OEEC) with hosting and managing information relevant to the Declaration on their webpage.

Carbon Neutral Counties Declaration

WHEREAS the world's leading climate scientists agree that the earth is warming at an unprecedented rate and that human emissions of greenhouse gases are the leading cause of climate change;

WHEREAS impacts associated with climate change include, but are not limited to, sea level rise, ocean acidification, more frequent extreme weather events (e.g. floods, heat waves), ecosystem disturbances, shifts in abundance and distribution of plant and animal species, and changes to the quantity and quality of regional water supplies;

WHEREAS scientists have projected that, in order to avoid severe, widespread and irreversible impacts of climate change, such as global and regional food insecurity, global warming must be limited to 2 degrees Celsius above pre-industrial levels;

WHEREAS, under the Paris Climate Agreement, a majority of the world's countries have agreed to plan and regularly report on climate change mitigation efforts, with a goal to limit the increase in global average temperatures below 2 degrees Celsius with efforts to further limit the increase to 1.5 degrees Celsius;

WHEREAS 29 countries, as part of the Carbon Neutrality Coalition, have pledged to meet the goals of the Paris Climate Agreement by achieving carbon neutrality by the second half of the century;

WHEREAS energy carbon neutrality is understood to be a balance of carbon emissions: that is, removing as much carbon dioxide from the atmosphere as is emitted in a defined period of time.

WHEREAS the United States is responsible for producing approximately 11 percent of the world's greenhouse gas emissions;

WHEREAS many leading U.S. companies are pledging to meet climate mitigation targets by the second half of the century, with several companies committing to carbon neutrality;

WHEREAS state and local governments in the U.S. have been setting new or strengthening existing climate mitigation commitments in recent years, with several U.S. cities pledging to achieve carbon neutrality by 2050 or sooner through the Carbon Neutral Cities Alliance or the Race to Zero campaign;

WHEREAS counties have a unique role to play in climate mitigation efforts through their influence over the development and implementation of local and regional policies geared toward county government operations and energy use, air quality, land use planning, transportation, zoning, forest preservation, water conservation, and wastewater and solid waste management;

WHEREAS counties have made significant progress toward existing climate commitments, such as the 2007 Cool Counties Climate Stabilization Declaration, in which counties pledged to

develop local greenhouse gas inventories, work with local, state and federal governments to reduce county geographical greenhouse gas emissions by 80 percent below 2005 levels by 2050, and urge federal actors to enact measures to meet this emission reduction goal, including more stringent fuel economy standards;

WHEREAS the implementation of more aggressive climate mitigation commitments at the county level would align counties with other local governments and those in the private sector leading on climate mitigation;

WHEREAS climate mitigation efforts provide numerous social, economic and environmental benefits for both local and regional communities;

NOW THEREFORE WE DECLARE,

We as Carbon Neutral Counties will take immediate steps to mitigate our county government's contribution to climate change by making the following commitments:

- i. Commit to being energy carbon neutral by 2040, prioritizing the reduction of operational greenhouse gas emissions to the greatest extent possible.
- ii. Urge federal and state lawmakers to provide incentives, requirements or other such measures to meet carbon neutrality goals, with specific measures targeting the building and energy, transportation and solid waste sectors.
- iii. Ensure the carbon neutrality goal is implemented equitably, and in a manner that protects and improves the quality of life for community members, regardless of age, race, color, sex, sexual orientation, gender identity, religion, national origin, marital status, disability, socio-economic status, neighborhood of residence or other characteristics. Ensure all community members can fully participate in and contribute to the environmental, social and economic benefits and/or opportunities that may result from the implementation of this goal, and that no communities are disproportionately impacted by the transition to a carbon neutral economy.

The South County Girls Soccer team defeated McLean 2-0 in the state semifinals and found themselves with their first shot at winning and competing at the Class 6C State Championship. The Stallions had an amazing run this year with 60 goals being scored in just 17 games, and were undefeated only conceding 4 goals all season.

Directing County Staff to Prepare a Plastic Bag Tax Ordinance

Background

During the 2020 General Assembly Session, the Board of Supervisors supported HB 534/SB 11, which authorizes localities to adopt a plastic bag ordinance.

Fairfax County, alongside the Northern Virginia Regional Commission, led the effort to request guidelines from the Virginia Department of Taxation (TAX) on how to effectively develop a County Disposable Plastic Bag Tax Ordinance. Recently, TAX has notified interested parties that it has developed these draft guidelines which provide needed clarity. With the guidelines being finalized, now is an opportune time to begin drafting a Disposable Plastic Bag Tax Ordinance. Time is of the essence as the Virginia Disposable Plastic Bag Tax Dealer Discount allows dealers the ability to retain two cents from tax collected on each disposable plastic bag until January 1, 2023, at which point it drops to one cent.

Proposed Action

Therefore, Mr. Chairman, I move that the Board direct County staff to prepare a County Plastic Bag Tax Ordinance for consideration in September 2021, provided that the Virginia Department of Taxation will have finalized their guidelines for such an ordinance by that time. Between now and September, staff should also conduct outreach to other Northern Virginia jurisdictions to let them know we are preparing a draft ordinance and welcome their input in the hopes of having a relatively consistent ordinance across the region. I also move that the Board direct the Office of Environmental and Energy Coordination and the Office of Public Affairs, as appropriate, to develop a public outreach campaign to solicit input and educate local businesses and residents on this ordinance.
