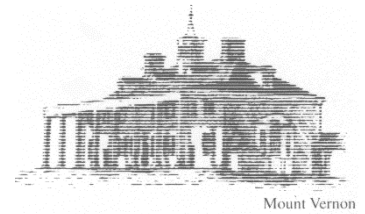

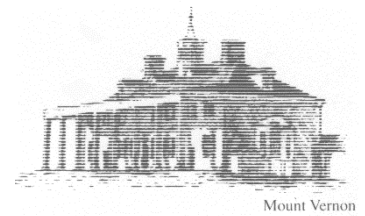

Brand Launch for Potomac Banks – Explore Fairfax South

In February 2019, I launched the Mount Vernon Tourism Task Force with the purpose to bring together key tourism stakeholders to connect and increase awareness of the vibrant cultural, natural, and heritage resources of the southern portion of Fairfax County. Visit Fairfax has collaborated with us and our many partners, including: Mount Vernon Estate, National Museum of the United States Army, Woodlawn Pope-Leighey House, Workhouse Arts Center, Gunston Hall, Gum Springs Museum, Fairfax County Park Authority, Arcadia Farms, National Park Service, Fort Belvoir, NOVA Parks, Mason Neck State Park, River Farm, South Fairfax and Mount Vernon Lee Chambers of Commerce, South Fairfax Development Corporation and local residents.

The Board has supported several initiatives as a result of the Mount Vernon Tourism Task Force work. This includes carryover funding to support the Semi quincennial Workgroup and for Visit Fairfax to study, develop, and procure a consultant for a tourism placemaking and marketing strategy. As a result of this work, the Potomac Banks Brand Launch will be on Wednesday, May 18, 2022, from 10:30 am to 12:00 pm at George Washington's Mount Vernon Estate.

The launch will highlight the brand which ties together the 10+ area sites with tourism packaging which will enable greater regional visibility and impact, with a new visitor savings pass. This new branding effort will create synergy between the historical, recreational, cultural, and ecological venues in the region, help grow opportunities for new tourism infrastructure, and enhance the visitor experience to the area.

NEW TOURISM BRANDING INITIATIVE TO BE ANNOUNCED FOR SOUTHERN FAIRFAX COUNTY

Brand to encourage cross-promotion, visitation of sites in historically rich area of Northern Virginia

Fairfax County, VA – May 4, 2022 – Members of the media are invited to attend a press conference announcing a new tourism branding initiative for the southeastern portion of Fairfax County, an area that is steeped in history, culture, museums, natural resources, and other attractions that tell the tale of the history of America.

The brand launch is a result of a multi-year destination development assessment by the South County Tourism Task Force (TTF), spearheaded by Mount Vernon District Supervisor Dan Storck, in collaboration with Visit Fairfax and the tourism sites/attractions located in the vicinity. This new branding effort will create synergy between the historical, recreational, cultural, and ecological venues in the region, help grow opportunities for new tourism infrastructure, and enhance the visitor experience to the area.

What: Formal announcement of new brand, unveiling of logo, and launch of visitor savings pass for the southeastern Fairfax County Cultural Corridor, an area that includes a treasure trove of tourism assets including George Washington’s Mount Vernon, George Mason’s Gunston Hall, the National Museum of the U.S. Army, the Workhouse Arts Center, Mason Neck State Park, among many others.

In addition to the brand launch, the press conference will include remarks by various local leaders (see below) and will be held at the home of America’s first president, George Washington.

Motion to Expedite Hearing for B.F. Saul SEA 99-P-034

Members of the Board,

B.F. Saul is proposing to redevelop a functionally obsolete 1970s-era office building located at 7926 Jones Branch Drive. This building, Park Place I, is part of a two-building complex, located at a gateway location along the Capital Beltway, next to the Scotts Crossing Road overpass and opposite the Capital One Tower. The other building in this complex, Park Place II, is commonly known as the Hilton Worldwide headquarters and was developed pursuant to a special exception for additional building height, approved in 2000 (Case No. SE 99-P-034).

The new Park Place I building is proposed to be the same size as the building it will replace but taller, by taking advantage of the increased building heights recommended in the Tysons Corner Comprehensive Plan. B.F. Saul proposes to achieve its desired building height through an amendment to the existing build height special exception (Case No. SEA 99-P-034).

The Applicant has worked with County Staff on the special exception amendment to improve the overall design, and we are encouraged by the progress made to date. The special exception amendment has also received favorable community support.

The special exception amendment is currently scheduled for a Planning Commission hearing on June 8, 2022. In order to ensure the application remains on track, the Applicant has asked for a hearing before the Board of Supervisors on June 28, 2022.

Therefore, I move that the Board of Supervisors direct the planning staff to schedule SEA 99-P-034 for a hearing before the Board of Supervisors on June 28, 2022.

This motion should not be construed as a favorable recommendation by the Board of Supervisors, nor does it relieve the Applicant from compliance with the provisions of all applicable ordinances, regulations or adopted standards.

Background: Mister Chairman, on March 8th this Board unanimously approved the attached motion to have the History Commission begin the process of evaluating the naming of the FCPD Helicopter Hangar after former Chief and Deputy County Executive David Rohrer (see attached).

Since then, the History Commission has determined that based on Board policy for renaming facilities established January 26, 2021, it is not the appropriate agency to evaluate the naming of the facility given that the Board is seeking to name the facility after a living person. They further determined that the Fairfax County Police Department is the appropriate agency to evaluate the naming of this facility.

The Fairfax County Police Department has since reviewed the naming of the FCPD Helicopter Hangar and approved naming it after David Rohrer (see attached).

Motion: Therefore, Mister Chairman, in accordance with the Board's naming policy which requires the appropriate agency review and approve facility name recommendations, I ask that the Board name the FCPD Helicopter Hangar after David Rohrer.

Naming FCPD Helicopter Hangar After Former Chief and Deputy County Executive
David Rohrer

Background: Mister Chairman, we recently had the honor of recognizing the retirement of longtime public servant, former Chief, and Deputy County Executive David Rohrer. Chief Rohrer dedicated 41 years to Fairfax County starting his career as a patrol officer in the Fairfax County Police Department (FCPD) in December of 1980. His first assignment was at the McLean District Station until his selection to join our TAC Team as an operator in 1985. He was promoted to sergeant in 1987 and worked as a patrol supervisor at the Fair Oaks Station until transferring back to the McLean Station in 1988. His previous expertise as an operator led to his return to the TAC Team as a supervisor in 1989. He continued to move up the ranks with a promotion to Second Lieutenant in 1990 and subsequently to Lieutenant in 1994. In 1997, Chief Rohrer was promoted to Captain and assigned to the Fair Oaks Station as the Commander. In 1999, Chief Rohrer was promoted to Major and served as a Staff Duty Officer overseeing patrol operations. In 2002, Chief Rohrer was promoted to Lieutenant Colonel serving as the Deputy Chief of Operations and Investigations.

Chief Rohrer spent 32 years with our agency moving up the ranks to his appointment of Chief in 2004. During Chief Rohrer's tenure as police chief, crime in Fairfax County dropped approximately 15 percent despite the growth of population that occurred during the same time frame. He helped modernize the Department by converting the agency from traditional paper reports to a digital record management system. Chief Rohrer also compassionately led the agency through several tragedies to include the loss of three of its officers, one during a training exercise, where he responded with new protocols to ensure better oversight and a culture of safety with the Department. In 2012, Chief Rohrer stepped down from police chief to serve as the Deputy County Executive of Public Safety until his recent retirement in January of 2022. He was selected for this role after a nationwide search and oversaw Fairfax County's Police Department, Fire and Rescue Department, Department of Public Safety Communications, Office of Emergency Management, Animal Shelter, and McConnel Public Safety and Transportation Operations Center.

Rohrer's service has impacted every part of Fairfax County, especially our police department. Prompted by Rohrer's legacy of service and impact on the FCPD, Chief Davis has requested that the Board name the FCPD Helicopter Hangar located off West Ox Road after former Chief Rohrer.

Motion: Therefore, Mister Chairman, I move that we begin the process to name the FCPD Helicopter



SUBJECT: Naming FCPD Helicopter Hangar After Former Chief and Deputy County Executive David Rohrer

Supervisor Pat Herrity brought forth a board matter on March 8, 2022 to have the Fairfax County Police Helicopter facility renamed after longtime public servant, former Chief, and retired Deputy County Executive David Rohrer. The renovation of the Heliport project located in the Springfield District will be substantially completed in July 2022.

After an initial review by the Fairfax County History Commission, the matter was referred to the Fairfax County Police Department (FCPD) to evaluate. Our review has confirmed that the renaming of the facility meets the criteria established in the Board of Supervisors' policy for the Naming of County Facilities at a Board Member's Request and is fully supported by the FCPD.

Chief Rohrer dedicated 41 years to Fairfax County starting his career as a patrol officer on the Fairfax County Police Department in 1980. He spent 32 years with our agency moving up the ranks to his appointment of Chief in 2004. In 2012, Chief Rohrer stepped down from police chief to serve as the Deputy County Executive of Public Safety until his recent retirement in January of 2022. He was selected for this role after a nationwide search and oversaw Fairfax County's Police Department, Fire and Rescue Department, Department of Public Safety Communications, Office of Emergency Management, Animal Shelter and McConnel Public Safety and Transportation Operations Center.

The impact of Chief Rohrer's commitment and guidance to public safety will forever be felt. It would not only be fitting, but also the Police Department's privilege to name our facility after Chief Rohrer to permanently memorialize this great leader.
