MATTERS OF INTEREST FROM GOVERNING BODIES

FCPS

Mr. Curran reported that South County HS won the state championship in football.

The winter sports season is also underway. Swimming and Diving had some logistical issues because the Reston RECenter pool was still under renovation. FCPS worked with FCPA and was able to find solutions to offset the unavailability of the Reston RECenter. The King Abdullah Academy located in Herndon, Virginia also helped accommodate some of the FCPS swim and dive needs.



Mr. Curran reported that he had a good meeting with the new School Board members. Eight of the twelve members are new and don't have a deep background in athletics. Mr. Curran briefly spoke to them about the role of the Athletic Council and extended an invitation to the School Board members to attend a future meeting.

Mr. Curran stated that there has been a push to put permanent bathroom facilities outside of high schools near stadium fields. There are several challenges including funding, zoning, location of fields, etc., but this would benefit all users.

Mr. Munson inquired if there was a possibility of an athletic subsidy program? Mr. Curran explained FCPS is looking at the One Fairfax model and it may be beneficial for him to do a budget presentation again for new members. FCPS is looking from an equity standpoint how athletics funded and there are a couple different models being looked at. One model is to look at the per pupil allotment tied to free and reduced lunch similar to how they are used in the classroom. The subsidy would be spread amongst all schools and include things like normalizing uniform rotations. The funding would be included in the budget and it would not just include high schools. Things like field trips for elementary and middle schools will bel looked at as well.

Mr. Flather inquired about the status of the bullet points for new School Board members that explains what the Council does and its role in the community had been drafted? Mr. McLaughlin stated that he will put together the document with input from others on the Council.

FCPA

Mr. Sutherland reported an additional field improvement project. Springfield/South County Youth Club will be funding the installation of lighting for Hooes Road Park RF #3. The project is scheduled to take place during the summer of 2020.

Mr. Sutherland stated that a 2020 Park Bond is likely. The bonds are no longer listed by projects. They are instead listed in buckets (land acquisition, new improvements, renovations, etc.)

Kevin Williams, Park Operations Manager for FCPA, who manages maintenance on school athletic fields, through partnership with FCPA, FCPS and NCS, will take over synthetic maintenance on high school synthetic turf fields and other synthetic turf fields on elementary and middle school properties. FCPA will Take over maintenance January 6 Premier Turf will be the vendor.

Several Council members inquired if there was a document that shows upcoming FCPS projects? Mr. Martino stated that the synthetic turf fields at Centreville HS, Herndon HS and Westfield HS will be replaced this summer. NCS will send out a full list of the FCPS projects once the document is finalized.



NCS

Mr. Martino reminded the Council that groups need to let NCS know by Wednesday if they do not plan on using scheduled weekend gym space. NCS is seeing scenarios where custodians are present, but the scheduled user group does not show up. Or the scheduled user group is present at the facility and there is no custodian to open the facility. NCS and FCPS are working together to minimize the weekend conflicts and issues.

NCS reported that a Council Facebook page or blog could not be run and operated by the County due to policies and procedures. The Council is more than welcome to create an independent Facebook page or blog.

NCS distributed an updated document with organizations and contact information broken down by magisterial district. If there are any updates to the document, please let NCS know.

Several Council members inquired on why FCPS gyms were closed January 5-6. NCS stated that those dates fell within FCPS winter break and there were ongoing discussions with FCPS regarding the closure.
