#### **MEETING OPENING**

Ms. Cantwell called the meeting to order at 7:30 p.m. Roll was called and a quorum was present.

#### PRESENTATIONS TO COUNCIL

Ms. Allyson Halverson from SCAN of Northern Virginia presented on a free training provided for athletic coaches to educate them on signs of child abuse and what steps can be taken by coaches such in such situations. For three decades, SCAN of Northern Virginia has been working throughout the region to develop effective prevention programming for all children and families, no matter what their circumstances.

## **COMMUNITY OUTREACH OPPORTUNITIES**

Mr. Leonard stated that there has been a series of presentations to the Council on a variety of topics including child abuse, concussion education, domestic violence, sexual abuse, suicide awareness, etc. and Mr. Christopher Pulley, Community Outreach Specialist with NCS, has done a fantastic job bringing those topics and presenters to the Council. Mr. Leonard asked the Council members if they find the presentations valuable, to which the Council responded overwhelmingly that they do. Mr. Leonard also wanted to make sure the information is getting out to the entire community. Mr. Flather said it would be helpful to have an updated list of sports organizations contacts by magisterial districts. NCS will work on updating the document for the Council.

Ms. Bauer inquired if the Athletic Council could have its own dedicated Facebook page to interact. Unfortunately, there is a lot of red tape involved in what can and can't be posted and what constitutes official Athletic Council business. Ms. Bauer also asked if the presentations to the Council could be posted online? All Council agendas, minutes and presentations are currently posted online on the NCS Athletic Council website.



Ms. Quinn also suggested that it would be great if there was a place where organizations could post upcoming events so the public can see. Mr. Leonard stated that NCS will talk to their communications teams about what types of things can be done online and what is feasible.

Mr. Thompson also encouraged the Council to utilize the sports-specific councils to distribute information discussed by the Athletic Council.

#### SPORTS TOURISM TASK FORCE

A draft PowerPoint presentation created by the consultant, Study of Sports Tourism Facility Opportunities in Fairfax County, was distributed to the Council. Mr. Leonard highlighted two key pieces of the presentation. The first is that the County's current field allocation policy is not conducive to encourage sports tourism opportunities. The second item is that while Fairfax County has many turf fields, they are not clustered in one location and thus are not ideal for tournaments. Mr. Leonard stated that the consultant was looking for feedback by early December. Mr. Leonard also praised the athletic community for how involved it was in the entire process and the consultant was quite impressed.

#### **COMMITTEE REPORTS**

Ms. Avvisato stated that the Council sub-committees should reconvene in January. These sub-committees include the by-laws committee to look at the overall Council's by-laws, Champions of Character committee, Community Outreach committee, Steering Committee and Allocation Committee. NCS will send a list of the current subcommittee membership and ask that any Council members interested in joining a committee to let NCS know.

#### Soccer

Ms. Bauer reported that the NCS on-call field and gym monitors have been doing a fantastic job in handling any issues that arise.

# Volleyball

Mr. Pruitt stated that that volleyball was transitioning from the fall season to winter. The Woodson HS girls' volleyball team also reached the State Finals this season. Mr. Pruitt was also pleased to report that there were 17 high school boys' volleyball teams this season and 17 elementary/middle school teams. This is great news for boys' volleyball in the area.

#### Baseball

Mr. Hahne stated that he was still celebrating the Washington Nationals world series victory and had nothing to report.

## <u>Ultimate Frisbee</u>

Mr. McMahon reported that Ultimate Frisbee is finishing up its fall season and they had 14 youth teams this year.

Mr. Meana informed the Council that youth tackle and non-tackle football was winding down for the season. Mr. Meana also praised the Champions of Character guest speaker Eric Moses and stated that Mr. Moses was extremely impressed with the ceremony.
