MEETING OPENING

Ms. Bauer called the meeting to order at 6:00 p.m. Roll was called, and a quorum was present.

ADMINISTRATIVE ITEMS

The meeting minutes from the virtual meeting on June 16 were approved.

CHAIRMAN REPORT

Ms. Bauer had nothing to report

COMMITTEE REPORTS

Mr. Flather encouraged the Council to form a committee to enhance the communication between FCPS, NCS and user groups. Mr. Flather explained that groups are receiving a lot of late cancellations, school programs are running later into community use time, lack of communication of construction projects, etc. were some of the issues groups were encountering across the County. Mr. Flather moved that the Council create a committee to look at improving communication between FCPS and NCS. The motion was seconded by Mr. McLaughlin and approved without objection.

Sports Tourism Implementation Committee

Mr. Flather stated that the Sports Tourism Task Force has a meeting scheduled for tomorrow. NCS has developed a survey for the tournament directors and community use groups displaced by the tournament pilot program to gather data on how the process worked for both parties.

REPORTS BY SPORTS REPRESENTATIVES

Baseball

Mr. Hahne reported the baseball community is excited for the start of the fall season

Basketball

Mr. Bergstrom stated that basketball was in the planning phase for the winter. The biggest unknown is COVID-19 and different variants that may impact the season. There are also questions regarding masks, vaccine requirements, etc.

Socce

Ms. Bauer reported the last few weeks have been stressful for the soccer community. The 3 weeks of rain caused a significant back up in the mowing schedule. Groups tried to explain to parents that heavy equipment used to mow the fields couldn't be used because it would damage the playing surface. Unfortunately, some grass fields weren't playable for the first weekend of games.



Ms. Bauer explained that walk-on groups are starting to be an issue again. The walk-on groups got used to accessing fields during the summer, however with organization practices starting it is becoming an issue. Police and school security, as well as NCS monitors help with the walk-on issues.

Volleyball

Mr. Baily stated that several groups were able to start boys' volleyball programs in the fall which consists of 12 teams consisting of elementary school and middle school players. Mr. Baily was also happy to report the Northern Virginia Boys High School Volleyball League had 250 boys registered from schools across the County. There have also been discussions with FCPS on what the next steps are to have boys' volleyball recognized as an official varsity sport. Boys' volleyball is currently sanctioned by VHSL, just not in northern Virginia.

STATUS REPORT FROM COUNTY REPRESENTATIVES

FCPS

Mr. Curran stated that all FCPS student athletes 16 years and older participating in winter sports must be vaccinated for COVID-19 by November 8, the first day of the winter athletic season. A FAQ (frequently asked questions) was distributed last Thursday and there will be another update on Friday to discuss operational functions. Mr. Curran explained that religious and medical exemptions will be provided, however those individuals must be tested weekly. Mr. Curran stated that they are still working on a vendor to provide testing, as well as a vendor to provide vaccines.

Fairfax County was the first jurisdiction in the state to announce the COVID-19 vaccine requirement, however several other jurisdictions have followed. Mr. Curran wanted to be clear that this is a Fairfax County directive, not a VHSL rule. Mr. Curran explained there has been mixed response from the community and his office has received several phone calls.

Mr. Curran reported that there is currently an enhanced diamond field maintenance program for the high school diamonds. However, there is no formal MOU or document that shows what the maintenance program entails. Mr. Curran would like a committee formed with diamond field users, NCS, FCPA and FCPS to look at the current diamond field maintenance program and draft a policy or MOU.

Mr. McLaughlin moved that the Council create a committee to document the current high school diamond field maintenance program and include all the appropriate parties. The motion was seconded by Mr. Thompson and approved without objection.

FCPA

Mr. Louis understands the frustration with the mowing, however the alternative of trying to mow on over-saturated fields would have caused more damage to the playing surface.

Mr. Louis reported that the synthetic turf projects at Holladay Field and Oak Marr Park were targeted to be completed by the end of September. However, delays in manufacturing, shipping and workforce shortages attributed to COVID-19 has caused delays and the target date for completion is now the end of October.

Mr. Thompson was happy to announce the Park Authority has hired a new Executive Director, Jai Cole. She comes to Fairfax County from Maryland-National Capital Park and Planning Commission, Montgomery Parks (M-NCPPC, Montgomery Parks) where she served as Chief of the Park Planning and Stewardship Division since 2018. She has a long history in parks and grew up in Fairfax County. She was formally approved by the Board of Supervisors yesterday.

Fairfax County Athletic Council 12011 Government Center Pkwy Fairfax, Virginia22035 703324-5523 Mr. Thompson reported that the Patriot Park North diamond field complex is closer to becoming a construction site. By the next Council meeting construction should be underway with a projected ribbon cutting at the end of the first quarter 2023.

Mr. Thompson announced that the Park Authority recently held public meetings on Pickleball, as well as the Braddock Park masterplan.

NCS

Mr. Martino stated that the Fall 2021 field and gym seasons are underway. Mr. Martino thanked those who were able to attend the virtual meeting with the Fairfax County Health Department to review expectations of groups using FCPS gyms. The two main takeaways from the meeting are that masks are required for everyone in FCPS facilities regardless of vaccination status, except for athletes or referees that are engaged in physical activity. The Health Department also provided a link for groups to report any positive COVID-19 cases to the Health Department to assist with contact tracing.

Mr. Martino reported that Police and School Security have been hired to patrol select locations. If there are any areas where groups feel Police or School Security is needed, please contact NCS.

Mr. Martino was happy to announce that NCS Athletic Services has hired a new administrative assistant, Aran Muradi, who will start Monday.

NEW BUSINESS

Mr. Thompson stated the Fairfax County Park Authority recently released a Draft Pickleball Study and are seeking additional public feedback. The following link has additional information on the Pickleball Study.
