### **MEETING OPENING**

Mr. Flather called the meeting to order at 7:30 p.m. Roll was called, and a quorum was present.

### ADMINISTRATIVE ITEMS

The meeting minutes from the March 15 Council meeting were approved.

### CHAIRMAN REPORT

Mr. Flather reported that Ms. Bauer spoke to the Board of Supervisors at the budget hearing regarding the APRT report and associated funding. Mr. Flather was pleased to announce that the BOS fully approved the funding from the APRT report. Ms. Bauer received a personal note from Chairman McKay regarding the funding for the APRT project. The APRT committee will meet to best determine how to use those funds.

Mr. Flather stated that the changes to the Council by-laws was submitted to the Board of Supervisors, however they have not been reviewed or voted on yet. Council meetings will continue to be in-person until the updated by-laws are approved.

Mr. Flather informed the Council that he was just made aware that the stadium fields at Falls Church HS, Oakton HS and Woodson HS will be out of service this summer due to synthetic turf replacement. Once the stadium fields are completed, the Falls Church HS and Woodson HS practice fields may be replaced as well, which would be done in the fall. This is still to be determined.

Mr. Flather stated that the projects could begin as soon as June 1 and will have a significant impact on end of season tournaments, referees, parents, etc. Other organizations will also be impacted if NCS needs to move groups around due to the projects.

The Council was concerned that diamond field usage may be affected by staging areas for the turf replacement projects. Ms. Garner stated at this time the only fields impacted are the stadium fields and surrounding tracks.

#### **COMMITTEE REPORTS**

#### **APRT**

Ms. Eckert informed the Council that the County had approved funding for the APRT softball report. Ms. Eckert identified the following projects at Wakefield Park and will keep the Council updated on the progress.

The funding also includes tournament support on an annual basis. The project has been assigned to a project manager to do all work during the offseason.

Communications with Fairfax County Partners - FCPS, FCPA, NCS and Community Users Mr. Flather reported the letter regarding the FCPS late cancelations was drafted, approved, and given to Dr. Anderson as the Athletic Council representative to the School Board. Mr. Tucker reported that Dr. Anderson shared the letter with the School Board chairman and FCPS Superintendent Dr. Reid. Dr. Anderson requested additional data that NCS and FCPS staff shared. Dr. Anderson reviewed the data, focusing on the most egregious schools and cancelations. Dr. Anderson plans on getting in touch with Executive Principals to make sure they pay attention to those locations and understand the impact to the community. Mr. Flather is encouraged FCPS is taking the issue seriously and requested if a statement could be provided about what actions the School Board is taking.

Ms. Garner reported that the community use office is putting together required training packet for school-based staff. There will be 5 different sessions available to attend in August. Those who do not attend one of the sessions, community use will reach out to the school principal directly. Community use is also sending out target dates for schools to get their events in that mirror the NCS scheduling seasons.

Mr. Hahne thanked Ms. Garner for her ongoing commitment to improve the late cancelations. The Council has brainstormed ideas to improve the late cancelations with the goal being a Memorandum of Understanding (MOU).

### Stephen A. McLaughlin Fairfax County Champions of Character

Mr. Martino distributed the current nominations NCS has received for the 2023 Stephen A. McLaughlin Fairfax County Champions of Character ceremony which is scheduled for October 17, 2023. Mr. Martino urged the Council to help with nominations as the deadline is August 1. NCS will resend the email with the nomination information to the Council. The Council inquired if participants for any sport could be nominated, for example swimming. The Champions of Character committee will be meeting soon to discuss and will let the Council know which sports can be nominated.

# Baseball

Mr. Hahne reported that rec leagues are wrapping up in the next few weeks. Post season tournaments, all stars and travel leagues will occur throughout the summer. High school baseball is currently in the district finals with the regional tournaments starting next week.

Mr. Hahne announced that the Patriot Park North complex is officially open with 27 tournament events scheduled for the first year. Another facility, Capital One Park in Tysons, recently opened and was fully funded by Capital One. Additional information can be found on their website:
