MEETING OPENING

Mr. McLaughlin called the meeting to order at 7:45 p.m. Roll was called and a quorum was present.

PRESENTATIONS TO COUNCIL

Chris Young from INOVA gave a presentation regarding concussions. He highlighted concussion education training opportunities available for athletes, coaches and parents that is provided by INOVA. He also encouraged the Council to visit the new INOVA Fairfax clinic.

CHAIRMAN'S REPORT

SPORTS TOURISM TASK FORCE

The interim report from the Task Force was distributed to the Council. Mr. Leonard explained that the field tournament policy was being looked at, as currently it is not conducive to hosting national tournaments. The field allocation policy committee met to review potential changes to the tournament scheduling section of the field allocation policy.

The next steps are to share the interim report with the Economic Advisory Commission, Fairfax County Park Authority Board, FCPS School Board and then the Task Force will reconvene in mid-late February.

Mr. Flather stated that the report was very detailed and contained a lot of information. He asked the Council to provide feedback after reviewing the report and stated that the focus is still on community-use time.

Mr. Thompson explained that the County was in the process of hiring a consultant to look at sports tourism opportunities and what facilities would make sense for the County.

Mr. Hahne explained that Fauquier County was developing a field complex that would have 8 rectangular fields and 4 diamond fields. He will send the information to the Council. Mr. Hahne also inquired if the report was able to measure the indirect and direct impact per individual? Mr. Thompson stated that there are economic models in the report and that FCPA, FCPS, etc. universally agreed to using a specific model that is in the report.

He also explained that the Task Force spent a good amount of time reviewing fiscal models. Mr. Hahne inquired if the Task Force looked at the fiscal impact of keeping local teams at home for these tournaments? Mr. Thompson replied that it was difficult to calculate, however, the high school State Jamboree hosted by Fairfax County high schools was mentioned as a positive example.

FCPS FIELD CANCELLATIONS

Mr. Flather handed out a list of notes regarding issues with FCPS. The Council had a discussion regarding the issues and it was decided that the Council pick a School Board meeting to attend to bring up the issues the community is experiencing. Mr. McLaughlin also stated that he would draft a letter for the Council to send to the FCPS Superintendent regarding the issues.

Fast Pitch Softball

Slow Pitch Softball

Ultimate Frisbee

Mr. Phung reported that the tournament he applied for in May 2019 has been scheduled and secured. He also stated that they are currently training at the South Run Field House.

Volleyball

Mr. Pruitt reported that the Chantilly HS girls' volleyball team won the state tournament. He also thanked Mr. Thompson and Mr. Martino for attending the volleyball council meeting to review the sports-specific by-laws. Mr. Pruitt also inquired about the friend of the gym program status? NCS replied that all they have heard from FCPS is the program is currently under review. Mr. Pruitt closed with stating that he fully supports the issues Mr. Flather brought up to the Council.



Baseball

Mr. Hahne stated that the baseball community was looking at synthetic turf and had polled several organizations. This fall baseball lost 41% of their games due to inclement weather. Mr. Hahne explained that there are Title IX issues with turfing school diamond fields and he will work closely with Ms. Willemssen as they look at potential options. Mr. Thompson stated that there were Title IX issues with FCPS fields as well.
