MEETING OPENING

Ms. Bauer called the meeting to order at 6:00 p.m. Roll was called, and a quorum was present.

PRESENTATIONS TO COUNCIL

ADMINISTRATIVE ITEMS

The meeting minutes from the virtual meeting on April 20 were approved

CHAIRMAN REPORT

Ms. Bauer reported that Ms. Willemssen has addressed the BOS regarding reestablishing the Girl's Fastpitch Softball Equity Action Plan Review Team (APRT). Ms. Willemssen has heard back from Chairman McKay and the Athletic Council is going to send a letter to the BOS in support of reestablishing the APRT committee.

COMMITTEE REPORTS

Communications with Fairfax County Partners - FCPS, FCPA, NCS and Community Users

Mr. Flather reported that there was a meeting last evening with FCPS, NCS and community users. Mr. Flather thanked FCPS for putting the meeting together and stated it was a good first step, but there is still lot of work to do. Mr. Flather stated that Mr. Hahne had sent an email to those who attended the meeting that touched on the main talking points. Mr. Flather requested the notes be entered into the official Council minutes and they are listed below:

FCPS COMMUNITY USE

LATE CLOSURES

This is the major issue and the reason that the Athletic Council created the committee on community use. This wasn't really discussed at the initial meeting on 5/17/22. These late closures have progressively gotten worse over the past 3 - 4 years. We are focused on the non-emergency closures that occur after the deadlines. We all could list hundreds of non-emergency closures that occur at the last minute (homecoming, PTA meetings, football games...). There are actual records of this as well. This is well after deadlines and well after permits have already gone out. We aren't talking about inclement weather closures or other emergency closures here.

COVID

COVID was discussed last night quite a bit. We all recognize that COVID has made everything more challenging. The core issues that we are discussing were all present before COVID. I do think community users understand how challenging it was for schools to manage schedules in 2021.



ACTIVITIES OFFICES

Most of us recognize that the activities staff at a high school is the hardest working group in most any

school. They are tasked with an overwhelming amount of work. I do think this group/committee can look at ways to help support our activities offices at high schools and admin staff at elementary/middle schools. More funding...

I know the community user groups are hoping to get some clarification on 8420. Specifically, are schools required to put in closures by certain dates? The answer to that question will lead us to the solutions.

COMMUNICATION

Communication is the key. We need to encourage communication.

COMMUNITY USE OFFICE PRESENCE

We all know that turnover is one of the root causes with all these issues:

- Turnover with ES and MS admin staff
- Turnover with activities offices staff at high schools
- Turnover with user group leadership
- Turnover with coaches at the youth/adult level- facility care

It has been great to see the engagement from the community use office over the past couple of months. That was a piece that has been missing over the past 3-4 years. It has been missing at athletic council meetings, DSA meetings, and more. I am not sure what the expectations are with presence at these meetings, so I am not looking to blame anyone. I am simply stating that we hope to get active engagement from the community use office so that we can all communicate effectively.

FACILITY ABUSE- COMMUNITY USERS

This has been an ongoing issue. Our community users not taking care of school facilities as well as we could. This goes back to turnover in leadership and coaching ranks. It also is directly related to relationships. The community use office has discouraged these relationships recently which are critical to make this all work. We need to find mechanisms to hold teams, coaches, and user groups accountable for any facility abuse that occurs with community use.

FACILITY OWNERSHIP

This is the elephant in the room. I can tell you that I feel like the Westfield HS baseball field is my baby so long as I am the head baseball coach there. I mow that field 3x a week from March – October. I spend countless hours on the upkeep and maintenance of it so that it is nice for both school and community use play. I get really upset when community users don't take care of it. I also feel like that WHS should always get priority on that field, but I know that is not fair and it is not realistic.

The underlying question is this:

- Should schools be able to close their facilities (gym, field...) anytime they want for anything?

There has been confusing communication on this topic. What is coming directly from the community use office to our schools regarding this topic? Have they been essentially told



that they can close down community use for school use at any point? Please let us know at the next meeting.

ADVOCATE- COMMUNITY USERS / NCS

It was a surprise to many of the community user groups and even school staff when the change occurred on March 1st. This was a major change and to not include or communicate with the Athletic Council and others was surprising. The community users need an advocate. That advocate was always NCS (people like Mark Martino). They were the go between. They were the problem solvers. They did their best to hold all people accountable. That includes both user groups and schools. We need NCS to continue in that role. Working together to find solutions will benefit everyone. Ultimately, it should create less work for the community office and others.

Mr. Flather requested another meeting be scheduled and requested the following:

- Would like next meeting to be in person
- Mr. Flather would like to work directly with Ms. Garner on the agenda for the meeting and be sent out beforehand. Some who attended last night's meeting felt unprepared
- Additional information on Notice 8420
- Schedule a couple weeks in advance to maximize attendance

Ms. Bauer stated that there is also a financial and economic impact caused by late cancelations, especially in certain areas of the County. Ms. Bauer is hopeful data can be collected to drive decisions.

Ms. McLaughlin apologized to the Council regarding the issues they are experiencing. Ms. McLaughlin suggested there be some sort of moratorium on when school cancelations can occur. She also suggested that schools need to be more creative and shift usage to other areas of the building to not cancel community use.

Mr. Thompson thanked Mr. Hatcher and Ms. Garner for putting the meeting together. Mr. Thompson suggested having a committee meeting and invite FCPS versus having FCPS set up the meeting. Mr. Thompson stated that communication is key, especially with the high schools. Unforeseen events are always going to happen, but a lot of the can be handled with a phone call to a school.

Baseball

Mr. Hahne reported that baseball has seen a huge shortage of umpires. Mr. Hahne was pleased to announce that the State of Baseball luncheons that were started locally have gained momentum national as well. There will be a State of Baseball summit at the National Harbor to bring the baseball community together. The summit is being led by Fairfax County and Mr. Hahne will share additional information when it becomes available.

Football

Mr. Hollingsworth stated that football is currently in their offseason. Mr. Hollingsworth explained that football is preparing for the upcoming season this fall but has seen the same challenge as other sports with a shortage of officials.

Lacrosse

Mr. Diehl reported that lacrosse is entering postseason play and everything is going great.

Soccer

Ms. Bauer acknowledged that soccer is also dealing with referee shortages. Ms. Bauer explained that scheduling this spring was difficult with FCPS spring break, Easter holiday weekend, Memorial Day, and school cancelations. Ms. Bauer was happy to report that



user groups are working together to fill in scheduling gaps and then letting NCS know to update the scheduling system.

Volleyball

Mr. Baily stated that the recreation volleyball season is ending shortly and are preparing for the fall season. Mr. Baily plans on meeting with Mr. Curran regarding high school boys' volleyball.

STATUS REPORT FROM COUNTY REPRESENTATIVES

FCPS

Ms. McLaughlin updated the Council on adding permanent bathroom facilities to the remaining high school stadium fields. Chairman McKay has taken a leadership role along with Mt. Vernon Supervisor Dan Storck. A working group has been assembled that Ms. McLaughlin and Mt. Vernon District School Board Member Karen Corbett Sanders are a part of. Chairman McKay is preparing a formal presentation to the BOS to garner their full commitment on setting a plan in place to get the remaining high school stadium field bathrooms installed. There are currently 15 high schools without stadium field bathroom facilities. Ms. McLaughlin explained that getting joint support from both the BOS and School Board like the Synthetic Turf Task Force is key. The goal is to have the remaining high schools have stadium bathroom facilities in the next 1-2 years.

Ms. McLaughlin requested a formal letter from the Athletic Council in support of the high school stadium field bathroom project. Chairman McKay plans to present to the BOS next Tuesday. Mr. Thompson moved that Ms. Bauer and Mr. Flather be empowered to draft a letter on behalf of the Fairfax County Athletic Council in support of the stadium bathroom project. The motion passed without objection.

FCPA

Mr. Sutherland and Mr. Thompson explained that Mt. Vernon Recreation Center will be undergoing renovation that will shut the facility down. The renovation will include adding a 2nd sheet of ice, as well as upgrading locker rooms and restrooms. Additional information on the Mt. NCS

Ms. Dotson stated that NCS fully supports the Athletic Council and communities' concerns and are available to help with scheduling and coordinating. NCS has also been meeting with FCPS on how to improve the issues addressed and coming up with solutions.

Mr. Martino reported that NCS is finishing up the spring field and gym seasons. Police and School Security coverage will also end in the next few weeks. NCS is working on summer field and gym scheduling and permits will be sent out in the next couple of weeks.

NEW BUSINESS

Ms. McLaughlin inquired about the status of the Audrey Moore Rec Center renovation. Mr. Thompson explained that FCPA is working through bond cycles with BOS. Those conversations will have a direct impact on Audrey Moore Rec Center renovation. Audrey Moore was originally included in next bond; however, the bond may get pushed back 2 years. Ms. McLaughlin is concerned that Audrey Moore Rec Center is the oldest rec center in the County and doesn't understand how the renovation can keep being pushed back when the condition of the facility is not good.

Ms. Bauer requested the Park Authority gather more information on the Audrey Moore Rec Center renovation and bond cycles and report back at the June Athletic Council meeting.

OLD BUSINESS

Mr. Flather inquired about meeting in person for committee meeting and Council meetings. NCS will check and update the Council if in person meetings are a possibility.

Mr. Thompson allocation policy committee is scheduling a meeting soon.

ADJOURNMENT

The meeting adjourned at 8:01 p.m.
