Fairfax County Community Action Advisory Board (CAAB) Meeting Minutes – Tuesday, April 4, 2023, 7:30pm Fairfax County Government Center

The meeting was called to order at 7:32 pm by Chair Michelle Jefferson.

Minutes – March 7, 2023

It was noted that Shari Zamarra's last name was misspelled under the Membership and Elections Committee section. The motion to approve the meeting minutes with the noted correction was made by Michele Menapace, seconded by Ben Zuhl and was carried without objection.

Department of Housing and Community Development Overview

Mark Buenavista and Vin Rogers from the Department of Health and Community Development gave an overview of the department's activities (see presentation slides). DHCD also serves as administrative staff for the housing authority. DCHD staff shared that the Housing Choice Voucher has a wait list and is currently closed. The CAAB and others in the community are able to advocate for policy changes to the Housing Authority by attending the Fairfax County Redevelopment and Housing Authority meetings which are held on a monthly basis. Any proposed changes would have to be done through amendments to the Housing Authority's Administrative Plan.

CAAB Member Information Sharing

- Michele Menapace Human Services Council presented budget recommendations to the Board of Supervisors. Supervisor Alcorn asked how to get feedback related to nonprofits and the challenges they are facing. The Board of Supervisors was informed that the CSBG funded programs submit quarterly reports in which they detail the challenges they are experiencing – the reports are a good source of information to understand the needs of vendors in the community. CCFAC is having a public comment period on at its April 11 meeting, as well as NOVI (Northern Virginia Idea Exchange).
- Marcia McDevitt Alliance for Human Services has been meeting with members of the Board of Supervisors. The alliance is taking budgetary positions, including county staff salaries and nonprofit salaries. Recruitment and retention of staff is a problem that county agencies and non-profits in the community are experiencing.
- Ben Zuhl Inside Scoop had the manager for field operations for the national low income coalition, as well as John Foust.
- Morgan Jameson World Pride 2025 is coming in June; expecting 3-5M people.
- Ken McMillon shared that the Pan Am shopping Center is being redeveloped into affordable housing.
- Nermine AbdelWahab shared that she is leaving Legal Services of Northern Virginia.
- Michelle Jefferson shared that she, Nermin and Heather attended an engagement session on fair housing hosted by the Office of Human Rights and Equity (OHREP). OHREP has been invited to present to the CAAB at a future meeting.

Adjournment

The meeting was adjourned at 9:17 pm.



A 5-year plan prepared by 3rd party contractor providing goals and strategies to affirmatively further fair housing


- 2016-2020: A Fairfax County-specific plan was prepared
- **Currently:** A multi-jurisdictional Regional Plan is in final review; which includes:
 - 7 Regional Goals
 - Additional local Fairfax County-specific goals
 - Review of progress on Fairfax's 2016-2020 plan

PUBLIC ENGAGEMENT

In March, the OHREP facilitated two community listening sessions for feedback on the proposed eight Fairfax-specific goals

PROPOSED OHREP GOALS

- Increase community awareness of Fair Housing rights by developing and providing new Fair Housing training and outreach activities.
- Enforce the Fairfax County Human Rights Ordinance through testing-initiated complaints that identify areas of concern.
- Increase the accessibility of fair housing services for individuals with disabilities and for whom English is not their first language.



Outreach on Housing Choice:

• "My Neighborhood" and "Predatory Lending" video campaigns

- Bus transit campaign (including Spanish language advertisements)
- 250,000 mobile-message campaign to zip codes of predominantly African American and Latino communities

Fair Housing Testing:

- 122 tests between June 2019-March 2021
- March 2022 published testing report
- Testing currently ongoing

- Fair Housing Task Force
- NVAR
- Promotion of diversity materials

Outreach to Individuals with Disabilities

- Reasonable Accommodations the focus of 2022 Fair Housing month webinar
