**HOUSING WAITLIST OPENING.** Beginning on June 7, the Fairfax County Redevelopment and Housing Authority will be accepting online preliminary applications for placement on the waiting list for publicly owned housing through the Rental Assistance Demonstration Project-Based Voucher program (RAD-PBV). Online applications will be accepted June 7-13, 2021. Complete details about this program and the application and selection process are available online.

SELECTION ADVISORY COMMITTEE FOR THE CONSOLIDATED COMMUNITY FUNDING POOL. An all-citizen Selection Advisory Committee (SAC) to be appointed by the Deputy County Executive for Health and Human Services will be tasked with reviewing and evaluating Consolidated Community Funding Pool proposals and making recommendations on how funds should be distributed to community partners that provide support to Fairfax County residents. A pre-service orientation will be provided, and this volunteer opportunity can be done entirely virtually if requested.

## **COVID-19 Updates**

- ♦ Gov. Ralph Northam updated his <u>executive order</u> to align with recent announcements by the Centers for Disease Control and Prevention. Some highlights: Mask requirements for indoor activities have changed for fully vaccinated individuals and social distancing and capacity restrictions have been lifted. Virginia's state of emergency will remain in effect at least through June 30.
- The Virginia Department of Health (VDH) announced that providers across the Commonwealth could begin vaccinating ages 12-15 following federal approval of the Pfizer-BioNTech COVID-19 vaccine for use in adolescents. Appointments can be made on the <u>Vaccine Administration</u> <u>Management System</u> (VAMS) website.

Transportation is available via FASTRAN if you do not have a ride. Register when you schedule your vaccine appointment.

After receiving a vaccine dose, people will receive a vaccination card that lists the type of vaccine received and the date the shot was given. This card is proof that people are fully vaccinated. If a card is misplaced, people can send an email to Virginia Immunization Information System (VIIS) help desk at <a href="mailto:vaccinerecord@vdh.virginia.gov">vaccinerecord@vdh.virginia.gov</a> or call the VIIS help desk at 1-866-375-9795 to request a copy of their vaccination record. The help desk operates from 8:30 a.m. to 5:30 p.m. Monday-Friday. People can also request a copy their vaccination record by filling out an <a href="mailto:lmmunization Record Request Form">lmmunization Record Request Form</a>. People should receive a response within 24 to 48 hours.
