CHAIRMAN'S MATTERS

- Mr. Bouie stated that he had a great vacation and hoped everyone had a great 4th of July.
- He thanked everyone that attended the Board of Supervisors' meeting to receive the proclamation declaring July Park and Recreation Month. The Supervisors had good things to say about Parks.
- There is a lot of summer league stuff going on such as camps and all sort of cool things.
- Mr. Bouie thanked staff knowing that things were tough with the major rainfall, which the board will receive an update on as well as some other good news.
- He would like to publicly thank Samantha Hudson who recently left Parks for a new job at the County's Office of Strategy Management for Human Services. He would like to thank Sam on behalf of the board for the absolutely tremendous job she did.

DIRECTOR'S MATTERS

- Mr. Kincannon reported that due to the rainstorm several Park Authority sites are impacted. Here is the latest information:
 - Riverbend Park's boat ramp is now open but boat rentals won't open this weekend.
 - Portions of the Potomac Heritage Trail at Riverbend Park are still closed.
 - Scotts Run West Parking Lot is still closed.
 - The CCT from Wakefield to Route 50 is clear; however, many park trails have debris or trees down
 - Byron Ave 2,3, & 4 – flood damage – closed
 - Rutherford 1 – wet – closed

- Pinecrest Golf Course closed due to sink holes
- Bridge at Lewinsville Park closed
- Pond trails at Green Spring Gardens Park closed
- Riverbend: 350 feet of trails washed out – damage to emergency vehicle access
- Riverbend boat ramp high water damage and debris
- Scotts Run: Parking lots and trails washed out
- Lewinsville bridge damaged but was scheduled for replacement in August
- Pinecrest Golf Course: sink holes and cart path damage
- Byron Avenue Fields and Rutherford Park: ballfield damage, fence damage, and lots of debris
- Green Spring Gardens: damage to paths near the pond
- Gerry Connolly Cross County Trail: lots of debris and trees damage, assessment still underway but from Wakefield to Route 50 has now been cleared
- Huntley Meadows: Trail damage, trees on boardwalk
- Spring Hill RECenter: water leaks in the windows; pool filter UV lamp damaged
- Colvin Run Mill: flooding in historic mill building

Parks has been inundated as all the communities in the area have been. Staff was out following the storm to begin to make assessments. He believes that Parks has the ability through the county which is self-insured to get some of the funding to get some things replaced. Hopefully Parks will incur minimal expense. Mr. Kincannon asked that when contacted by colleagues and constituents reach out to ask them to be patient. We have nearly 25,000 acres of parkland and are significantly down in the park maintenance staff because the economy is good, and people are not taking the wages Parks can offer.

- On the good side, Mr. Kincannon recalled that back in January and February Parks talked about the weather and its impacts to Parks and the deficit was almost \$4M. Based on the actions of staff and the leadership, not only by division directors, but also Sara Baldwin, and Aimee Vosper for looking at others ways to fund using proffers, donations, and some of the telecom money in the past, and looking at other opportunities, versus using the revenue fund and the general fund. Parks will mostly likely end the year at about \$1.2M - \$1.5M in the positive. This means that Parks will not have to take the county's \$2M bail out. He has been talking with the budget office and they probably make note of that when they take year end action in July.

Parks will not have to take money from the reserve. The money that the board approved using will not go back in the reserve which will bring it up to about \$2.4M.

The actions the Park Board took related to the telecommunications fund and being able to use the donations in the future will occur in the third quarter transfer. These actions will provide more spending ability next year by using funds that have been locked up and unable to be used, \$1.3M in donations.

Staff has been working on setting budget targets for each site and revenue targets for those revenue producing facilities. Staff has learned that they can run the facilities with less staff. It doesn't mean that they have to work longer hours, just be a little more creative and have better time management.

Even though things have improved the controls are going to remain in place in order to have \$1.5M in net revenue next year as Parks prepares to shut down Mount Vernon and Audrey Moore RECenters. It's important to build the reserve up to 10%; it is at 5% now.

Staff will engage the board in discussions regarding other ways to build the reserve for the future. While the county was magnificent in its support, Parks doesn't want to rely on the county. It is much better if Parks can do it on its own.

- Mr. Kendall noted that the Summer Concert Series in Mason District has not experienced any weather cancellations in the three weeks since it began.

Resolution Honoring Board of Supervisors Chairman Sharon Bulova and Braddock District Supervisor John Cook for Their Outstanding Support of the Preservation and Public Enjoyment of Historic Oak Hill

ISSUE:

Seeking approval of the resolutions to honor Chairman Sharon Bulova and Braddock District Supervisor John Cook for their support of the preservation of historic Oak Hill and ensuring public access to the site.

RECOMMENDATION:

The Park Authority Executive Director recommends approval of the resolutions honoring these officials for their steadfast support of historic preservation at Oak Hill.

TIMING:

Board action is requested on July 24, 2019.

BACKGROUND:

Oak Hill is a privately owned 18th century Georgian-style home that was preserved in October 2004 when the Board of Supervisors, Park Authority Board, and Northern Virginia Conservation Trust negotiated the purchase of an historic easement from Seville Homes. As part of that agreement, limited public access to the site is provided each year. The property was slated for development at the time.

The home and adjacent property are part of the original Fitzhugh land grant, the Ravensworth Tract – totaling more than 22,000 acres – dating from the 1680s. In Fairfax County, Oak Hill is the sole surviving plantation home built by the Fitzhugh family. Today, the original home remains intact along with much of the historic landscape, including 200-year-old boxwoods.

Since the enactment of the agreement in 2004, the community has been invited into the home each year for historic reenactment, refreshments, music and tours. In 2018, the program was cancelled due to the need for repairs but this year, the program will once again be held for the public on Saturday, September 21, from noon until 4 p.m.

The use of an historic easement, the partnership and collaboration between all parties including neighbors, and the ultimate protection of the historic property as well as the

granting of public access in perpetuity are all noteworthy and unique. Both Chairman Bulova and Supervisor Cook have ensured these agreements continue to flourish and have supported the annual event with funding as well as staff time and resources.

Braddock District Supervisor Cook noted, "Oak Hill brings the history of Braddock to life. This event offers a fascinating opportunity to learn more about our community's past."

Chairman Bulova, then the Braddock District representative and in large measure the architect of the agreement that ultimately protected the site from development, noted, "We were very grateful to Seville Homes." She added, "Once they realized how interested I and the community were in preserving not just the manor house but also the grounds, they voluntarily entered into the historic easement arrangement."

BACKGROUND:

For more than 25 years from June through August, the Fairfax County Park Authority carries on the American tradition of summer concerts by offering musical performances, children's shows, international cultural performances, and drive-in movies. The Summer Entertainment Series brings together 11 local series featuring 170 free performances at 16 venues. Performances are supported by donations from corporate sponsors and individuals through the Fairfax County Park Foundation and in partnership with the Fairfax County Board of Supervisors. Each summer approximately 40,000 persons attend the performances.

Summer 2019 marks the last season for several members of the Board of Supervisors who have been instrumental in the development and expansion of the Summer Entertainment Series.

First envisioned by Chairman Sharon Bulova in 2013, the "Evening on the Ellipse" concert series is held on the back lawn of the Fairfax County Government Center on Thursday evenings during July and August. Prior to that time, Chairman Bulova was the driving force behind Braddock Nights, which led to the expansion of concerts countywide.


