Mr. Bouie called the meeting to order on May 22, 2019, at 5:45 p.m.

Mr. Johnson offered the minutes from the 2018 Annual Meeting for review. There were no objections. A motion was forwarded by Mr. Bouie to accept the minutes. It was seconded by Mr. Thompson and unanimously approved.

Mr. Johnson reviewed the 2018 Public Links Annual Report. Mr. Thompson noted that there was no break out for the wine expense at Burke Lake. Staff will provide those numbers to the board.

New Business

Mr. Johnson provided an update on the status of adding wine to the Twin Lakes and Pinecrest ABC Permits. Pinecrest added wine to their beer permit in January 2019 and Twin Lakes added wine in April 2019. Mr. Johnson noted that the addition of wine, coupled with the range and clubhouse renovation at Burke Lake made a positive impact on the significant increase of alcohol sales at that site. Mr. Johnson also reviewed the full liquor license operation at Laurel Hill. Currently, Laurel Hill only services liquor during private events. Mr. Bouie asked why liquor was not sold all of the time to include the other user groups. Mr. Johnson explained that the current staffing age and level at Laurel Hill were considerations in that decision. Mr. Bouie asked staff to look into adding liquor at the other golf sites, stating that such a business expansion could bring in significant additional revenue.

Mr. Bouie presented the slate of officers for election to the Public Links, Inc. Board of Directors. The following people were elected by unanimous vote:

2019 Annual Report

Introduction/Overview

Public Links Inc. operates alcoholic beverage concessions at the following six Fairfax County Park Authority golf facilities: Burke Lake, Greendale, Jefferson, Laurel Hill, Pinecrest and Twin Lakes.

Gross revenues in 2019 for Public Links Inc. were \$391,083. This was a 15% increase over 2018 gross revenue, net revenue was up \$29,855 or 15%. Total expenses were up \$18,362 but were flat compared to expenses relative to revenue. The total paid to FCPA was \$264,133, an increase 61% or \$100,575 from 2019.

Liquor was added in the summer of 2018 to the offerings at Laurel Hill and their ABC license was updated accordingly.

No major expenditures from Public Links for any course.

THIS LEASE, made this 22nd day of July, 2020, by and between FAIRFAX COUNTY PARK AUTHORITY, hereinafter called Landlord, and PUBLIC LINKS, INC., hereinafter called Tenant.

WITNESSETH:

That for and in consideration of the mutual covenants and promises herein contained by and between the parties hereto, the Landlord agreed to lease to the Tenant the right to use the Clubhouses and adjacent grounds at Greendale Golf Course, Twin Lakes Golf Course, Pinecrest Golf Course, Burke Lake Golf Course, Jefferson Golf Course and the Laurel Hill Golf Club for a period beginning at 12:00 o'clock Noon, on the 22nd day of July 2020, and ending at 12:00 o'clock Noon, on the 21st day of July 2021, unless otherwise notified or terminated as provided herein, as follows:

- 1. The parties agree that the Tenant shall have the right and privilege to operate a concession for the sale of food, beverages, and beer in agreed areas at the Greendale Golf Course, Pinecrest Golf Course, Twin Lakes Golf Course, Burke Lake Golf Course, Jefferson Golf Course and Laurel Hill Golf Club, Fairfax County, Virginia.
- 2. It is understood that the Tenant will also be entitled to use such facilities, equipment and fixtures provided by the Landlord in the operation of its concession.
- 3. Tenant agrees that they will use said property for the sole purpose of selling food and beverages, including beer, wine and liquor at Greendale, Pinecrest, Twin Lakes, Burke Lake, Jefferson and Laurel Hill Golf Courses and for no other purpose.
- 4. Tenant will not use and will not permit said property or any part thereof to be used for any disorderly or unlawful purpose.
- 5. Tenant will at all times be subject to reasonable rules, restrictions, and instructions regarding the use of the property by the Landlord.
- 6. Tenant agrees to observe and abide by any and all lawful notices, rules, and requests given or made by Landlord for the occupancy, operation, and maintenance of the property.
- 7. Tenant will not cause or permit any signs, advertisements, pictures, fixtures, inscriptions, or notices to be displayed, inscribed upon, or affixed on any part of the outside of the said property except as authorized by Landlord and any applicable public law.
- 8. It is understood that this lease may be terminated by either party upon giving thirty (30) days written notice from either to the other, after which this lease shall no longer be in full force and effect.
- 9. The Tenant will be responsible for the maintenance; cleanliness of all equipment, fixtures, and furnishings supplied to it by the Landlord, and agrees to return the same to the Landlord in the same condition as given initially, less ordinary wear and tear.

- 10. Tenant agrees, at its own cost and expense to keep and maintain all permits and licenses required by the laws of the Commonwealth of Virginia, and the County of Fairfax, and to keep in full force and effect Public Liability insurance in the amount of at least \$100,000 per person in any one occurrence, and no less than \$300,000 in the aggregate in any one occurrence, which coverage shall include Products Liability Protection. Said policy will name the Landlord as an additional insured on the Contract.
- 11. In return for the use of all of the facilities by the Tenant in the Greendale, Pinecrest, Burke Lake, Jefferson, Laurel Hill and Twin Lakes Golf Courses, the Tenant agrees to pay to the Landlord the total of all net proceeds received by it from the operation of its concession.
- 12. All of the terms, covenants, agreements and provisions herein contained shall bind and insure to the benefit of the Landlord, Tenant, their herein, executors, administrators, personal representatives, successors, trustees, receivers, and assigns, as applicable, except as otherwise provided herein.
- 13. All nouns used herein shall be interpreted and construed to include the singular, plural, masculine, feminine, or neuter forms in any place or places in which the context may require to indicate such interpretation and construction.
- 14. Unless otherwise modified by the context of this lease, the word "term" whenever used herein shall include and be construed to mean the original and full term of this lease, any extension or renewal thereof, and the period of time between the beginning of the original term and the termination of this lease for any cause whatever.
- 15. This lease contains the entire agreement between all parties hereto and shall not be changed or modified in any manner except by an instrument in writing executed by the parties hereto.
