#### INFORMATION

#### Update on Garden Plot Program

For at least 20 years, there have been long wait lists to obtain a garden plot within the Park Authority. Staff has implemented several measures to reduce the list or reduce wait times on the list, such as limiting renters to one garden plot, inspecting regularly to be sure plots are actively used, removing renters who are not using their plots according to the rules and guidelines, and re-renting vacant plots as soon as they become available. During the pandemic and continuing to date, interest in gardening is still very strong. Staff continue to work with Planning and Development to identify potential new sites through master planning processes. In addition, staff are members of the Fairfax Food Council's Urban Agriculture workgroup and the Partnership for a Healthier Fairfax work groups, providing advice for community groups that wish to implement a community garden. Nevertheless, interest in renting a garden plot is still strong and the registration list is still long.

The rules and guidelines for the garden plots program were last reviewed and revised with the garden plot renters in 2009. At that time it was agreed that woody plants could be planted, if they remained under 6 feet tall. In the intervening years, woody plants have become a problem. Gardeners are challenged by maintaining them to the 6 feet standard, impacting neighboring gardeners due to shading and water uptake.

With these lessons-learned, woody plants are not permissible at the new plots at Hogge and Laurel Hill. Both sites are raised bed plots and there is potential for root systems to invade the raised bed structures and compromise their integrity.

To date, the registration list is nearly 800, which is greater than the number of plots available. At some locations, registrants are waiting more than 2 years to be offered a plot to rent. FCPA is adding 57 new garden plots combined at Hogge Park and Laurel Hill/Nike site in 2023. The number of new plots provides opportunities for less than 10% of those on the registration list to receive a plot this year.

To allow additional opportunities for wait-listed gardeners to participate in the program, FCPA will implement a 5-year rental limit at the new plots at Laurel Hill. The garden period for the plots at Hogge Park are from April to November. Registrants may garden for one year and then must re-register at the end of the season to be able to garden again, when space is available.

# Garden Plot Program Statistics

- 11 locations, in every supervisory district except Springfield
- 726 plots to rent, including 34 at Hogge and 19 at Laurel Hill
- Fees: \$140 for large plots and large raised beds, \$80 for small raised beds at Hogge.

# Garden Plot Program Issues: Long wait lists and woody plants

#### 2023: Staff Recommendations

- Woody plants (trees, shrubs, woody vines) banned in all garden plots starting in 2024.
- Limits on rental period: 5-year limit on participation beginning with new tenants at Laurel Hill

#### **Fiscal Impact:**

- No fiscal impact to limiting the number of years a renter may continuously garden.
- Eliminating woody plants will likely save funds on raised bed repairs and staff time clearing abandoned plots



# Why Ban Woody Plants?

- ❖ Woody plants: fruit trees, shrubs, cane plants such as blackberries, grapes, hardy kiwi, etc.
  - Difficulty in enforcing current 6-foot limit due to rapid growth of most woody plants.
  - Woody plants and any supporting structures shade other garden plots.
  - Roots can encompass the entire plot and interfere with gardening in neighboring plots.
  - Cane plants spread rapidly and are difficult to remove.
  - In raised beds, woody plant roots can compromise integrity of the structure.
  - New tenants must clear out trees/shrubs expensive and/or physically demanding.
  - Difficult to rent plots and garden in plots that contain woody root systems.

# Managing Garden Plot Demand

#### 5-year rental limit at Laurel Hill

- Only 19 plots available at Laurel Hill
- Greater access for all Fairfax County gardeners with rotating rental periods
- Demand for plots in this area is strong
- FCPA made key investments in beds and fences

# Current measures to reduce the registration list (currently 800+):

- One plot per tenant household
- Regular inspections to remove renters who do not follow rules
- Vacant plots are offered and filled quickly
- Identified potential sites for new garden plots; lack master plan designation and/or funding
- Work with partners to identify new plots on non-county land
- Provide advice on starting community garden plots.

#### **INFORMATION** (with presentation)

#### Deer Management Plan

The Park Authority has been participating in the Fairfax County Deer Management Program since its inception in 1998. The program includes approximately 100 FCPA parks and three treatment methods (archery, managed shotgun hunts, and sharpshooting).

Each year the Park Authority Board receives information about the deer management activities planned for the coming fiscal year, as overseen and implemented by the Fairfax County Police Department.

Unless otherwise directed, staff will proceed with the Deer Management Program as planned.


#### Summary for FY23 (2022-2023)

Attachment 1 summarizes deer harvest results by park and treatment method for the previous season of the Fairfax County Deer Management Program. Two treatment methods were implemented in FY23: archery hunting and police sharpshooting. No managed shotgun hunts were conducted. There are currently no non-lethal methods approved for deer population control in Virginia.

Deer herd reduction activities took place at 102 FCPA parks with 534 deer removed (642 in total including non-FCPA properties).

Archery continues to be the most cost-effective and successful method of herd management, representing 94% of the total program harvest last season. Last season, 521 volunteers participated in the archery program donating 32,832 hours of hunting and scouting hours, for an average of 63 hours per volunteer. These volunteers were organized into 18 hunt clusters and were individually screened (background check, licensure, hunter safety education) and qualified for accuracy to participate by the Fairfax County Police Department. Fairfax County insures these volunteers under its general liability policy.

Sharpshooting was conducted at 5 county parks: Bren Mar Park/Turkeycock Run Stream Valley, Grove Point Park (formerly Franconia Park,) Frying Pan Farm Park, and Huntley Meadows.



#### Planned Activities for FY24 (2023-2024)

Attachment 2 summarizes the parks proposed for the upcoming season of the Deer Management Program, organized by supervisory district.

Parks are recommended for the program based on one or more of the following factors:

- 1. Public safety concerns related to deer-vehicle collisions
- 2. Residential complaints of deer damage near the park
- 3. High estimated deer population in the park (> 20 deer/sq. mile)
- 4. Measurable impact to park vegetation (within browse plots)
- 5. High natural resource value of the park
- 6. At the request of the park manager

All approved hunting and parking areas will be mapped in a Geographic Information System (GIS) by July and made available online to the public as a web map linked from the Police Department's Deer Management Program website (<a href="https://www.fairfaxcounty.gov/wildlife/deer-management-program">https://www.fairfaxcounty.gov/wildlife/deer-management-program</a>). This data is also made accessible to all county employees within the GIS data system.

Archery dates: Saturday, September 9, 2023 - Saturday, February 17, 2024.

Staff propose to add the following FCPA parks for the archery program: Old Courthouse Spring Branch Stream Valley and Raglan Road Park (Hunter Mill District). Sharpshooting may also be used as an alternative to archery at these parks.

Sharpshooting dates: Various dates (TBD) between November 2023 – March 2024.

Operations will not be conducted over the Thanksgiving holiday from November 22 – 26, 2023 or during the winter holiday season from December 20, 2023 – January 1, 2024.

Staff propose to add the following FCPA parks for the sharpshooting program: Bull Neck Stream Valley, Hill District Park, McLean Hunt Estates (Dranesville District); Fox Stone Park, Waverly Park, Lake Fairfax Park (Hunter Mill District); and Nottoway Park (Providence District.)

The upcoming sharpshooting schedule will also include Bren Mar/Turkeycock Run Stream Valley, Grove Point Park/Monticello Woods, Frying Pan Farm Park, Dranesville Tavern/Grand Hamptons Park, and Huntley Meadows/Dogue Creek Stream Valley, that have been included in prior years. Lake Fairfax and Huntley Meadows Park will receive a combination of management methods including a shortened archery season followed by sharpshooting in the late season. The final sharpshooting schedule will be dependent on FCPD staffing and number of available nights during the fall and winter.

<u>Shotgun hunts:</u> No managed shotgun hunts will be conducted in the Sully Woodlands area in FY 2024 due to low harvest using this method in recent years and to reduce program operating costs. Hunts have been held in this area over most seasons dating back to FY 2006, with only a few exceptions. Elklick Preserve, Halifax Point District

Park, Mountain Road District Park, and Rock Hill District Park will remain in the archery program and only archery will be used at these parks for deer herd reduction in FY 2024. Richard W. Jones Park (Pleasant Valley Golf Course) will not be included in the program since managed hunts are not being conducted.

<u>Public Notification:</u> Notification letters will be mailed to property owners adjacent to approved park sites in July 2023. Letters are mailed to residences that fall within 200 feet of parks included for archery and within 500 feet of parks included for sharpshooting. Over 23,700 letters were mailed in FY 2023.

#### FY24 Deer Management Program Public Information Meetings:

Links to a recorded webinar providing an overview of the Deer Management Program will be posted on the county's Deer Management Program website in August as has been conducted for the past three years. Public meetings for the FY 2024 Deer Management Program have not been determined at this time. If there are concerns about new park additions (or existing parks), staff will be available to speak with or meet with residents, HOAs, Civic Associations, etc. as needed to address concerns.

#### **Data Collection Efforts**

Data collection efforts in FY24 focus on the following components of the program:

- 1) Evaluating the browse impact of deer on native vegetation
- 2) Conducting deer density estimates with game camera surveys
- 3) Monitoring reportable deer-vehicle collision (DVC) trends
- 4) Collecting herd health data over the course of the season

#### Browse Impact Surveys

Park staff have established 556 permanent vegetation plots in 61 parks included in the Deer Management Program. Deer browse impacts to native woody vegetation are measured at each plot location. In FY 2023, 155 browse plots were surveyed by park ecologists. Plots will be resampled at 4-year intervals to evaluate deer browse impact trends over time.

#### Camera Surveys

Deer density surveys have been conducted annually in select parks using infraredtriggered cameras to estimate the number of deer visiting a bait station to examine deer Board Agenda Item May 24, 2023

population trends over time. In August 2022, camera surveys were conducted in 21 parks (53 camera stations).

Recent changes associated with the detection of Chronic Wasting Disease will affect monitoring efforts going forward. A year-round deer feeding ban has been in effect in Fairfax County since last year, but the Virginia Department of Wildlife Resources (DWR) had given special authorization to use bait for camera surveys conducted through the Deer Management Program. With CWD now confirmed in the county, the DWR will no longer authorize the use of bait for camera surveys. This restriction will require the use of alternative methods to estimate deer population metrics. Staff are examining other field methods that are comparable to camera surveys but will likely not have a new method in place during FY 2024.

Staff are investigating the possibility of using small Unmanned Aerial Systems (drone) to conduct deer density surveys. Surveys using this technology have been recently used to conduct deer surveys in county parks in Montgomery County, MD and countywide in Arlington County, VA. More information will be provided to the Board of Supervisors and the Fairfax County Park Authority for review and discussion after we receive proposals to determine whether a drone pilot study might be feasible and if funding can be identified to support these surveys.

#### Deer Vehicle Collisions

Collisions involving deer in Fairfax County have resulted in injury and fatality of residents and extensive property damage. Reportable crashes in Fairfax County include police reports through the Traffic Records Electronic Data System (TREDS). These reportable crashes include accidents that result in injury or fatality, or property damage exceeding \$1500. According to data from TREDS, an average of 103 reportable deervehicle collisions (DVCs) occurred annually in Fairfax County since 2010, ranging from 75-120 DVCs a year during that time frame. Overall, there is a declining trend in reportable DVCs countywide, with 85 DVCs reported during the 2022 calendar year. It should be recognized that actual DVCs are underestimated because not all collisions are reported to the police or meet TREDS criteria.

#### Herd Health Data - Chronic Wasting Disease

During the 2022-2023 deer hunting season, the DWR confirmed CWD in an adult male deer legally harvested on private land in Vienna, Fairfax County. As a result of this detection, Fairfax County has been added to CWD Disease Management Area 2 (DMA2) by the Virginia Department of Wildlife Resources (DWR) beginning in the 2023-2024 deer hunting season, which also includes Arlington, Culpeper, Fauquier, Loudoun, Madison, Orange, Page, Prince William, and Rappahannock Counties.

Attachment 3 summarizes the CWD surveillance efforts. In FY 2023, over 49% of the deer harvested from the Fairfax County Deer Management Program were tested for CWD. Samples were collected from 318 deer (172 bucks, 146 does) harvested in 82 parks. Most samples (92.5%) were from hunter-harvested deer in the archery program. Collectively, county staff have sampled and tested 776 deer from 103 parks/properties harvested through the Fairfax County Deer Management Program since FY 2020 in collaboration with the DWR and local hunters.

Staff have used "CWD Surveillance Drop Sites" in accordance with DWR guidelines to sample a greater number of deer harvested in the archery program. This includes temporary establishment of small freezer stations where hunters drop off samples from harvested deer for CWD testing. Freezer drop sites are secured from public access and operated from October – December. FCPD Wildlife staff monitor the locations and process the material for lab submission. Drop sites were established at Burke Lake, Lake Accotink, Lake Fairfax, Grist Mill Park, and the Flatlick (Area 5) Maintenance Shop in prior years. With FCPA permission, staff will establish freezer drop sites at these locations again for hunters in the county program to have their deer tested for CWD.

#### Deer Transport and Processing Challenges

With the inclusion of Fairfax County in the CWD Disease Management Area, restrictions regarding transport of deer went into effect on May 1. Whole deer carcasses and any parts containing brain and/or spinal cord tissues originating from Fairfax County may only be transported to locations within DMA1 and DMA2 which includes Fairfax, Prince William, Arlington, Loudoun, Fauquier, Rappahannock, Culpeper, Page, Madison, Orange, Frederick, Clarke, Warren, and Shenandoah counties. This restriction will impact hunters in the Deer Management Program who either live outside of these counties or use processors and taxidermists outside these DMAs. To assist with hunter retention and minimize impacts, staff are looking to establish one or more stations in discrete locations where hunters could break-down their harvested deer (i.e., quarter, debone) to meet legal requirements for carcass transport if necessary. These locations could potentially include county parkland if permission were granted.

The lack of deer processors in Fairfax County is becoming a critical issue that has potential to impact recruitment and retention of hunters in the Deer Management Program. Currently, there are no deer processors that are operational within Fairfax County. Individuals have tried to open for-profit processing businesses and non-profit charities to process deer and donate to local food banks but have not been able to identify suitable locations due to county code and zoning restrictions. As such, hunters must take the harvested deer to processors outside the county or butcher their own deer. Additionally, program staff must take deer harvested from sharpshooting

operations to outside processors to donate to Hunters for the Hungry and other food banks, since there are no operations within Fairfax County.

There are only a limited number of processors in neighboring counties where deer can be transported under CWD regulations. These processors are typically inundated with heavy demand and often reach capacity in mid-November when they are no longer able to accept more deer, or close before the deer season ends. Some processors have considered shutting down their business. This situation could result in less program participation and lower deer harvest if hunters have nowhere convenient to take their deer and local processors are at capacity or shut down, coupled with the transport restrictions due to CWD. Given these circumstances, it would be prudent to reexamine county code and zoning requirements to determine if an exception can be granted for deer processing operations in Fairfax County to minimize impacts to deer management efforts and increase local donations of venison to those in need.

#### Venison Donations

Food insecurity has increased in many areas resulting from unemployment or other economic constraints. Additionally, there is growing interest in the consumption of local, sustainable wild game for health reasons and a movement towards "field to fork" initiatives. The Deer Management Program helps to address these needs by providing locally sourced venison that is donated for food to individuals in need through local processors and charitable organizations. Over the past seven years, 2,066 deer harvested in the county's Deer Management Program have been donated to provide food for people in need. This includes 871 deer donated to Hunters for the Hungry and 1,195 deer donated directly to individuals and families. Based on a conservative estimate of 30 lbs. of venison per deer, this equates to 61,980 lbs. (247,920 meal servings) of donated venison. Staff will continue to track the contribution of venison donations through the county program in the upcoming season.

#### FISCAL IMPACT:

The Police Department dedicates time of one Wildlife Management Specialist (Katherine Edwards, Ph.D.) and one Animal Protection Police Supervisor (Sergeant Earit Powell), with two full-time Assistant Wildlife Biologist positions and two seasonal assistants supporting field tasks during the hunt season. Additional overtime is authorized as needed for Police Department personnel to provide sharpshooting services and security during night-time sharpshooting operations and daytime managed hunts when conducted.

# Fairfax County Deer Management Program 2022-2023 Chronic Wasting Disease Surveillance Update

Chronic Wasting Disease (CWD) is an incurable disease, found in deer, elk, and moose in North America. It is a slow-acting and progressive neurologic disease that ultimately results in death of the animal. The disease-causing agent is spread through the urine, feces, and saliva of infected animals and through water or soil contaminated with prions. Clinical signs of CWD, which typically do not develop for several months to over a year after exposure, include staggering, abnormal posture, lowered head, drooling, confusion, and marked weight loss.

CWD was first diagnosed in Virginia in 2009 and has been subsequently detected in 13 counties: Clarke, Culpeper, Fairfax, Fauquier, Floyd, Frederick, Loudoun, Madison, Montgomery, Pulaski, Rappahannock, Shenandoah, and Warren counties. As of March 2023, 178 white-tailed deer have tested positive for CWD in Virginia.

The Virginia Department of Wildlife Resources (DWR) is responsible for CWD surveillance and management and has established three DWR Disease Management Areas (DMA), which encompassed 15 counties in Virginia during the 2022-2023 deer hunting season. DMA1 included the counties of Clarke, Frederick, Shenandoah, and Warren. DMA2 included the counties of Culpeper, Fauquier, Loudoun, Madison, Page, Orange, and Rappahannock Counties and DMA3 encompassed Floyd, Montgomery, Pulaski, and Carroll counties.

During the 2022-2023 deer hunting season, the DWR has confirmed CWD in an adult male deer legally harvested on private land in Vienna, Fairfax County. The deer was brought to a taxidermist in late October of 2022 and DWR obtained the sample shortly thereafter as part of the Department's proactive statewide CWD surveillance efforts. At the time of harvest, no outward signs of disease were noted, and the deer appeared to be in good condition. Because this is the first CWD-positive detection in Fairfax County, the DWR conducted an extensive forensic investigation to confirm the harvest location of this deer.

As a result of this detection, DMA2 will be expanded to include Fairfax, Prince William, and Arlington counties for the 2023-2024 deer hunting season. In accordance with the DWR's CWD Management Plan, regulatory actions will go into effect in Fairfax, Prince William, and Arlington counties beginning May 1st, 2023, and will include the following:

#### 1. Prohibition on white-tailed deer fawn rehabilitation

Rehabilitation of deer fawns is prohibited within Fairfax County and deer fawns originating from Fairfax County may not be rehabilitated in any other locality.

#### 2. Restricted carcass transport

Whole deer carcasses and any parts containing brain and/or spinal cord tissues originating from Fairfax, Prince William, or Arlington counties may only be transported to locations within DMA2 and DMA1 which includes Fairfax, Prince William, Arlington, Loudoun, Fauquier, Rappahannock, Culpeper, Page, Madison, Orange, Frederick, Clarke, Warren, and Shenandoah counties.

In addition to these new restrictions, a year-round deer feeding ban is in place in Fairfax County in accordance with state wildlife regulation (4VAC15-40-285). Feed and bait piles, including

mineral licks, artificially congregate deer, thereby facilitating both direct disease transmission between sick and healthy deer and indirect transmission through exposure to a contaminated environment. The feeding ban restricts the placement or distribution of any food, salt, mineral or similar substances for any purpose if the placement of these materials results in the attraction of and/or feeding of deer and applies to both public lands and private properties.

Over the past four years, staff have taken a proactive approach to conduct voluntary surveillance due to the potential impacts of CWD on deer populations in the Commonwealth and the likelihood it would spread to Fairfax County. Staff were trained by DWR personnel and follow agency guidelines for the sampling of deer and testing for CWD, which includes the removal of medial retropharyngeal lymph node samples from harvested deer. Only yearling and adult deer were tested; no fawns were submitted for testing per DWR guidelines.

Samples from harvested deer were collected through police sharpshooting efforts and the use of "CWD Surveillance Drop Sites" for the archery program. Drop sites consisted of small freezer stations that were temporarily established, with property owner permission, on county parkland and hunt club property, where hunters could drop off samples from deer harvested in the Fairfax County Deer Management Program for CWD testing. Freezer stations were located at Burke Lake, Lake Accotink, Lake Fairfax, Grist Mill Park, the Flatlick Maintenance Shop (Area 5 Shop), Bull Run Regional Park, and the Izaak Walton League. Sites were secured from public access and operated from October – December. FCPD Wildlife staff monitored these locations during the program season and processed the samples for lab submission. Deer harvested during sharpshooting operations between November and March were also tested before donation to individuals, food banks, and charitable organizations including Hunters for the Hungry.

This season, Fairfax County Deer Management Program conducted voluntary sampling of white-tailed deer for CWD between September 2022 and March 2023. Over 49% of the deer harvested from the Fairfax County Deer Management Program during the 2022-2023 deer season were tested for CWD. Lymph node samples were collected from 318 deer harvested in 82 parks in Fairfax County, VA. Of the deer tested, 294 samples (92.5%) were from hunter-harvested deer through the county's archery program, 21 samples (6.6%) from county sharpshooting efforts, 2 deer dispatched by the Animal Protection Police (<1 %), and 1 deer found dead (<1%). Overall, 146 does and 172 bucks were sampled. The mean age of sampled does was 2.7 years (range = 1.5 to 9.5 years), and the mean age of sampled bucks was 2.6 years (range = 1.5 to 7.5 years). Mean sample age overall was 2.6 years. The increased sampling this season was made possible due to a generous donation from Safari Club International, National Capital Chapter, to support enhance CWD surveillance efforts. Collectively, county staff have sampled and tested 776 deer from 103 parks/properties harvested through the Fairfax County Deer Management Program since FY 2020 in collaboration with the DWR and local hunters (Tables 1-5; Graph 1).

Samples were submitted for analysis to the Wisconsin Veterinary Diagnostics Laboratory in Madison, WI. All test results from deer harvested on county parkland have come back as CWD "Prions Not Detected." This result is based on current transmissible spongiform encephalopathy (TSE) research, noting the possibility of protease resistant prion protein (PRP-RES) present at levels below detection sensitivity of the test. PRP-RES may also be present in other tissues not submitted for testing. All test results were reported to the State Wildlife Veterinarian and Wildlife Disease Biologist with the DWR.









# Fairfax County Deer Management Program FY 2023 Summary Statistics

- Deer herd reduction activities took place at 102 FCPA parks
- 534 deer harvested from FCPA parks
  - 502 deer harvested by archery
  - 32 deer harvested by sharpshooting
- 521 volunteer archers donating 32,832 hours of hunting and scouting hours
- 642 deer harvested in total including non-FCPA properties
- Archery continues to be the most cost-effective and successful method of herd management, representing 94% of the total program harvest last season.

## Fairfax County Deer Management Program Monitoring

#### **Browse Impact Surveys**

- Measure deer browse impacts to native woody vegetation
- 556 permanent vegetation plots in 61 parks
- In FY 2023, 155 browse plots were surveyed by park ecologists.
- Plots will be resampled at 4-year intervals.

#### **Deer Density Camera Surveys**

- In August 2022, camera surveys were conducted in 21 parks (53 camera stations).
- Baited camera surveys can no longer be used due to CWD regulations. Staff are examining alternative field methods but will likely not have a new method in place during FY 2024.


