Subject: Proposed Budget Cuts for Parks

Dear Fairfax County Board Members and Officials,

It is my understanding that the Fairfax County Executive is asking county agencies, including the Park Authority, to reduce their budget proposals. As a lifelong Fairfax County resident, I believe the county should increase park funding, not reduce it.

Public parks are historically the targets of decreased funding or ceased funding. Parks are so vitally important to not only the health of the ecosystems, but adds to local offerings where residents and families can spend quality time engaged in activities in a healthy, safe environment.

Among the suggested cuts are not funding new positions in forestry and bamboo mitigation that have not been filled, closing park restrooms, reducing trail maintenance, and increasing fees for children's summer programs while reducing their availability. These cuts are all unnecessary and would be a mistake.

Fairfax County is overrun with nonnative, invasive plant species such as bamboo. Management and/or eradication of these species is critical. Park restroom numbers are low as is. Closing them is threat to public health should visitors use the woods as a rest area. Keeping these open is important to the health of the park and convenience for visitors.

Fairfax County parks already receive less than 1% of the county budget. Reducing spending for our parks sends the message that these areas are not a priority. Please do not let the parks slip through the cracks and become another statistic. They are vital for residents and wild species alike.

Ladies and Gentlemen,

RE: OPPOSE General Fund Budget Reductions for Fairfax County Parks

As a resident of Oakton, VA and a Fairfax Master Naturalists, I oppose the budget reductions for Fairfax County parks!

My family continues to support an increase budget for Fairfax County parks, particularly as that budget supports efforts to maintain healthy ecosystems that protect and conserve natural resources. We were disappointed to see possible cuts of general fund monies for the FY 2025 budget amounting to approximately \$2.4 million.

Instead of cuts, we ask you to urge the Board of Supervisors to increase funds for county parks, to bolster efforts to acquire more land, restore degraded lands and create more natural resource-focused parks. These steps can help implement the county's climate action, resiliency, and natural

landscaping plans; increase trees and other natural vegetation that absorb carbon and other pollution and stem stormwater runoff and help reverse declines in birds and insects.

The parks are already poor cousins in the Fairfax County budget, receiving less than 1% of the County funds. There is no fat to cut. We understand that the Park Authority has suggested, in response to a request from the County Executive for a 7% reduction of monies from the general fund for 2025, eliminating new personnel positions, specifically two forestry positions and a bamboo mitigation position. Given the accelerating effects from climate change, the parks cannot afford to put off hiring personnel whose job is to maintain a healthy park ecosystem through attention to tree health and combating invasive plants. Trees and a healthy forest environment mitigate the effects of climate change and provide much needed relief from urban heat islands for the growing Fairfax County population.

The parks are more essential than ever to wildlife AND community health. Closing restrooms could send park users into wooded areas to the detriment of the environment. Reducing trail maintenance can reduce opportunities for appreciation of the parks' natural resources. Increasing the cost of and reducing availability of Rec-Pac youth programs is particularly problematic for low-income families. I encourage you to oppose requests to cut the parks budget. Subject: Funding for Fairfax County Parks

I am writing to urge you not to cut funds from the Fairfax County Parks. I am a registered voter who has lived in the Mason District for nearly 30 years. The park system was one of the reasons we moved into the county. Over the years, we took our children to Fairfax County parks nearly every weekend, sent them to summer camps, and took advantage of the wide offering of after-school classes. As the world faces unprecedented challenges to the environment, our children must learn how to respect and co-exist with nature. Fairfax county parks create a love and respect for the outdoors that is fundamental to creating the political will to face climate change.

As the director of <u>Diva Crows</u>, a non-profit that rehabilitates injured and orphaned songbirds, I have partnered with the park service for several years to conduct educational programs to teach children (and adults) to be good avian neighbors. I have introduced non-releasable songbirds to audiences at Lake Accotink, Burke Lake Park, Ellanor Lawrence, Long Branch, and Hidden Oaks. I do not charge anything for the programs and audiences get to see birds up close and learn about the species who live in their backyards. It is a partnership that benefits all parties; cutting back on park staff and programs would

undermine the work that we are doing. I'm sure the same is true for many other groups who use the parks as a platform for their public service messages.

In short, Fairfax parks are essential to the quality of life in the county. If one needs to save money, cutting a program that represents 1% of the budget will not solve the problem. Better-funded programs should be the place to start budget cuts.

Dear Fairfax County Park Authority Board,

I am writing to express my support for funding our parks, and in particular in support of programs for equity and natural resource management. In an era where we are all experiencing some degree of social disconnection and already are seeing the impacts of climate change, we need to invest more in our parks, not less. This week's heat wave is a reminder of the importance of accessible shady, green spaces for all communities in the county. Even with the recent increased contributions of the general fund to FCPA, FCPA still receives less than 1% of the county budget, a

paltry amount for such an important part of our County's programming, beauty, biodiversity, and community.

When my family and I moved to Virginia in 2021, we bought a house right next to a path leading into Hidden Pond, one of Fairfax County's many wonderful parks. The trails in the woods behind our house were our favorite thing about our new home. We consider ourselves tremendously lucky to be able to walk into our park just a few feet from our door, and we take advantage of it every single day. My children, ages 3 and 6, are privileged enough to be able to explore nature just beyond our backyard, to be able to walk to a playground and a nature center. We have the funds to be able to sign my older daughter up for summer camp programs through the FCPA as well.

Unfortunately, not everyone is as privileged as we are to be able to access beautiful parkland and afford educational programming within walking distance of their homes. On average, wealthier and whiter neighborhoods like mine have much more access to green space than communities of color and poorer communities. Increasing county funding for parks will help transition to a more equitable model of funding where all Fairfax County residents have equal access to high-quality parks and recreational services. Additional funding for staff and for increased ecological stewardship is so important if we want to provide equitable access and educate a new generation of Fairfax residents who care for the earth and its many inhabitants (flora and fauna).

I'll also add that the overwhelming presence of invasive species in our woods cannot help but make an impression on me every single time I walk in the woods (every day). The parks need more staffing and assistance to discourage these invasives and encourage biodiversity. The invasives are becoming out of control; not only harms the beauty of our parkland but also contributes to problems with erosion and native species loss.

In addition, I am extremely concerned about the climate crisis and am aware of the importance of taking care of our green spaces not just for our enjoyment, but for the sequestration of carbon, the maintenance of biodiversity, and the increase of resilience against flooding. Parkland is on the front line for future climate resilience. Keeping the county's 24,000 park acres healthy serves us all with cleaner air and water, flood control and higher property values. If funding is cut, the Park Authority cannot adequately steward our forests, implement equity initiatives, and so much more. Budget cuts to FCPA completely undermine important strides the BOS has made to adequately fund programs such as the park ranger pilot program and dealing with invasive species. Please reconsider.



We have had the pleasure of enjoying an ice cream at Burke Lake. We learned about making cornmeal like the Native Americans at Huntley Meadows and we made reptile keychains and s'mores at Ellanor C. Lawrence park.

I could list more of the numerous park related activities I have been lucky enough to engage in, but, in an effort to avoid being redundant, I will try to make my case as to why I feel our parks are so integral. We are so lucky to learn in such a beautiful county. The wetlands at Huntley Meadows are renown for being home to so many migratory birds, wetland reptiles, and native plant species; so much so that it entertains visitors from all over Virginia and even other states. Riverbend Park has one of the most magnificent display of Virginia Bluebells I have ever seen. Green Springs offers free classes teaching people how to grow their own vegetables. These parks and programs encapsulate much of what makes life enjoyable and worthwhile. In short, we absolutely cannot afford to cut funding to such a fundamental and community-building branch of our government.

My name is Claudia Rojas and I am a long-time resident of Fairfax County, having arrived in Falls Church at age 7 from El Salvador. I am writing to express my support for a park budget that prioritizes equity and healthy ecosystems. I oppose cuts to the Park Authority's budget when the budget is already underfunded.

Growing up in the Culmore area as a child, I was limited to the elementary school playground which is within walking distance. I was fortunate to enjoy days at the library, though many kids prefer more active hobbies. As I've grown older, I've noticed how limited park space is for this area. There is a small park next to the Woodrow Wilson Library with some green space and benches. Next, there is Justice Park which is currently undergoing habit restoration.

I joined the volunteer-led effort at Justice Park this past summer after volunteering in my neighborhood and understanding that so many of our children and youth fall into bad habits--quit school, cope with drugs--not because they want to, but because the green spaces, the healthy outlets are limited. One of the biggest tragedies for me is that Latinx and immigrant children live right next to Lake Barcroft, a private lake property, which they are likely never to be invited to, and are far more likely to join a gang than to enjoy a summer day with water activities right around the corner. I hope you consider the impact of cutting the park budget.



My name is Jamie Bacon and I live in Alexandria. I want to express my opposition to significant cuts to the Park Authority's budget for a number of reasons.

I only moved to Alexandria this past June but I have decades of experience with how important maintaining parks and nature reserves is for a community. I'm a biologist who studied the effects of pollution on Bermuda's wetlands and wildlife and who also witnessed the plague of invasive species in Bermuda's forests. I was also Education Officer for the Bermuda Aquarium Museum and Zoo for 10 years where we would run 5-6 natural history camps per week during the summer for children from preschool to high school in age.

I am quite concerned that you are suggesting eliminating the new forestry positions and the bamboo mitigation position. Forestry management, such as controlled burns, is now more important than ever as evidenced by the numerous forest fires seen in North America and elsewhere. Without management, diseases and invasive species can also create havoc within an ecosystem in a short period of time.

I am also concerned that you are proposing reducing your Rec-Pac sites by 25%. I know how important summer camps can be to both the children and their working parents and I think this reduction could have quite a negative impact for local families.

Finally, I really believe that eliminating bathrooms can negatively impact visitors to the point that they will not visit an area where there isn't a bathroom. If you are eliminating them at athletic field sites, what are the people utilizing that site supposed to do?

In sum, I know how important parks can be for a community, particularly those members who are not fortunate enough to have a yard of their own. This was very evident in Bermuda. My friends are telling me that I will love visiting Huntley Meadows Park and I'm very much looking forward to that as well as exploring other parks within Fairfax County with my grandchildren. In my opinion, leaving a legacy of well-maintained, ecologically healthy parks for future generations should remain a priority for the county.




### Consumer Price Index (CPI)/Baseline Increases: \$658,018

- Overall CPI for most goods and services has stabilized post-COVID, although catch-up funding for past unfunded increases is still required.
- To continue providing our baseline services as they are, additional funds are required.
- Major maintenance contracts are driving large increases in staffing specifically.

# Bamboo Removal on Parkland: \$400,000

- We estimate that there is currently ~200 acres of running bamboo countywide on FCPA property and receive multiple resident complaints per month.
- In response to Fairfax County Code §119-3-2, passed in March 2022 (with enforcement which started January 2023), funding is needed to proactively mitigate bamboo infestation.
- Assuming coordinator position is saved, this ongoing funding would cover the annual needs for mitigation.

# Forestry Funding: \$890,000

- The current contract budget of \$383,000 only covers about 30% of the annual costs of removing high-risk trees
- Average # of trees removed has increased by 100% (1,005) compared to ten years ago
- Cost overruns are taken from other high priority maintenance projects. With no additional funds, we must scale back to only high-risk trees
- Additional funding will allow FCPA to move from reactive service delivery to proactive and preventative care needs


