ACTION

Scope Approval – Mount Vernon Woods Renovation (Franconia District)

ISSUE:

Approval of the project scope for the renovation of Mount Vernon Woods.

RECOMMENDATION:

The Park Authority Executive Director recommends approval of the project scope for the renovation of Mount Vernon Woods.

TIMING:

Board approval of the project scope is requested on March 13, 2024, to maintain the project schedule.

BACKGROUND:

The 2020 Park Bond Program includes the renovation of Mount Vernon Woods to include a shelter, multi-sport court, playgrounds, skatepark, parking, soccer field, stormwater management facilities, trails, and associated site work.

The project will be delivered into two phases. Phase 1 includes a shelter, multi-sport court, playgrounds, parking, soccer field, stormwater management facilities, trails, and associated site work. Phase 2 includes the skatepark portion.

The park shall be made available to the public after completion of Phase 1 with limited closures as needed to complete Phase 2.

The proposed timeline for the project is as follows.

Staff estimates that the renovation will result in additional annual revenue. Staff estimates a negligible change in annual operating and maintenance costs.

A project team was assembled with representatives from Park Operations Division, Park Services Division, Resource Management Division, and Planning and Development Division (PDD) to establish the project scope in accordance with the approved PDD Work Plan.

FISCAL IMPACT:

Funding is currently available in Fund 30400, Park Bonds, in the amount of \$3,501,024 in PR-0000147-007, Mount Vernon Woods, and \$600,000 in ARPA Funding, totaling \$4,101,024 to fund this project.

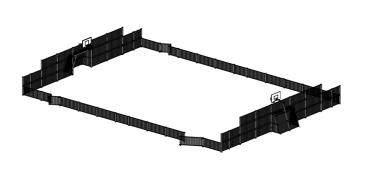

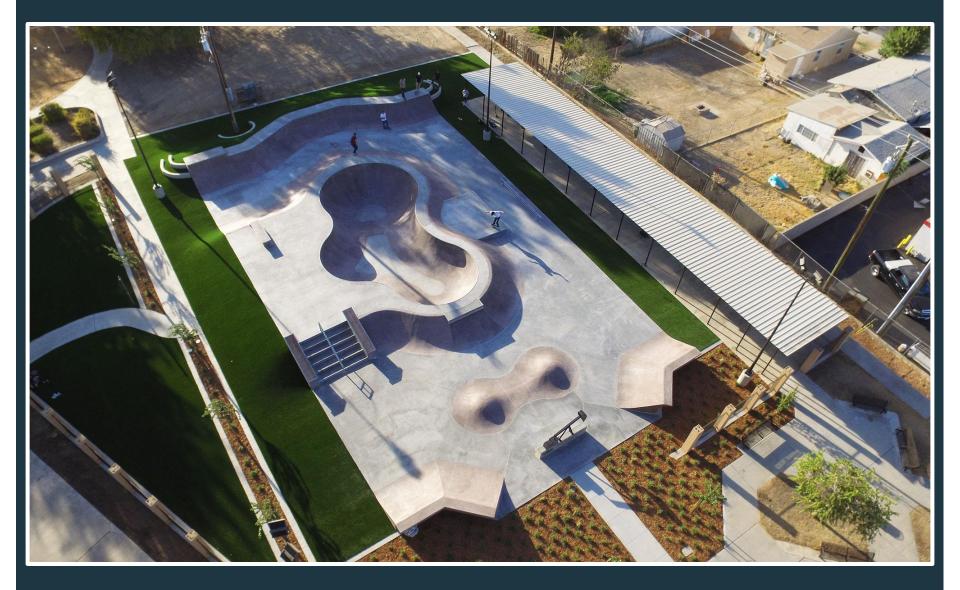

INFORMATION

FCPA Energy Plan Update (County-Wide)

The 2021 Fairfax County Operational Energy Strategy (OES) included goals to reduce energy use in existing county facilities and operations, with a target of 20% use reduction by 2029 based on FY2018 baseline. To assist County agencies in meeting this and other OES goals, the Office of Environmental and Energy Coordination (OEEC) has implemented the following initiatives to improve energy efficiency and reduce the carbon footprint of County facilities:

- Projects funded in the Carryover Budget via the County Energy Program
- Projects funded via the Countywide Environmental Improvement Program (EIP)
- Rooftop Solar Panel Installation via a County Power Purchase Agreement (PPA)
- Canopy-mounted Solar Panel Installation via a County PPA
- Energy Efficiency Projects via a County agreement with an Energy Service Company (ESCO)
- Installation of Electric Vehicle (EV) Charging Stations

The Fairfax County Park Authority (FCPA) has benefitted greatly from a strong partnership with the OEEC. In the past four years FCPA has implemented or soon to implement over \$24 million in energy improvement projects with \$11.8 million in County-funding, resulting in an overall energy use reduction of 18.5% through FY2023. Staff will present an update on FCPA involvement in the programs listed above and forthcoming energy projects.

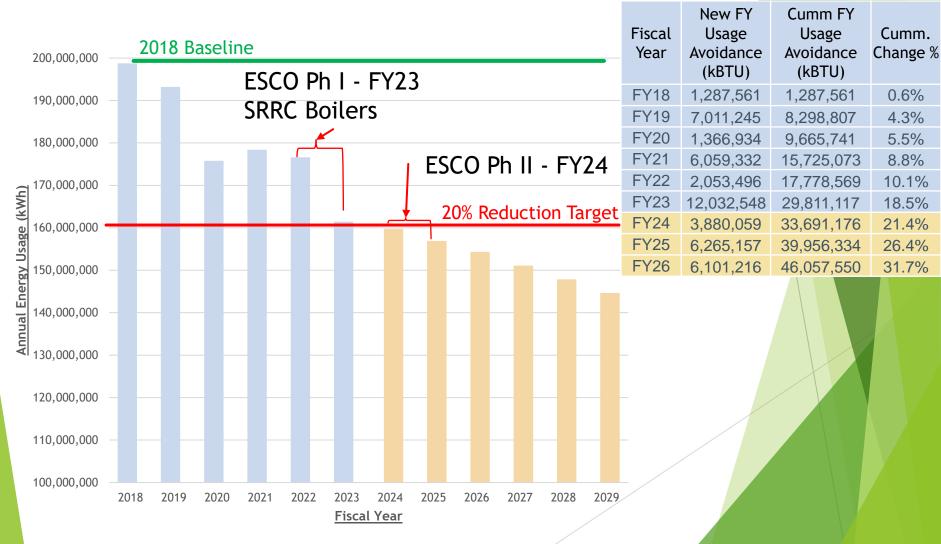

FCPA Zero Waste Plan Update (County-Wide)

The County Zero Waste Plan section of the 2021 County Operational Energy Strategy was adopted by the Board of Supervisors in October 2022. Following the adoption, Fairfax County Park Authority (FCPA) staff have been working closely with the County's Zero Waste Core Team to identify steps to meet and exceed the planned goals of reducing County generated waste by 25% of 2018 baseline and diverting 90% of remaining waste away from trash landfills through recycling, composting, reuse, or other means.

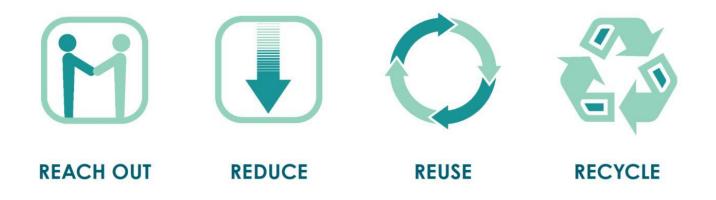
During CY 2023, Park Authority staff identified Pat Tomlinson as the FCPA Zero Waste Champion, working closely with the County's Core team member Keith Snyder, to get FCPA's Zero Waste effort started. The team helped get funding to expand compost collection to all FCPA hosted Farmers Markets in CY 2023, collecting over 100,000 lbs of compost from the community. There were 32 water coolers upgraded to bottle filling stations at various Rec Centers, golf courses, and nature centers during the year, with funding provided by the County's Environmental Improvement Program. The Trailblazer team utilized the County's new "Party Pak" reusable dishware program at its annual event in October 2023, minimizing trash produced at the event and composting food scraps. This program's use will be expanded in CY 2024 across more FCPA events.

Goals for CY 2024 include expanding the FCPA Zero Waste team to include all departments, generating more Zero Waste educational materials for facility patrons and staff, and expanding Zero Waste opportunities at FCPA events.

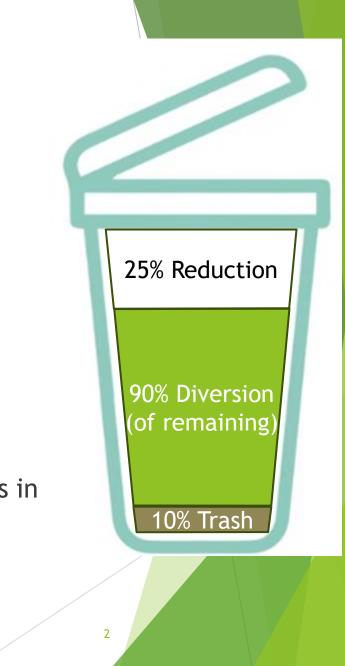

Primary Goals of the Zero Waste Initiative: Reach Out, Reduce, Reuse, and Recycle.

- 2021 Operational Energy Strategy
- 2022 County Zero Waste Plan
- Target to be Zero Waste by 2030
 - Reduce the overall waste generated by 25%
 - Divert 90% of waste from disposal
- Equity should be a core consideration in all Zero Waste efforts in alignment with the One Fairfax Policy.

- >100,000 pounds compost collected at FCPA Farmers Markets.
- 32 Bottle filling stations installed.

- Compost collection expansion, increased usage, and education.
- Site specific Zero Waste projects.
- Incorporate sustainable purchasing priorities.

Zero Waste Program Goal #3: <u>**Reuse</u>** Sustainably Produced Recyclable Materials</u>

2023 Progress:

- Reusable food ware at FCPA internal events (Trailblazers).

<u>2024 Goals</u>:

- Evaluate golf clubhouse grill reusable food ware pilot.
- Pilot FCPA hosted event reusable food ware efforts.
- Utilize funding from Zero Waste, Plastic Bag Tax Revenue, or other funds to establish additional programs to provide reusable materials for daily and special event food and beverage service.





Zero Waste Program Goal #4: <u>**Recycle**</u> Rather than Wasting Valuable Resources

2024 Goals:

- Evaluate the number and locations of all recycling containers at FCPA facilities.
- Reduce the recycling contamination rate, currently ~33%.
- Increase availability of recycling containers for outdoor events.
