Kiel Stone, Park Authority Board	6:26	Thank the board for funding, better trajectory than one-time funding; Equity findings and the transformation of our system to a more accessible one will not be quick, easy or in- expensive. We will need new committed funding and challenged board to expand revenue – meals tax and transit occupancy tax.		
Anita Herrera, Park Foundation	6:30	Supports the proposed budget recommendations on baseline funding for FCPA. Thanked for past funding. Highlighted the foundations function in supplementing parks funding.		
Aimee Martin, Friends of Green Spring	6:42	Thanked for last year's support and this year's sustained funding. Please, we want some more. We really need permanent site staff to do the on-site activities. Parks are not sustainable without permanent on-site people. Parks and Libraries are the tiniest sliver of the budget. Support for equity recommendations.		
Elizabeth Ende, Faith Alliance for Climate Solutions	7:01	Supports tree planning and promotion of the county's tree canopy across the county and in parks. Enhance policies to preserve mature trees in the county's land use process. Increase support for the Invasive Management Area program. Protect and enhance our parks and small green spaces.		
Whitney Redding, Friends of Holmes Run	7:43	This year supported more than 50 different stewardship events. Support invasive plant control and stormwater restoration. Approves 2025 investments in parks including maintenance, park forestry and bamboo removal. Park Authority share of the General Fund has been traditional 0.6%. Invasives Management Area program is in need of additional staff to help manage volunteer efforts.		
Terri Harley	7:47	Allocate funds for environmental education – including invasive plant control and educational efforts on the benefits of native plantings.		
Lula Bauer, Fairfax County Athletic Council	8:17	Increase funding for the Turf Replacement Fund and promote the quality and safety of the county's athletic facilities.		
Courtney Massey, Defund NOVA Police	8:37	Mentioned support for investment in Parks.

Funding for outreach staff within the parks, potential for more bilingual staff.

		which did not include cuts to park budgets. Historical	
		underfunding of parks is well-documented. It is far below	
		that of best practices. Best practices for actively managed	
		land was between \$3K and \$6K per acre. Currently Park	
		Authority is \$351 per managed acre. Annual cultural	
		resource management is about \$500K below best practices.	
		Fairfax County operational funding – per-acre is far below	
		that of other jurisdictions. Cited Kiel Stone's testimony	
		related to ongoing deferred maintenance and the revenue	
		model of the Park Authority and dedicated funding.
