



       Suburban Center






## Element of the County's Area plans

- Includes key elements for implementing the Policy Plan's goals and objectives at more detailed geographic levels






#### Transportation Maps










 Utilize existing undeveloped and open space areas to create pedestrian and bicycle connections within the greater Lorton community. Low impact techniques for trail development should be utilized in environmentally sensitive areas.





- Fairfax County is updating and combining the Bicycle Master Plan and the Countywide Trails Plan into the ActiveFairfax Transportation Plan
- Next round of public engagement is expected in Spring 2024






- Identify improvements that can promote linkages between Lorton's gateways along primary roads and transportation facilities serving commuters, tourists, and other visitors.

#### **Community Vision Statement**

 Identify areas where future growth can be guided at sufficient development levels to support the siting of Lorton's future Bus Rapid Transit (BRT) stations.




- Virginia Department of Rail and Public Transportation (DRPT) recommended prioritizing segments that are most competitive for federal funding
  - Areas with higher population and employment
  - Connection to the regional transit network
    - Phase I and II would be most competitive for federal funding
    - Phase III would be less competitive for federal funding





#### **Community Vision Statement**





 Ensure the land use pattern is supported by a balanced network of well-maintained roads, pedestrian and biking facilities, and transit systems designed to accommodate safe and convenient access within Lorton.





## Modal options considerations

- Walking more than recreation, can reduce auto trips
- Biking more than recreation, can reduce auto trips
- Driving efficient and comfortable
- Transit more than commuting, local circulation
- Emerging technologies "the great unknown"





 Establish Lorton Road as a local-serving boulevard through streetscape and urban design elements to improve pedestrian comfort and safety that include wider walkways and landscaped medians, improved wayfinding signage and lighting, public art, and street trees that encourages the development of the core as a well-connected destination, rather than a pass-through.



- Expected roadway function of Lorton Road
  - carry an even mix of local and through traffic
  - link collectors with principal (major) arterials
  - perform a significant function in the transportation network
  - closely approach principal arterial in terms of traffic characteristics and role in the network





- Continue Transportation Assessment
- Report to Task Force
  - Existing conditions assessment
  - Future baseline conditions assessment
  - Future conditions assessment with proposed new land uses
  - Potential mitigations and improvements
