# STAFF REPORT FOR PLAN AMENDMENT 2022-CW-3CP

## BACKGROUND

On December 6, 2022, the Board of Supervisors (BOS) authorized Comprehensive Plan Amendment 2022-CW-3CP to revise references in the Comprehensive Plan (Plan) from the Lee Supervisor District to the Franconia Supervisor District. The BOS took action on the same day, December 6, 2022, to amend and readopt Fairfax County Code Sections 7-2-3 and 7-2-7 of the Fairfax County Code to rename the Lee Supervisor District to the Franconia Supervisor District.

In March 2021, Supervisor Lusk launched a series of community engagement conversations focused around getting input from residents about changing the Lee District name. In mid-January 2022, the Fairfax County Redistricting Advisory Committee (RAC) evaluated BOS district and precinct names with a focus on equity, as tasked by the Board of Supervisors. As a result of this evaluation, the committee recommended a name change for the Lee District. Based on resident input and the committee recommendation, Supervisor Lusk presented a Board Matter on June 28, 2022, to initiate the process of formally changing the name of the Lee District to Franconia District. The Board of Supervisors approved his Board Matter.

On July 13, 2022, the Fairfax County Park Authority Board took action to change the names of the Lee District RECenter and Lee District Park, to Franconia District RECenter and Franconia District Park, respectively.

This item aligns with focus area eight of the One Fairfax Policy: Neighborhoods that support all communities and individuals through strong social networks, trust among neighbors, and the ability to work together to achieve common goals that improve the quality of life for everyone in the neighborhood. The Redistricting Advisory Committee (RAC) evaluated magisterial district names based on seven criteria, including whether a name is associated with the Confederacy, segregation, racism, and slave ownership.

As noted in the materials provided to the Board prior to the December 6 action for the name change, while the historical record is somewhat inconclusive on whether Lee District is named for Robert E. Lee or a family member, the significance of the Lee name to the Confederacy remains. The specific name of a magisterial district is essential to forming trust within communities and is an expression of community values. Names that are more inclusive enable neighbors to feel more welcome, leading to a greater sense of belonging.

#### PROPOSED PLAN AMENDMENT

The proposed Plan amendment would revise references in the Plan from the Lee District to the Franconia District. References to the Lee District in the Plan primarily relate to the Lee District Park and Lee District RECenter. References to the Lee District Park will be revised to Franconia District Park, and references to the Lee District RECenter will be revised to Franconia District RECenter. Many of these edits will be found in the Area Plan Volume IV. Maps in the Comprehensive Plan will not need to be updated in association with this Plan amendment.

Editorial changes are not proposed to the published document from consultants that are a part of the Comprehensive Plan. The Lee District references mentioned in the "Fairfax County Bicycle Master Plan", Appendix 5 of the Transportation Element of the Policy Plan, are not included in the proposed editorial changes, since this is a published document from a consultant, dated October 2014. Updates to the Transportation Element will be considered as part of the Policy Plan review underway.

Staff identified two Planning Sector names that include the name Lee; the Lee Community Planning Sector, within the Providence Supervisor District, and the Lee-Jackson Community Planning Sector, within the Sully Supervisor District. A separate process is recommended to consider the next steps related to renaming these Planning Sectors. The two Planning Sectors were not part of the Lee Supervisor District renaming evaluation discussions with the community or RAC, and were not part of the December 6, 2022, Board action.

Work is also underway to evaluate the next steps related to the renaming of Lee Highway to Route 29 and Lee Jackson Memorial Highway to Route 50, and a separate Plan amendment is anticipated that will incorporate the new names for those roads.

# CONCLUSION

This Plan amendment proposes editorial changes to the Comprehensive Plan that will revise references from the Lee District to the Franconia District. There are limited references to the Lee District in the Comprehensive Plan, and the proposed edits primarily refer to the renaming of Lee District Park and Lee District RECenter. In total, there are 23 proposed edits to the Comprehensive Plan to reflect this change.

Staff recommends the Comprehensive Plan be modified as shown below. Text proposed to be added is shown as <u>underlined</u> and text proposed to be deleted is shown with a <del>strikethrough</del>. Text shown to be replaced is noted as such.

#### **"INTRODUCTION**

•••

Planning for the future of the arts is viewed within the changing character and demographics of Fairfax County and in relationship to existing arts venues within the county and region. Fairfax County is an established county in the sense that it has been largely built out, particularly from a traditional residential perspective. Significant redevelopment and expansion of commercial centers, however, will continue. The demographics of Fairfax County are shifting significantly. Given the size and diversity of Fairfax County, residents tend to associate themselves with their communities and these communities have varying arts opportunities. From an arts venue perspective, the District of Columbia (Kennedy Center, Smithsonian, Corcoran, etc.) and Wolf Trap National Park for the Performing Arts serve as "bookends," providing performing and visual arts of international stature. The Center for the Arts at George Mason University provides additional programming of national and international quality, as well as an educational arts environment. The Lorton Workhouse is a major arts venue in the county, with facilities for working artists, performing groups, and exhibitions. Increasingly, the Workhouse will become not only a Fairfax County asset, but regional and national in scope. Smaller local arts venues in the county include among others Alden Theatre at the McLean Community Center, Center Stage at the Reston Community Center, the James Lee Community Center Theater, ArtSpace in Herndon, Greater Reston Arts Center, and the McLean Project for the Arts. Four amphitheaters of varying sizes are located in Fairfax County parks and nature/historic sites including Burke Lake Park, Ellanor C. Lawrence Park, Mason District Park, and Lee Franconia District Park."
