<b>6. Land Fill Operation</b>	Within 100 yards of a residential dwelling prohibited from 9 p.m. to 6 a.m.	1. At any location from 6 a.m. to 9 p.m. and, 2. When located 100 yards or more from a dwelling, from 9 p.m. to 6 a.m.	
<b>7. Outdoor Truck Loading/ Unloading</b>	When located within 100 yards of a residential dwelling prohibited from 9 p.m. to 6 a.m.		1. At any location between 6 a.m. and 9 p.m.; and 2. When located 100 yards or more from a residential dwelling between 9 p.m. and 6 a.m.

<b>10. Person, Motor Vehicle or Instrument</b>	Unless otherwise excepted, prohibited when plainly audible inside a residential dwelling with doors and window closed, and the sound must be discernible regardless of whether such doors and windows are closed: <ol style="list-style-type: none"> <li>1. Between 10 p.m. &amp; 7 a.m. on Sun.-Thurs., or between 11 p.m. &amp; 7 a.m. on Fri., Sat., and the day before a Fed. Holiday; or</li> <li>2. Between 1 a.m. &amp; 7 a.m. on Sat., Sun. and Fed. Holidays when the residence is located in a mixed use area and the sound is emanating from a location that is not another residential dwelling.</li> </ol>		<ol style="list-style-type: none"> <li>1. Within any residential area between 7 a.m. to 10 p.m. on Sun. – Thurs; or from 7 a.m. to 11 p.m. on Fri, Sat., and day before a Fed holiday.</li> <li>2. <b>11. Animals</b>	Animal noise: 1. Between 10 p.m. and 7 a.m. that is plainly audible in any other persons residence with doors and windows closed and the source of sound generation is discernible regardless of whether such doors or windows are closed; or 2. Between 7 a.m. and 10 p.m. when the animal noise is plainly audible and discernible across property boundaries or through partitions common to residential dwellings and such sound can be heard for more than 5 consecutive or nonconsecutive minutes in any 10 minute period. Animal sounds that can be heard for less than 5 consecutive or non-consecutive minutes in any 10 minute period shall not be subject to the Noise Ordinance.	1. When the animal is responding to pain or injury or is protecting itself, its kennel, its offspring, a person from a real threat, or 2. When the animal is a police dog that is engaged in the performance of its duties at the time of making the noise. 3. When part of a bona fide agricultural operation.	
<b>12. Emergency Work</b>		Any time	
<b>13. Alarms for fire, emergency or imminent danger</b>	1. Emergency alarm testing between 9 p.m. and 7 a.m.; and 2. Routine testing that occurs between 7 a.m. and 9 p.m. and for more than 2 consecutive or nonconsecutive hours in any one day.	1. Emission of sound for purpose of alerting people to the existence of an emergency, provided that such alarm signals cease when any such threat is no longer imminent. 2. The routine testing of plainly audible between 7 a.m. to 9 p.m., provided that such testing does not occur for more than 2 consecutive or nonconsecutive hours in any one day.	
<b>14. Preempted Activities</b>		Activities for the regulation of sound that have been preempted by Federal or State law.	
<b>15. Snow and Ice Removal</b>		Snow and Ice removal from walkways, parking areas and travel lanes - any time

Use of generators when there is no power outage caused by a storm or other emergency;</li> </ol>
21. <b>Impulse Sound</b>		Impulse sound that does not exceed the maximum decibels listed in the Maximum Sound Level Chart.	Anytime
