### **Agritourism Definition**

Any activity accessory to an agricultural operation that allows members of the general public to view or enjoy rural activities for recreational, entertainment, or educational purposes, regardless of whether the participant paid to participate in the activity. These activities may be permitted at a property with a farm winery, limited brewery, or limited distillery subject to the limits on attendees in subsection 4102.2.C.4, which limits apply collectively to public or private events and activities and agritourism uses on that property. Agritourism activities include but are not limited to the following:

- 1. Farm tours, including educational or entertainment programs, workshops, or demonstrations;
- 2. Harvest-your-own activities;
- 3. Seasonal festivals and attractions, including crop mazes or hayrides;
- 4. Events including, but not limited to, corporate picnics, family reunions, farm-to-table dinners, weddings, and similar uses;
- 5. Hiking, horseback riding, and other natural activities; and
- 6. Other activities as determined by the Zoning Administrator.

### Agritourism Activities: Revised Approach

Tier	Total Attendees per Day	Advertised Range For Board Consideration
Tier 1: 5 to less than 10 acres	75	50 to 150
Tier 2: 10 to less than 20 acres	150	100 to 200
Tier 3: 20 to less than 80 acres	300	250 to 350
Tier 4: 80 acres or more	350	300 to 400

### Agritourism Standards

#### **All Agritourism Uses**

- Parking must be located on the same lot as agricultural operation
- Number of attendees are limited by tiers in table

#### **Administrative Permit**

- Tier 4 activities that exceed 350 total attendees per day up to 150 days per year [Advertised range: 100 to 150 days per year]
- Permit valid for 2 years and may be renewed on 5-year basis
- Transportation management and parking plan required

#### **Special Exception**

- May be requested to:
  - Exceed number of attendees permitted in Tier 1, 2, 3, and 4
  - Exceed the number of days permitted by administrative permit in Tier 4
- Transportation management and parking plan required

### Related Changes

#### **Bed and Breakfast**

Propose a by-right option when in conjunction with an agricultural operation with limitation on events

#### **Farm Worker Housing**

Define and expand current provisions including size, location, and recordation requirements

#### **Food Trucks**

Permit in association with an agritourism use, limited brewery, limited distillery, or a farm winery with limitations on hours and location

#### **Wayside Stands**

Permit permanent structures, expand size and location regulations for those located on 80 acres or more, expand products that can be sold, and only allow in conjunction with an agricultural operation
