

LAND USE ACTIONS

During the 3rd quarter of Fiscal Year 2023, the Planning Commission acted on **42** applications; affording 134 citizens an opportunity to speak at the 12 public hearings held. The district with the highest number of applications considered was the Springfield District with 12 applications acted upon.



COMMITTEE ACTIVITY

Tysons Committee

Met on January 12th with the Department of Planning and Development staff for a presentation on the Tysons Tracker platform, which included an overview of the platform, conclusions derived from the tracker, and the data within the tracker that informed such conclusions. Staff responded to the Committee's questions that were raised from this presentation.

Reston Comprehensive Plan Workshop

On January 26th, the Planning Commission held a Reston Comprehensive Plan Study workshop on drafted Plan Amendment, PA 2020-III-UP1. The Department of Planning and Development staff gave a presentation which was followed by a roundtable discussion with the Committee and members of the Reston community.

On March 30th, the Planning Commission held the third workshop on changes made to a draft copy of the Reston Comprehensive Plan Study Plan Amendment, PA 2020-III-UP1. The Department of Planning and Development staff gave a presentation that covered the changes to the amendment, followed by a roundtable discussion between staff and the Commission.

Land Use Process Review Committee

Met on February 16th with the Department of Planning and Development staff on the County's Parking Reimagined effort. Staff also responded to questions from the Committee.

Transportation Committee

Met on February 16th with the Department of Planning and Development staff for a presentation on proposed plan amendments for County Parkways including PA 2021-CW-2T: Fairfax County/Franconia-Springfield Parkways and PA 2019-III-T1: Burke Centre Parkway. Staff responded to the Committee's questions and shared community feedback.

Capital Improvement Program Committee

Met on February 23rd with the Department of Management and Budget, Department of Planning and Development, and the Department of Public Works and Environmental Services staff for a presentation on the proposed Fairfax County Capital Improvement Program (CIP), Fiscal Years 2024-2028, in preparation for the Planning Commission's workshop and public hearing, scheduled for Wednesday, March 1, 2023 at 7:30 p.m. in the Board Auditorium of the Fairfax County Government Center.

Met on March 16th with the Department of Management and Budget, Department of Planning and Development, and the Department of Public Works and Environmental Services staff to discuss potential motions for approval of the CIP.

Site-Specific Plan Amendment Workshops

On March 2nd, March 9th, and March 23rd the Planning Commission held workshops regarding the Site-Specific Plan Amendment (SSPA) nominations to determine which of the proposed nominations would move forward for further study as part of the Comprehensive Plan Amendment Work Program.
