Policy Plan Amendment Purpose of Comprehensive Plan and Relation to Regulatory Documents



- <u>Comprehensive Plan Policy Plan</u>: Provides countywide guidance on land use vision along with goals, objectives, and policies to achieve the vision.
- <u>Comprehensive Plan Area Plan Volumes</u>: Provide specific guidance and considerations to ensure compatible development within an identified area.
- <u>Zoning Ordinance</u>: Regulates land use and implements Comprehensive Plan for the orderly and controlled development of the County.
- <u>Public Facilities Manual (PFM)</u>: Provides guidelines governing the design of new development.



## Policy Plan Amendment Policy Plan Overview



- Total Objectives, Policies, and Appendices in Policy Plan (excluding Public Facilities Element)
  - 103 Objectives
    - 63 Objectives need modification/new policies to address Board documents
      - May need new Objectives to address new policies
    - 40 Objectives need minor editorial changes to bring into present/future
  - 474 Policies
    - Almost all need to be updated in some capacity (refined, modernized, edited, removed)
  - 25 Appendices
    - Some can be removed based on Zoning Ordinance overlap

Environment Element: Board of Supervisors Open Space Goal

"Fairfax County should support the conservation of appropriate land areas in a natural state to preserve, protect and enhance stream valleys, meadows, woodlands, wetlands, farmland, and plant and animal life."

#### **Environmental Protection Goal**

"The amount and distribution of population density and land uses in Fairfax County should be consistent with environmental constraints inherent in the need to preserve natural resources and to meet or exceed federal, state and local standards for water quality, ambient air quality and other environmental standards."



#### **Environmental Protection Goal**

"Small areas of open space should also be preserved in already congested and developed areas for passive neighborhood uses, visual relief, scenic value, and screening and buffering purposes."

## **Environmental Concerns**

"This element of the Plan focuses primarily on environmental concerns which impact, or are impacted by, the development of land." Countywide Objectives and Policies are grouped into three broad categories:

- Environmental Pollution
- Environmental Hazards
- Environmental Resources

## **Environmental Pollution**

**1.** Preserve and improve air quality.

2. Prevent and reduce pollution of surface and groundwater resources. Protect and restore the ecological integrity of streams in Fairfax County.

**3.** Protect the Potomac Estuary and the Chesapeake Bay from the avoidable impacts of land use activities in Fairfax County.

**4.** Minimize human exposure to unhealthful levels of transportation generated noise.

**5.** Minimize light emissions to those necessary and consistent with general safety.

#### **Environmental Hazards**

**6.** Ensure that new development either avoids problem soil areas, or implements appropriate engineering measures to protect existing and new structures from unstable soils.

**7.** Minimize the exposure of new development to the potential of flood impacts.

**8.** Minimize the exposure of county residents to potential pipeline ruptures and explosions and avoid hazards from electrical transmission and distribution facilities.

#### **Environmental Resources**

**9.** Identify, protect and enhance an integrated network of ecologically valuable land and surface waters for present and future residents of Fairfax County.

**10.** Conserve and restore tree cover on developed and developing sites. Provide tree cover on sites where it is absent prior to development.

**11.** Promote the use of open space/conservation easements as tools to preserve environmental resources.

#### **Environmental Resources**

**12.** Improve the identification and mitigation of environmental impacts, and the monitoring and enforcement of environmental policies as applied to land disturbing activities.

**13.** Design and construct buildings and associated landscapes to use energy and water resources efficiently and to minimize short- and long-term negative impacts on the environment and building occupants.

## The Climate

- Resiliency
  - Reverse Heat Islands, equitable tree canopy
  - Reduce risks of flooding
- Climate & Energy
  - Compact development near public transportation
  - EV charging facilities
  - Ped/Bike infrastructure
  - Green Buildings
  - Data Centers
- Water Quality and Water Supply
  - Salt management (DEQ Salt Mgmt Strategy & Data Centers)
  - Medical facilities (hospitals, assisted living) on septic
  - Septic / Wells

## The Landscape

- Intact floodplains, RPAs, EQCs Ecological Corridors
  - Limit encroachments
- Biodiversity and restoration of degraded ecosystems
  - Remove invasive plants
  - Plant NOVA Natives
  - Expand tree canopy
  - Avoid fragmentation of open space

## The Neighborhood

#### Sustainable, Equitable, Resilient Communities

LEED Neighborhood Design (ND) – Green Neighborhood Development for compact, walkable, mixed-use neighborhoods.

"Transit, comfortable walking/biking, convenient access to shops, services, public spaces, and meeting places. Avoids fragmentation of wildlife habitat. Has parks, plazas, playing fields, trees, controls runoff and heat island effects. Community gardens, social interaction, physical activity. Housing types for a range of incomes, ages, abilities, and allows families and community to remain as circumstances change."

## The Site

- Better Site design
  - Identify and protect environmental features
  - Minimize grading
  - Protect and amend soils
  - Preserve mature tree stands
  - Use Low-impact development (LID) / green infrastructure first
  - Design bird-friendly buildings
  - Solar orientation, solar, and solar-ready
