

## LAND USE ACTIONS

During the 3<sup>rd</sup> quarter of Fiscal Year 2024, the Planning Commission acted on **29** applications; affording 44 citizens an opportunity to speak at the 9 public hearings held. The district with the highest number of applications considered was the Dranesville District with 8 applications acted upon.

## Land Use Process Review Committee
