Chairman Niedzielski-Eichner called the Policy Plan Committee meeting to order at 8:44 p.m. in Conference Room 11 of the Fairfax County Government Center, 12000 Government Center Parkway, Fairfax, Virginia 22035.

//

Chairman Niedzielski-Eichner stated that the purpose of the meeting was to receive a presentation from staff regarding the plans for community engagement, in response to feedback received from the Committee's discussion. He added that at the conclusion of the meeting, there should be consensus on the path forward for the community engagement process that would benefit the overall Policy Plan process. Chairman Niedzielski-Eichner recognized staff for a presentation on the final Outreach Plan for the Policy Plan.

Corinne Bebek, Planning Division (PD), Department of Planning and Development (DPD), introduced Sarah Godfrey, Community Engagement Specialist, Office of the Deputy Director, DPD, who assisted with the outreach presentation and finalized the outreach plan. She also introduced Kelly Atkinson, Assistant Director, PD, DPD; and Chris Caperton, Deputy Director, Office of the Deputy Director, DPD.

//

Ms. Bebek gave a presentation on updates to the elements of the Policy Plan. A copy of the staff's presentation is in the date file.

//

Sarah Godfrey, Community Engagement Specialist, Office of the Deputy Director, DPD, gave a presentation on the Outreach Plan for Planning Commission Input. A copy of the staff's presentation is in the date file.

//

Ms. Godfrey came to a stopping point in her presentation to respond to Chairman Niedzielski-Eichner on question on staff's definition of ranking questions. Ms. Godfrey clarified in terms of ranking questions from feedback received from the public.

//

Ms. Godfrey continued her presentation.

//

Ms. Bebek discussed the next steps of the project, which included the following:

- An update on the Policy Plan with the Board of Supervisors Land Use Committee;
- A release of a memorandum that addressed the Policy Plan Amendment (2022-CW-3CP) Outreach Plan;
- An internal dry run of the in-person and virtual kick-off meetings with County agencies to identify any setup and operational issues;
- Would meet with the community at large and the focused topic groups over the next few months to discuss the plan;
- Review of feedback received from the kickoff and focus group meetings; and
- The plan for a future Policy Plan Committee meeting would include an update on the outcomes from the outreach process, as well as discussions on policy considerations.

Ms. Bebek thanked the Committee members for their time and Ms. Godfrey for her presentation.

There was a discussion between Ms. Bebek; Ms. Godfrey; Kelly Atkinson, Assistant Director, Planning Division, Department of Planning and Development; and multiple Committee members regarding the following:

- Staff clarified that the reason for the gap between the development of the policy plan process and the final report of the outreach plan was to allow for a more cohesive draft to release to the public of the community feedback report;
- Staff confirmed that work on the policy development process and completion of the public engagement process would be completed concurrently;
- A discussion of staff's plan for citizen participation during Phase 1 of the policy plan update process;
- Staff confirmed that the Nextdoor community engagement platform, a Channel 16 news release, bus ads, and social media graphics would be utilized to garner community interest on the plan;
- Staff disclosed there was a push for mid-May to introduce the project to the community;
- Staff confirmed they were in the process of finalizing the details on interactive features, coupled with a list of targeted questions, for community engagement on the various aspects of the plan;
- Whether the Planning Commission and the Board of Supervisors was part of the policy plan's public input synthesis process;
- Staff confirmed the plan would be advertised through the County's public meeting calendar and other channels and some of those public meetings would be through the County's public notification process;
- Commended staff on the detailed improvements made to focused areas;
- Commended staff on the inclusion of the Board, Authorities, and Commissions as part of the planning process;
- Concerns regarding the messaging aspects of the plan to the community;
- Staff confirmed that an outside consultant would not be hired to develop a public input questionnaire for the plan;
- The results from the crosswalk study would determine policy considerations and help craft the public input questionnaire;

- Staff discussed how some aspects of the County's outreach plan mirrored the Montgomery Thrive 2050 plan;
- A suggestion that the information outreach phase of the plan be done in tandem with the community feedback report to formulate a plan that would address the community's concerns;
- Staff disclosed that the plan would be translated into the top nine languages;
- Staff disclosed collaboration efforts with the Department of Neighborhood and Community Services, to understand the language needs for the County's diverse population;
- Staff disclosed that Engage Fairfax would host the community engagement section of the plan's interactive survey;
- Staff's thoughts on the level of personal information requested as part of the community engagement process;
- Staff discussed the tools that would direct the community to the public input page on the County's website;
- A suggestion that a landing page on the County's website be accessible that directed the public to the plan's interactive survey;
- Clarification on how the policy plan compared with other aspects of the County's area plans and how the community engagement process was highlighted;
- Staff clarified that the policy plan process was different from the Centreville Study Task Force;
- Staff planned to utilize the services of the Planning Commission, the Board of Supervisors, and focus topic groups during outreach process for the plan;
- Staff clarified that the quick response (QR) codes would be located on the Fairfax Connector buses;
- Staff clarified they were not familiar with the use of QR codes on Metrobus system, but would look into the possibility of incorporating those i ads to that system;
- A discussion on the types of visuals that could be incorporated into plan's messaging process to broaden the outreach to the community;
- A discussion on Phases 3 and 4 of the plan's proposed outreach push, and the language between the community feedback and final staff report;

- Staff confirmed that they planned to provide regular updates to the Board of Supervisors and the Planning Commission throughout the Policy Plan outreach process;
- Staff confirmed they would use feedback received from the committee and community to develop plan language;
- A recommendation that the editorial review process be incorporated into the proposed outreach policy plan; and
- A suggestion that language that summarized the proposed outreach push for Phase 1 be incorporated before moving to Phase 2.

Ms. Bebek thanked the Committee members for their time.

Chairman Niedzielski-Eichner gave a summary of the information presented to the Committee and thanked staff for incorporating the Committee's feedback from the last meeting.

Committee members confirmed there was a general consensus on the staff's recommendations for the plan.







### Policy Plan Amendment Outreach Plan

A Fairfax County Department of Planning and Development Document April 2024





#### PROJECT BACKGROUND

In December 2022, the Board authorized a Comprehensive Plan amendment to holistically update the Countywide Policy Plan for the first time since its' establishment in 1990.

The goals of a complete Policy Plan Update are to:

- review, update, and streamline existing Policy Plan elements;
- add new Policy Plan elements as needed; and
- ensure the Policy Plan is in alignment with the Countywide Strategic Plan, the One Fairfax Policy, and other recently adopted policies and initiatives.

The Policy Plan contains goals, objectives, and policies relating to eleven functional elements: Land Use, Transportation, Housing, Environment, Economic Development, Heritage Resources, Public Facilities, Human Services, Parks and Recreation, Revitalization, and Visual and Performing Arts. The Policy Plan guides planning and development activities by describing future development patterns in Fairfax County and protecting natural and cultural resources. The Policy Plan update will help inform future planning and development decisions throughout the county.

The project area includes all of Fairfax County and all who live and work in the county will be impacted by the Policy Plan update and are encouraged to participate in the project's community engagement opportunities. The Policy Plan Update will be a multi-year, multi-phase process, with Phase 1 focusing on the topics of the Preface, Land Use, Transportation, Environment, Parks and Recreation, Human Services, Community Health, and Equity. Public hearings before the Planning Commission and Board of Supervisors are not yet scheduled.

#### **OUTREACH PROCESS**

Four phases of outreach are identified for this project, starting with informational outreach with the community to include kick-off meetings and informational stands and pop-ups at community events, beginning in May 2024. The second phase includes focused topic outreach beginning in Summer 2024 and running through the end of the year; this is where staff will collaborate with groups on potential policy considerations. Staff will then compile a community feedback report during the third phase highlighting the feedback received during the first two phases of outreach and describing actions, if any, taken in response by staff. This outreach phase will include publication of the report as well as meetings with the Board of Supervisors, Planning Commission, and community to further refine draft Plan text. The final phase of outreach is the public hearing process which will include publication of a staff report with draft Plan text, and public hearings where feedback or public comment on the staff report and final policy recommendations is welcome. Outreach materials developed for each phase of the process will include, but is not limited to, flyers, surveys, social media and web postings, video development, advertisements, and email distributions. These materials will also be shared on the project webpage. Materials specific to each phase will be released as the phase is approaching.

To understand more about planning in Fairfax County and how the Plan Amendment process works, the Department of Planning and Development's Planning Division worked with a consultant to develop a series of Planning 101 videos, accessed <a href="here">here</a>. These videos are helpful background information for those that are interested in learning more about the planning process ahead of the outreach kick-off planned for May 2024.
