Nicole Wynands, Department of Transportation, gave a presentation on, the ActiveFairfax Transportation Plan, a copy of which is included in Attachment A, which covered the following topics:

- Project Overview;
- Public Engagement Summary;
- Vision, Goals and Objectives for Active Transportation; and
- Proposed Safe Streets for All Program

There was a discussion between Ms. Wynands and multiple Committee members on the following issues:

- The method used to calculate bicycle users and greenhouse gases saved;
- Goals were created to assist with prioritizing needs however funding is subject to board decision;
- Explanation of interactive map for public use and requests;
- Explanation of the walk share analysis which depicts walkability if neighborhoods were connected to each other;
- Staff to review public submissions with park staff and fond solutions as needed;
- How this transportation plan is connected to the Comprehensive Plan;
- Suggestions to include coordinating staff into the process sooner as opposed to the end of the process;
- Utilizing the CIP to assist in funding some of the project; and
- Progress on the gap analysis.

Chairman Cortina thanked Ms. Wynands for her presentation and stated that a future Transportation Committee meeting would focus on areas that are not often thought of in this process, such as the Springfield area.
