Facility Deficiencies:

- Inefficient building systems and infrastructure that are well beyond their life cycle
- Insufficient power and technological capacity
- Inefficient site lines promoting customer and staff safety and security concerns
- Inefficient layout for customer service
- Inadequate group study rooms
- Inadequate meeting spaces and seating
- Insufficient collection size due to space constraints


Kingstowne Site (6.74 acres) Beulah St. & Silver Lake Blvd.

- Joint Development Feasibility Study with the Town of Vienna
 - 21,000 SF new Library
 - Additional structured parking for Town and Library
- Fairfax County
 - 21,000 SF new library, parking and associated site work
- Town of Vienna
 - 84 or 188 parking spaces based on final selected development option.
