I. PURPOSE

The purpose of this General Order is to outline investigative responsibilities and procedures for all employees of the Fairfax County Police Department (FCPD).

II. POLICY

It is the policy of the FCPD that law enforcement investigations be conducted in a manner that treats all community members fairly, equitably, and with respect. Investigations begin with the arrival of the first officer on scene, are divided into preliminary and follow-up stages, and eventually conclude once adjudicated through the courts. Follow-up responsibilities are determined by the nature of the act and necessity for further investigation. Victims and witnesses shall be provided with assistance pertaining to their rights, their role in the court process, support services, and any other needed resources required by law or Department policy.

III. DEFINITIONS

- A. **Criminal Street Gang:** Per the [Code of Virginia](#), any ongoing organization, association, or group of three (3) or more persons, whether formal or informal, with (1) a primary objective or activity that involves the commission of one or more criminal activities, (2) has an identifiable name or identifying sign(s) or symbol(s), and (3) whose members, individually or collectively, commit, attempt to commit, conspire to commit, or solicit two (2) or more predicate acts, at least one of which is an act of violence provided those acts are not part of a common act or transaction.
- B. **Gang Member:** Per the [Code of Virginia](#), any person who (1) admits membership in a gang, (2) is observed by a law enforcement officer frequenting a known gang area, associating with known gang members, and demonstrates gang style of dress, tattoos, hand signals, or symbols, or (3) is arrested on more than one occasion with known gang members for offenses consistent with gang activity.

- C. **Miranda Warnings:** Procedural safeguards requiring officers to warn a criminal defendant, prior to any questioning, that they have (1) the right to remain silent, (2) that anything they say can be used against them in a court of law, (3) that they have the right to the assistance of an attorney, and that (4) if they cannot afford an attorney, one may be provided prior to questioning if they so desire.
- D. **Preliminary Investigation:** Commences when the first police officer arrives on scene and continues until the investigation is either paused or transferred to another investigative entity.
- E. **Victim:** As defined per the [Code of Virginia](#), any individual who has suffered physical, psychological, or economic harm as the direct result of the commission of any felony, [assault and battery](#), [domestic assault](#), [stalking](#), [sexual battery](#), [attempted sexual battery](#), [maiming](#) or [driving while intoxicated](#). Also refers to spouses or children of such individuals, parent or legal guardians of such individuals who are minors, or spouses, parents, or legal guardians of such individuals who are physically or mentally incapacitated or was the victim of a homicide. Victims do not refer to parents, children, spouses, or legal guardians of an individual who commits a felony or other enumerated criminal offense as outlined in this definition. Any individual culpable for a crime being either investigated or prosecuted is not considered a victim for purposes of protected rights and services in the Code of Virginia, however, the exclusion does not include individuals culpable for other crimes, even if related, and as such, the individual is afforded protected rights and services. An individual's status as an inmate, documented, or undocumented person does not disqualify them from being considered to be a victim.
- F. **Victim Services Brochure:** Handout that provides victims and witnesses with a listing of specific rights afforded to victims of crime and includes phone numbers for the Fairfax County Police Department, Office of the Commonwealth's Attorney, Magistrate's Office, and Fairfax County Courthouse, and the Department's Victim Services Division.

#### IV. PRELIMINARY INVESTIGATIONS

- A. **Officer Responsibilities:** Officers shall conduct the following activities during all preliminary investigations:
  - 1. **Render Aid and Secure Evidence:** Provide or seek access to medical aid for any injured individual(s) and protect the scene to ensure potential evidence is neither lost nor contaminated.

2. **Establish Jurisdiction:** Determine whether a criminal offense has occurred, and if so, the jurisdiction the offense occurred in and all relevant details. Where the jurisdiction is unknown, officers shall continue their investigations under the assumption that the offense occurred in Fairfax County in order to protect the interests and rights of potential victims, recover evidence, facilitate prosecution if necessary, and avoid delays in reporting offenses.
3. **Identify Involved Individuals:** Determine and identify suspect(s), victim(s), and witness identities, information known, and complete contact information and pursue arrest whenever lawful either at the scene or through follow-up investigatory measures. Officers should also initiate local or NCIC/VCIN queries requisite to the case under investigation in accordance with Department policy and NCIC/VCIN procedures.
4. **Broadcast Information and Request Resources:** Provide timely notifications to supervisors, broadcast critical lookout information to responding officers through the Department of Public Safety Communications (DPSC), and request additional resources as needed. Officers should communicate any obtained information that pertains to physical descriptions, direction and means of flight, known weapons and description, and other relevant information in a timely manner.
5. **Protect Crime Scenes:** Ensure all crime scenes are protected, make proper arrangements for the collection of evidence, process scenes whenever physical evidence exists as required, and fully brief responding detectives who are assuming follow-up investigations. The patrol officer or detective assigned to the investigation shall be responsible for ensuring delivery of evidence to the laboratory when required.
  - a. Crimes Against Individuals: The investigation of facts and collection of evidence for most crimes against individuals (ex: homicides, sexual assaults, malicious wounding) shall be the responsibility of the Major Crimes Bureau (MCB). Where MCB is requested to conduct the investigation, the patrol first line supervisor or MCB supervisor should determine if the nature and the magnitude of the crime scene warrants Crime Scene Section (CSS) response, or whether it can be handled by a patrol officer or detective. If a crime scene is not readily identifiable, the first line supervisor shall consult with the on-call MCB supervisor or lead detective prior to requesting a CSS detective and on scene officers shall ensure that action is taken to preserve the evidence until it can be collected. Supervisor responsibility for CSS detectives shall fall with the CSS supervisor during normal business hours. After hours, supervisor responsibility is with the on-call CSS supervisor.

- b. **Crimes Against Property:** The collection of evidence for all crimes against property (ex: burglary, larceny) shall be the responsibility of the investigating patrol officer or MCB's Criminal Investigations Division (CID) where the offense occurred as determined by a patrol supervisor in coordination with the CID supervisor. Patrol officers who conduct preliminary investigations in CID cases may, at the discretion of the CID commander, be temporarily assigned to CID until the investigation concludes. Patrol officers should also be named as arresting officers for purposes of Uniform Crime Reporting (UCR) documentation. Where high incidents of crime against property occur within a specific geographical location, and it is determined that CSS should be responsible for processing all related scenes, the respective station commander may contact the CFD commander for authorization regarding the variance in the above established policy regarding CSS callouts. In any situation where a supervisor has determined that the means to collect evidence of value is beyond the ability of a patrol officer, the supervisor may request response by CSS through the Duty Officer.
6. **Obtain Statements:** Obtain written and/or oral statements from all victims, witnesses, and suspects if the statements can be obtained through lawful means and subsequent to issuance of Miranda warnings as applicable. Where a case is to be turned over to MCB, officers shall not attempt to interview suspect(s) conducting preliminary investigations unless approved by lead detectives or MCB supervisors.
7. **Exchange Information:** Furnish information for victims who wish to seek warrants in strict accordance with [FCPD Regulation 204.16](#) (Information to Community Members Seeking Warrants).
8. **Victims Services Brochure:** Provide a Victims Services Brochure as applicable to identified victims or witnesses of a violent crime.
9. **Death Notifications:** MCB detectives (or patrol officers when the case is not turned over to MCB), who investigate the death of any foreign national shall be responsible for notification of the consular officer in a timely manner.
10. **Documentation:** Document all pertinent information, to include the offering of a Victim Services Brochure to any victim or witness of violent crimes, in an incident report or supplement in the current Records Management System (RMS) in accordance with the Department's [Report Writing Manual](#). Officers shall ensure that all notes written in their field notebooks ("007s") are fully transposed into incident reports and supplements. Officers shall be

personally responsible for the storage and preservation of their field notebooks for a period of no less than five (5) years.

**Note:** All death investigations, regardless of whether a MCB detective becomes involved, shall be forwarded to MCB in the current RMS.

- B. **Patrol Supervisor Responsibilities:** Patrol supervisors shall provide assistance and guidance to officers on scene and arrange for additional Department resource assistance as needed. Patrol supervisors shall ensure a complete preliminary investigation has been conducted and review all reports written by officers under their direct supervision. Supervisors shall only approve those incident reports that comply with the Department's [Report Writing Manual](#). Supervisors should encourage patrol officers to investigate criminal cases to the fullest extent where a case is not turned over to a detective.

## V. FOLLOW-UP INVESTIGATIONS

- A. Officers and detectives who conduct follow-up investigations shall review Departmental records, incident reports, and supplements from preliminary investigations and conduct follow-up interviews to acquire additional information as needed. Officers and detectives shall also be responsible for reviewing laboratory examination results, disseminating Department information as needed, arranging for subsequent examinations (including polygraphs) or surveillance, collecting evidence, the planning, organizing, and conducting of searches, reviewing criminal histories, identifying and arresting offender(s), determining suspects involvements in other crimes, preparing case supplements, and preparing cases and assisting in court prosecution.
- B. Periodic contact via telephone or in-person shall be made with crime victims for additional information as needed and to notify them of changes in case status in a timely manner. All victim contacts should be documented in supplements to the original incident report.

## VI. INVESTIGATIVE RESPONSIBILITIES

- A. Where an investigation has been assigned to a detective for follow-up investigation, that detective, a MCB supervisor, or their collective designee shall be responsible for any subsequent investigatory measures and contact with any victim(s), witness(es), or complainant.
- B. Investigations under the purview of MCB that are re-classified to offenses that would traditionally fall under another entity's responsibility shall continue to be

investigated by the assigned detective unless otherwise determined by MCB supervisors.

- C. **Violent Crimes Division:** The Violent Crimes Division shall assume primary responsibility for investigation of the following crimes wherever they occur in Fairfax County:
1. **Cold Case:** Unsolved stranger rapes, sodomies, and sex-related abductions, unsolved homicides and equivocal deaths, and events involving the use of deadly force by a FCPD officer. Deaths of individuals that occur while in the custody of FCPD, including during and after an arrest or detention, while being transported in a police vehicle, at any police facility, or while at the ADC. Deaths of individuals in a medical facility who are in in the custody of the Fairfax County Sheriff's Office (FCSO).
  2. **Child Abuse:** Physical abuse of children by caretakers that involve serious or life-threatening injuries, sexual abuse of a child by a caretaker regardless of victim age, (unless the victim is 13 years of age or older and the suspect is unknown or not a caretaker).
  3. **Domestic Violence Squad:** Incidents of violence involving individuals in covered relationships as well as intimate partners (which include current or former spouses or partners), including felony assaults, strangulations, abductions, burglaries (domestic related), stalking, unlawful tracking, and protective order violations.
  4. **Homicide Squad:** Accidental deaths (ex: overdoses, death as the result of a fall, etc.), accidental shootings of one individual by another where death is considered imminent, homicides, suicides, suspicious deaths, active duty FCPD and Fairfax County Fire Department deaths, found body cases (to include a found fetus), drownings, infant death cases, construction fatalities or serious injuries (hospital emergency room treatment in critical condition), fire fatalities, felonious life-threatening assaults (aggravated malicious wounding) resulting in permanent disability, disfigurement, or potential death, found skeletal remains (human bones), in-custody deaths in jail (Sheriff's Office responsible for custody) not involving any mitigating circumstances (ex: suicide), natural deaths with no attending doctor, cases where next of kin cannot be located or contacted, all medical examiner cases, bombings where injury or death occurs, conspiracy to commit murder (OCN or CIU may work), abduction case involving the abduction of minor children by strangers or unrelated persons where circumstances indicate the child's life is in danger (Sex Crimes may work where sexual assault is involved).

- a. **Nursing Care/Home Facility Deaths:** Police responses shall not be required to natural deaths attended by medical personnel that occur at nursing homes unless they involve Medical Examiner cases.
  - b. **State Run Facilities:** Suspicious death cases occurring in state-run facilities require notification to Virginia State Police for determination of the investigating agency.
5. **Armed Robbery and Contact Shootings (ARC) Squad:** ARC shall assume primary responsibility for the investigation of the following crimes whenever they occur in Fairfax County:
- a. All robberies involving firearms, including bank, street, commercial establishments, and home invasions.
  - b. Carjackings.
  - c. Abductions committed in connection with robberies.
  - d. All contact non-fatal shootings and non-contact shootings into an occupied residence, business, vehicle, or at an individual.

**Note:** Accidental discharges of a firearm (i.e., cleaning a loaded firearm) shall remain the investigative responsibility of responding patrol officers in consultation with the Office of the Commonwealth's Attorney.

6. **Sex Crimes:** Sex crimes committed against victims thirteen (13) years of age or younger, bigamy, rape, felony and serial sex offenses, abductions and/or burglaries where sexual offenses are committed or attempted, sodomy, human trafficking, aggravated sexual battery, animate/inanimate sexual penetrations, incest cases where the victim is eighteen (18) years of age or younger, marital felony sexual assaults/rapes, peeping cases related to serial indecent exposure cases, indecent exposures where the victim is thirteen (13) years of age or younger or have follow-up leads and appear to be related to a serial offender.

D. **Criminal Investigations Division:** The Criminal Investigations Division shall assume primary responsibility for investigation of the following crimes wherever they occur in Fairfax County:

- 1. Abductions (non-domestic and non-dating stalking).
- 2. Burglary.

3. Street Robberies that do not involve the use of a firearm.
4. Reckless discharges of firearms that do not involve death or serious injury.
5. Grand Larceny (\$1,500 or more from a person or business).
6. Financial Crimes (excluding financial cases reported through FICOR).
7. Extortion that includes a threat of violence and/or loss of \$5,000 or more.
8. Non-Fatal Felonious Assaults that Require Medical Attention.
  - a. Includes stabbings, malicious wounding, and blunt force trauma.
9. Missing Persons (excluding child custody disputes).
10. Fugitive Extraditions.
11. Vandalism.
12. Obscene or Annoying Phone Calls/Texts.
13. Prescription Fraud.
14. Stalking (non-domestic and non-dating stalking).
15. Computer Crimes (Fraud, Trespass, Invasion of Privacy, Theft of Services, Threats and/or Harassment).

**Note:** Abduction cases that are not associated with sexual assault or robbery crimes will be investigated by CID unless facts and circumstances exist that support transfer of investigative responsibility to the Violent Crimes Division.

- E. **Cyber and Forensics Division:** The Cyber and Forensics Division shall assume primary responsibility for investigation of the following crimes wherever they occur in Fairfax County:
- a. Internet Crimes Against Children (including attempts).
  - b. Production, Distribution, and Possession of Child Pornography (including attempts).



F. **Organized Crime and Intelligence Bureau:** The Organized Crime and Intelligence Bureau (OCIB) shall investigate the following:

1. Narcotics-related overdoses.
2. Incidents related to possible terrorist activity.
3. Bomb Threats.
4. Bias Crimes.
5. Active threats to public safety, to include school threats and swatting cases.
6. Violent felony fugitives from justice.
7. Investigative support for gang-related crimes.
8. Narcotics-based organized crime (ex: drug distribution and networks), money laundering, vice offenses (ex: prostitution), violations of the Drug Control Act, and other related cases.
9. Larcenies of automobiles (cars, trucks, buses, registered motorcycles or motorcycles with engine displacements of 125cc or more whether licensed or not), tractor trailer rigs (where the entire rig is stolen), larceny of completed engines or transmissions, alterations to vehicle identification numbers and/or markings, unauthorized use of vehicle cases when suspect is unknown, stolen vehicles from other jurisdictions recovered in Fairfax County with apprehension.

G. **Crash Reconstruction Unit:** The Operations Support Bureau's Crash Reconstruction Unit (CRU) shall investigate the following traffic crashes:

1. Fatal and life-threatening injury traffic crashes.
2. Serious injury commercial/passenger carrier crashes.
3. All train crashes involving life-threatening or fatal injuries.
4. County vehicle crashes involving death or serious injury.
5. Suicides by moving transportation (includes trains, aircraft, boats).
6. Industrial accidents involving a motorized vehicle resulting in death.

H. **Patrol Officers:** Patrol officers must be granted approval by both a MCB supervisor and their district commander prior to conducting an investigation of any offense falling within the purview of MCB and/or OCIB. Where a patrol officer conducts follow-up investigations in these cases, a copy of the preliminary report and all supplements shall be forwarded in the current RMS to the investigative entity affected for record keeping purposes. MCB personnel shall assist and provide guidance as necessary, however, all follow-up investigatory measures shall be the responsibility of the assigned patrol officer until otherwise directed by the MCB supervisor.

1. The Organized Crime and Narcotics (OCN) Division shall be consulted for all significant narcotics cases, arrests, and search warrants for both guidance and deconfliction. Patrol officers shall not, under any circumstances, conduct vice or narcotic investigations that require pre-arranged scheduled criminal activity (i.e.-setting up “deals”) that may also involve the use of technology or web-based applications without approval of the OCN commander.

## VII. GANG INTELLIGENCE UNIT

A. **Responsibilities:** The Gang Intelligence Unit (GIU) shall provide investigative and enforcement support to any Department entity or investigation associated with gang activity. GIU is a standing element that is assigned to the Special Investigations Division (SID) of OCIB and maintains a repository of regional gang intelligence for investigatory support. GIU call-outs for traditional MCB investigations shall require the GIU supervisor to coordinate with an MCB supervisor to determine whether MCB shall also respond.

GIU shall also review all gang-related case reports, confirm or deny the presence of gang activity and/or gang member association, and follow-up on gang cases where intelligence may be gained and disseminate monthly gang activity summaries, officer safety bulletins, and related information to the Department as needed. GIU is responsible for timely notifications to affected station commanders of current or future gang activity and shall provide educational support on gang-related topics upon request to the Department and community.

B. **Officer Reports:** Incident reports shall be classified as “**GANG ACTIVITY**” as a subsequent event in the current RMS whenever the following criteria exists:

1. The investigating officer or detective suspects a case is gang-related, or any suspect(s), victim(s), or involved individual(s) is identified as, or believed to be, a gang member, or any gang member/associate is charged with a crime.

2. Where a reliable informant identifies an incident as gang-related, or any informant identifies the incident as gang-related and the allegation can be corroborated by other independent information.
  3. Where an officer reasonably believes the incident may motivate a delinquent group to form an alliance for self-protection, retaliation, or any other reasons that would categorize them as an emerging gang.
- C. **Gang Tracking Database:** GIU shall maintain a gang intelligence system through the current RMS that tracks gang member contacts in Fairfax County. Individuals that meet the definition of a gang member per the [Code of Virginia](#) shall be entered into the gang tracking module and NCIC/VCIN. The GIU supervisor shall serve as administrator of the tracking system and approve all entries and deletions in compliance with federal and state regulations. Only GIU detectives shall enter gang members into the tracking system or NCIC/VCIN.
- D. **Station Commander Responsibilities:** District station commanders shall appoint a Station Gang Coordinator to serve as a station liaison with GIU. Commanders shall review reports, bulletins, and intelligence summaries of district gang activity, communicate gang-related concerns to the Criminal Intelligence Division Commander, and coordinate station initiatives with GIU.
1. **Station Supervisors:** All station level supervisors shall review incident reports to ensure gang activity is captured whenever reportable, ensure gang-related information is forwarded to GIU and the station gang coordinator, and immediately notify GIU via the PLC whenever gang activity occurs resulting in the interview of any victim, suspect, or witness.
  2. **Station Gang Coordinator:** Station gang coordinators shall review information on gang activity in their district from all law enforcement sources, verify and forward information to GIU for entry into the current RMS and NCIC/VCIN, assist station personnel and GIU detective as needed with follow-up investigations, provide timely gang activity information to district station personnel as needed, attend monthly gang coordinator meetings or provide an alternate, and provide informational training to officers and educational seminars to community groups, schools, and businesses.
- E. **Major Crimes Bureau Responsibilities:** MCB supervisors shall coordinate with the GIU supervisor to investigate and apprehend criminal gang members and determine in the course of their respective investigations whether MCB or GIU detective responses or follow-up investigations are warranted. Where MCB and GIU personnel both respond to a scene, MCB shall maintain primary control of the scene and coordinate investigatory assignments with the MCB supervisor,

unless a MCB supervisor is unavailable, in which case GIU shall have investigative responsibility and control of a scene. Gang-related homicides may necessitate the temporary assignment of GIU detective(s) to MCB to work under the supervision of a MCB supervisor.

## VIII. SERVICES TO CRIME VICTIMS, WITNESSES, AND SURVIVORS

- A. The Victim Services Division (VSD) shall provide services to crime victims to ensure their rights as provided for by the [Code of Virginia](#) are protected and reduce the reoccurrence of secondary trauma that might potentially be experienced after an initial crime occurs.
- B. **Officer Responsibilities:** In the absence of a VSD specialist, officer and detectives shall be responsible for addressing the immediate needs and concerns of victims and witnesses, to include but not be limited to, providing case numbers, phone numbers, addresses for police or county services, transportation to shelters or medical facilities, protection from harm or threat arising out of cooperation with either law enforcement or prosecutorial efforts, assistance in petitioning for protective orders, scheduling line-ups, interviews, and other appearances at the convenience of the victim or witness, notification of court dates and hearings, updates on case status, and return of victim property held as evidence in a timely manner when no longer required for prosecution.
- C. VSD shall provide assistance to any victim(s) of the following crimes:
1. Homicide/Manslaughter
  2. Adult/Child Rape and Sexual Assault
  3. Child Physical Abuse
  4. Domestic and Intimate Partner Violence
  5. Stalking
  6. Assault/Battery
  7. Malicious Wounding
  8. Vehicular Manslaughter
  9. Home Invasions
  10. Robbery
  11. Human Trafficking
  12. Carjacking
- D. **Victims Services Division Specialists:** VSD Specialists shall coordinate services to victims and witnesses with detectives and patrol officers as appropriate and whenever not detrimental to the successful prosecution of a case. VSD Specialists are available 24/7 and through on-call status. Supervisors may request VSD support through either the on-call supervisor or

Director of the VSD through the PLC. VSD shall provide services, information, and referrals to victims and witnesses of crimes on the following resources:

1. **Emergency Aid:** On-scene crisis intervention, information pertaining to victim and witness rights and services, safety planning, referral for emergency financial aid, emergency transportation, response and accompaniment to a medical facility for sexual assault, intimate partner examination, emergency restraining or protective orders, information assistance on recovery of stolen property, crime scene clean-up, and interpreter services.
2. **Counseling and Advocacy:** Crisis intervention services, referrals for short and long-term counseling, access and referrals to support groups and group counseling, community crisis response, access to counseling during criminal and juvenile justice adjudication procedures, intervention with employers, creditors, and landlords, and intervention with public agencies.
3. **Investigations:** Regular updates on investigation status as appropriate, basic information on the criminal justice system (but not provide legal advice), assistance with scheduling of line-ups, interviews, and other required appearances at victim and witness convenience, compensation claim filing and processing assistance, protection from intimidation and/or harassment, notification of pretrial release of an accused individual, input into bail and bond release decisions, and transportation/parking assistance for appearances associated with the investigation.
4. **Prosecution:** Orientation with the criminal justice system, updates on case status, accompaniment to court, assistance in being provided separate waiting areas during court proceedings when appropriate, witness alert/on-call technology 24/7, employer intervention services, assistance in recovery of property held as evidence, restitution routinely requested or an explanation in writing, landlord/creditor intervention, and notification of plea negotiations and victim consultation in plea decisions.
5. **Post-Prosecution:** Notification of the right to submit a victim impact statement, distribution of victim impact statements to probation and parole, victim impact statement in allocutions, information/notifications of appeal of parole hearings, and notifications of change in status.
