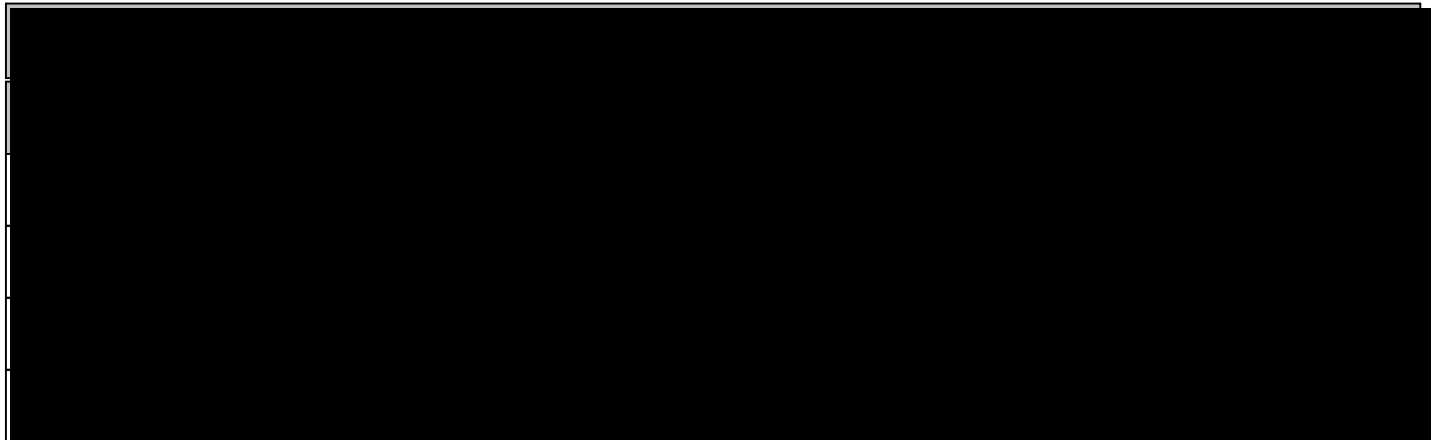

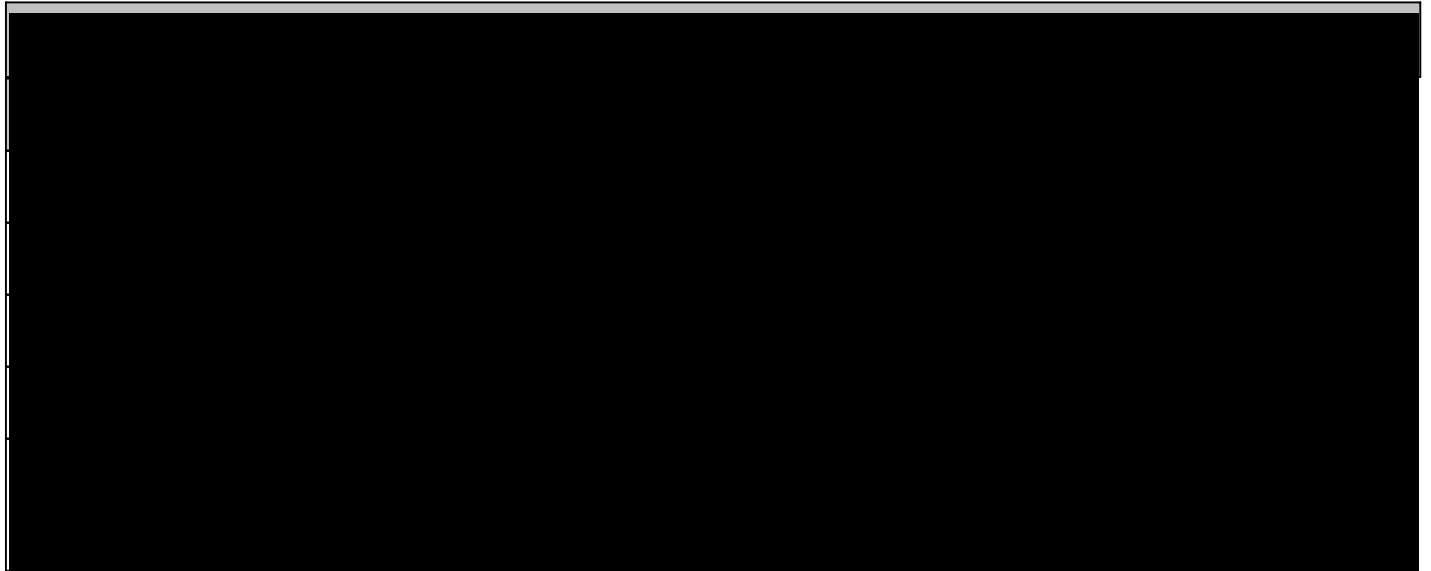

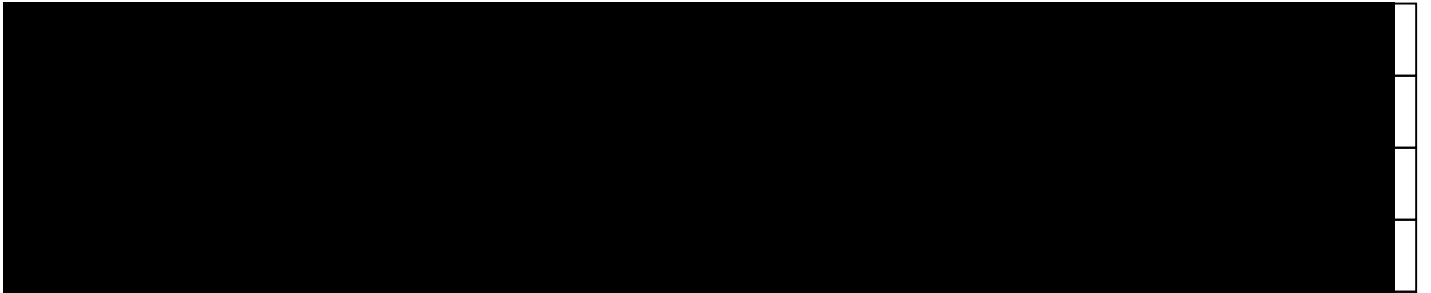

Notes/Narratives

On 1-7-15, around 1445hours [REDACTED] and his friend [REDACTED] were walking to the buses when they were approached by two male students [REDACTED] right outside the cafeteria. [REDACTED] grabbed [REDACTED] shirt and pushed him into the corner of the wall. [REDACTED] then punched [REDACTED] in his right eye. Then [REDACTED] punched [REDACTED] in his right eye as well, while [REDACTED] was holding him against the wall. [REDACTED] was not able to get away. [REDACTED] witnessed the assault. [REDACTED] both wrote out statements.

I spoke to [REDACTED] and he stated that [REDACTED] ran up to [REDACTED] and punched him in the head. According to [REDACTED] then pushed [REDACTED] into the wall and punched him. [REDACTED] claimed that he saw this happened and ran over to tell [REDACTED] to stop fighting, because they are friends and he didn't want him to get in trouble. I spoke to [REDACTED] father on 1-9-15 around 1500hours and informed him of the investigation and pending charges. Mr. [REDACTED] stated he would let [REDACTED] mom know as well.

[REDACTED] stated that [REDACTED] and his friend ran up on them while they were walking to the buses. [REDACTED] stated that [REDACTED] and [REDACTED] started pushing them. He then grabbed [REDACTED] and pushed him against the wall. [REDACTED] claimed that [REDACTED] swung on him but missed and he was able to run away. [REDACTED] claimed that [REDACTED] ran after him and punched him in the back of the head. [REDACTED] (the principal) happened to be in the hallway and apparently then grabbed [REDACTED] walked away. [REDACTED] did not report any injury. [REDACTED] mom was notified by Ms. [REDACTED] on 1-9-15 at 1105 hours about the investigation and pending charges.

I spoke to [REDACTED] father on 1-9-15 and he stated that he wanted to press charges. Mr. [REDACTED] took son to [REDACTED] to have his eye examined on 1-7-15. His right eye was swollen. There was no school on thursday, however I spoke with [REDACTED] in my office on 1-9-15 and his right eye was still swollen.

Since this assault, [REDACTED] and [REDACTED] continue to follow [REDACTED] around the school. A teacher has witnessed these students waiting outside the bathroom for them to walk by (I have a copy of the referral that was sent to Ms. [REDACTED]). I have two more students that are being harassed by [REDACTED] and Ms. [REDACTED] is translating those statements for me.
