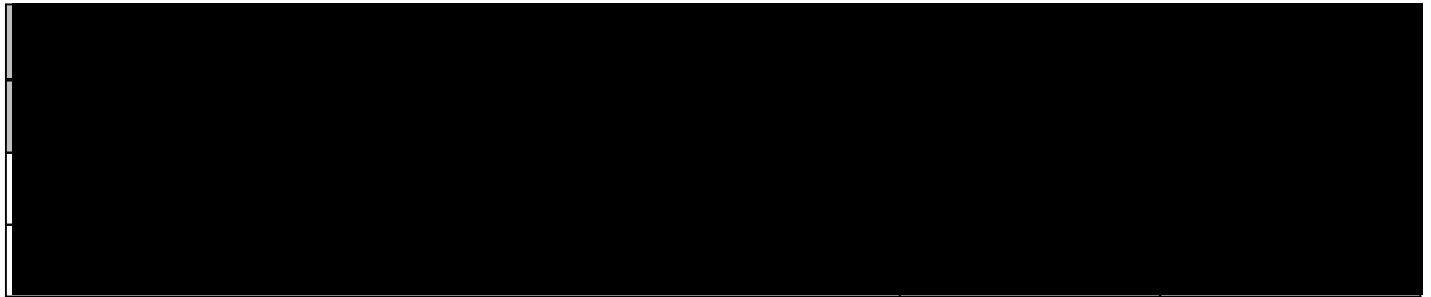

## Notes/Narratives

On 1-9-15 around 1110 hours, [REDACTED] (the principal) was walking up a back staircase to go upstairs to the learning lab. This back staircase is off limits to students and there is a sign posted. This staircase is located next to the LDR.

The female student is standing there holding her underwear in one hand and her pants in the other hand. The female student gets dressed and [REDACTED] brings her immediately to my office.

Both [REDACTED] came into my office. We identified the female student as [REDACTED] finally gave us the name of the male student that took off running from the principal. His name was [REDACTED] located [REDACTED] and got his statement. [REDACTED] gave us several different stories as to what happened. She finally admitted that he is her boyfriend and they planned to meet up. They arranged this meeting through an app called, KIK.
