### Notes/Narratives

On January 26th, 2015 while continuing to investigate case #20150270029, a student [REDACTED], informed School Security that she bought the marijuana from another female student at school during [REDACTED]. [REDACTED] stated the student's name is [REDACTED]. [REDACTED] was escorted to AIA for the remainder of the day until the 7th grade [REDACTED] could talk to her about the incident. School Security then brought [REDACTED] to their office. [REDACTED] bookbag was searched by Security and they located a small container wrapped in tin foil with two small baggies inside that contained a green leafy substance. [REDACTED] told Security that [REDACTED] during [REDACTED]. That \$20 was also taken by Security. [REDACTED] admitted to selling marijuana in school. [REDACTED] said that some H/M named [REDACTED] who she thinks [REDACTED] was the one who gave her the marijuana to sell at school. The only further description she could provide was that he is a [REDACTED], 6 feet tall, and has bushy eyebrows. [REDACTED] said that this [REDACTED] met her outside of her house on 1-25-15 and gave her the stuff to sell. School Security turned the container with the two baggies and the cash over to this unit. The substance from each baggie was field tested and both tested positive for marijuana. All of the evidence was packaged and stored at Station 2.

[REDACTED] mom responded to the school to [REDACTED]. She was informed of school consequences by Mr. [REDACTED] and this unit informed her of the criminal charges.

This unit will be filing for a petition for distribution of marijuana on school property. The report and Intake form was sent to South County Juvenile Intake.
