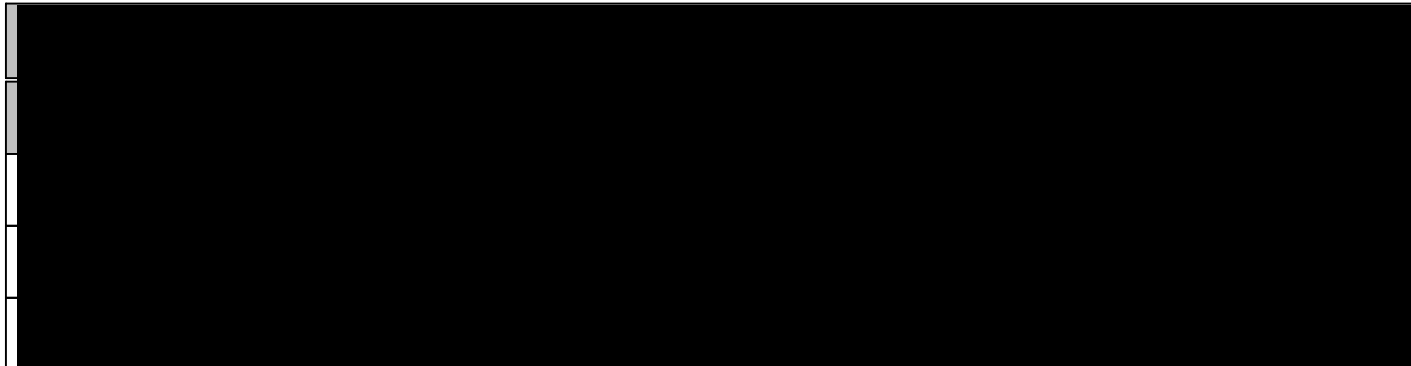

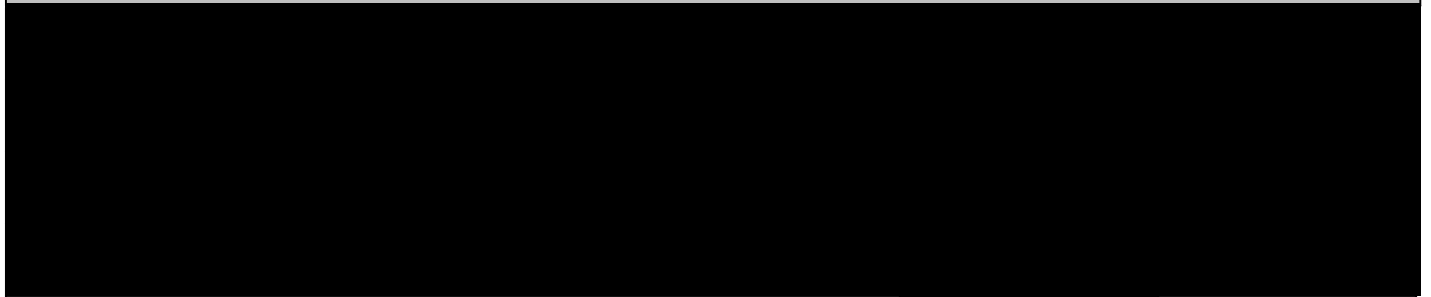

Notes/Narratives

On 2-09-15, I was called to the 8th grade [REDACTED] office because a sexual assault just occurred. One of the counselors [REDACTED] brought an 8th grade student, [REDACTED] to [REDACTED] office. [REDACTED] n told her counselor that there was a male student in her [REDACTED] class that has been touching her inappropriately since the beginning of the semester (2-4-15).

[REDACTED] stated that on her first day in the class a male student, [REDACTED] touched her buttocks. [REDACTED] told him to stop and pushed his hand away. She stated that the touching became increasingly more frequent. [REDACTED] would touch her buttocks and her breasts. Most of the touching occurred while she was sitting in her chair. There were a few occasions when [REDACTED] would slap her buttocks as she walked out of class. On 2-9-15, [REDACTED] was still touching her inappropriately and she continued to push his hands away and told him to stop. At the end of class he touched her vaginal area with his hand for a few seconds. At no time did his hands go under her clothes.

[REDACTED] parents right away and they responded to the school immediately.

I called [REDACTED] mom on 2-9-15 at 1pm to advise her of the situation and the possibility of criminal charges. She gave me permission to talk to her son about the incident in class. [REDACTED] said he thought she was cute and on the first day he took her planner and wrote his number down. [REDACTED] grabbed her planner back and erased the number. [REDACTED] stated he only touched the side of her leg and never her breasts. He claims that they both horseplay/play fight back and forth and that he accidentally touched her vaginal area on monday. [REDACTED] refused to write a statement for me.

I spoke to the teacher, [REDACTED], and he stated the only interaction he saw between the two students was when [REDACTED] is my girlfriend' and [REDACTED] replied, 'No way.' There were two students in class that witnessed [REDACTED] buttocks. They have provided written statements.

[REDACTED] was immediately suspended from school and his case will be sent to the Hearings Office.

[REDACTED] father, and mothers again on 2-10-15 at 0830 hours. I explained the criminal/court process to them and they stated they needed time to think about this.

I received an email from [REDACTED] family on 2-12-15 stating that they want to press charges. I then spoke to [REDACTED] and explained the charges and the next steps.

The report and Intake form was sent to Juvenile Intake. Nothing further at this time.
