After speaking to several students at school, I found out that sent the video to two students at Sandburg: stated that he did not send it to anyone. admitted to sending it to a female student at Sandburg. One day (they could not provide a specific date or time) during pulled out his cell phone and showed told said he would send the video to them. This video was sent via the application:
The video was sent to 15+ students at Sandburg MS. I met with conference room. did not want to give his version of what happened and how the video was distributed to multiple students. step father refused to have turn his phone over for the investigation. This meeting took place on 4-21-15 at 1330 hours.
I consulted with and the CWA's office is not going to prosecute the students that distributed this video at this time. The CWA's office will pursue charges again for production of child porn and one count of distribution of child porn. requested that I collect the phones/tablet from These items were sent to the property room at station 2. The parents of were notified.
A search warrant was written, signed, and executed on 4-20-15. With the help of CIS and CIB I collected phone and three other electronic devices that possibly have the video stored on it.
