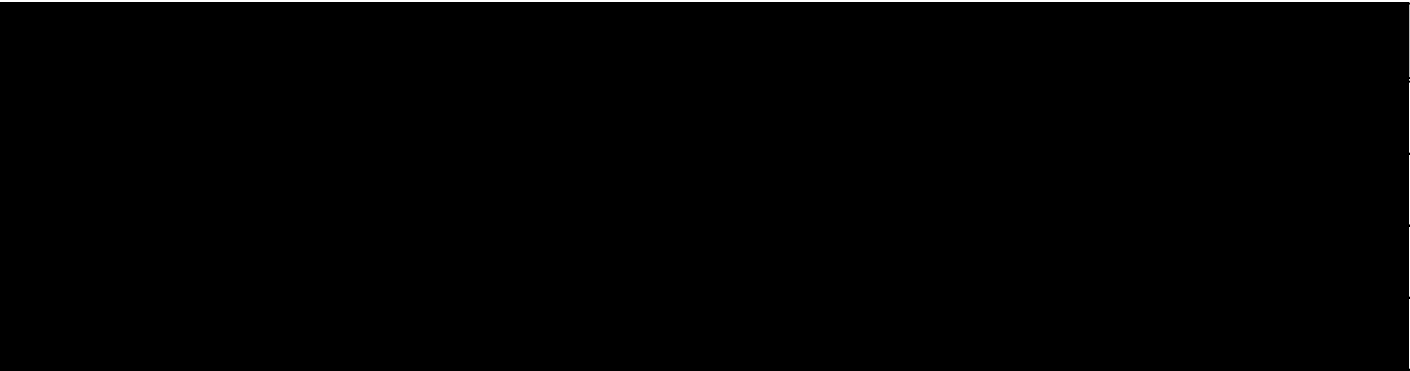

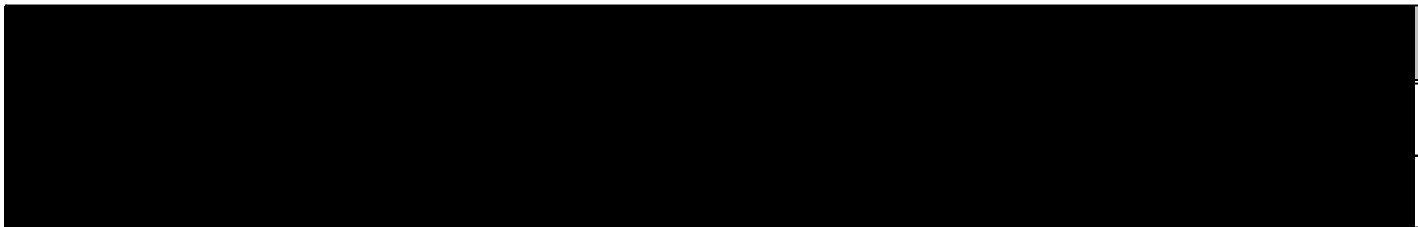

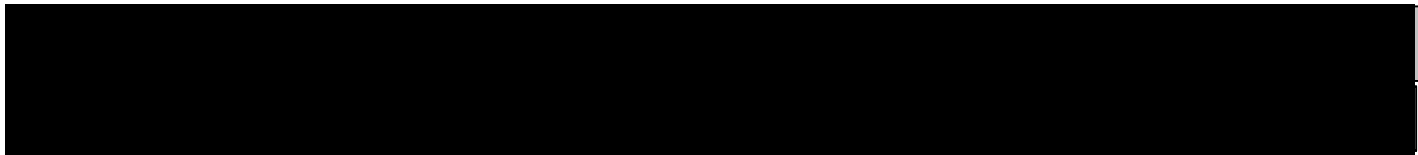

Notes/Narratives

On 6-3-15, I was notified of an assault that took place on 6-2-15 during 7th period (1310-1355 hours). The assault took place in room [REDACTED]. According to [REDACTED], came to her office, crying, after the assault took place. I spoke with [REDACTED] and she stated the following took place. [REDACTED] several students were crowded around the window because another student threw a cookbook out the window. [REDACTED] stated that a male student, [REDACTED], `fell` onto her and touched her breast. [REDACTED] thought it was an accident so she ignored it. Later in class [REDACTED] pulled her hair and said, `gaga`. As class was dismissed he fell into her again and touched her breast a second time. She yelled at him when he touched her the second time and he ran off. She felt it was intentional because she noticed he was laughing. [REDACTED] stated that there was a witness, [REDACTED]

[REDACTED] stated that she saw [REDACTED] breast. [REDACTED] heard [REDACTED] talking about how he was going to touch her breasts. [REDACTED] had another student, [REDACTED] fake push him into [REDACTED]. She also saw the boys laughing about what they had done.

[REDACTED] was suspended from school for 5 days. I have not been able to talk to [REDACTED]. I have made several attempts to speak with [REDACTED] and [REDACTED] so I can hear his side of the story, but Dad has not responded about when we can talk about the incident.

On 6-9-15, [REDACTED] have decided to press charges for sexual battery. I sent this report and the Intake form to JDC.
