





Notes/Narratives

On 6-11-15, [REDACTED], came to my office to report that someone stole her iphone during 3rd period. [REDACTED] stated that she had her phone in the pocket of her binder and her English class was in a different room that day. The class was in the new Learning Lab. A few minutes before the bell rang is when [REDACTED] noticed that her phone was missing. [REDACTED] told her teacher [REDACTED] and she told her there was nothing she could do.

[REDACTED] went to the front office to report the larceny. [REDACTED] also called her mom [REDACTED] who responded up to the school. [REDACTED] also brought her son who had his iphone and was attempting to track the phone. For the next several hours it showed up as being inside and around the school and the phone would turn off and on. Around 1430 hours, we were able to show that the cell phone was possibly in the 7th grade Boy`s Locker Room. I went immediately to the locker room and had every student stop what they were doing and gave them a chance to had it over. Nobody said anything so I had [REDACTED] send another alert to the phone. I heard the noise in the locker room. One of the [REDACTED] and myself tried to locate the phone. Then the teacher said he found the phone on the floor in one of the bathroom stalls. One witness, [REDACTED] stated that he saw [REDACTED] slide the phone under the bathroom stall. [REDACTED] claims he found it upstairs on the floor and kept it in his pocket all day long until 8th period when I showed up searching for it that was when he slide it under the bathroom stall.

I contacted [REDACTED] mom and notified her that the victim`s parents wanted to press charges.

The iphone was entered into TTY and later removed.

The Intake form and report was sent to JDC Intake for processing.
