Notes/Narratives On 9-18-15 around 1130 hours. was turning onto school grounds from Ft. Hunt Road and observed a female student getting out of a vehicle on Ft. Hunt Road. recognized the female as who is currently an 8th did not recognized the unknown male who dropped her off on the road instead of taking her to the front office. The red vehicle had a Maryland license plate, unknown tag. reported this to later in the afternoon and told her a story that did not make any sense. paid this male to drive her to school since she missed the bus. know anything about this unknown male. was involved in an case back in April where there was an arrest made. Since that event mom took her cell phone away. (Parent Liason, translator) on came to school to meet with myself, 9-21-15 at 1330 hours. was not present. stays in her bedroom from the moment she gets home from school and does not engage with the family. She is not helpful at home. is always trying to use her littler brother's tablet/ipod to connect to the house WiFi. has found different phones, ipods, etc in possession on several differnt occassions. According to mom, the school assigned her a latop and mom has caught her up late at night on the laptop. Yet, still has not taken the laptop from does not want to be apart of the family and according to mom it is because she resents the family. is the 3rd child and was the only one born in El Salvador. All the other children were born in the United States. came to the United States when she was about 8 years old. According to mom, she was smuggled into the United States and almost died. Mom also was prescribed sleeping pills but never takes them. has a hard time falling asleep and mom has noticed from time to time that the mouthwash is missing. On 9-18-15, takes her to the bus stop in the mornings. mentioned that uses secretly. Mom could not remember. According to another student who happens to be cousin, stated that on 9-18-15 he saw on the bus that morning. never went to her 1st period class. The automated phone system should have alerted mom that not in class however we discovered that the number was wrong in the system which is why mom never knew she was absent. It just hapened to be a concidence that get out of that vehicle. about this event. I have not questioned any parties involved in this case. I have sent this case to I spoke to follow-up given history.
