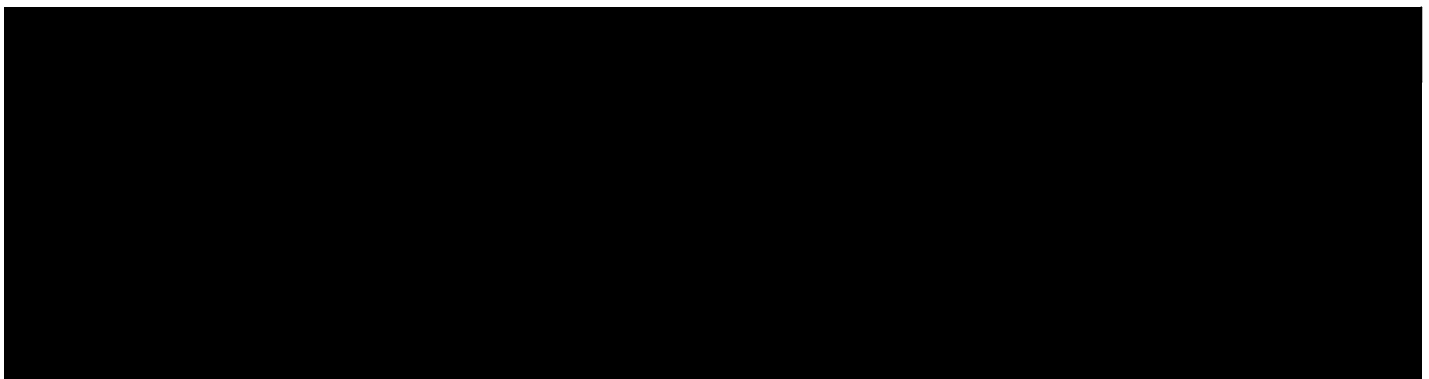

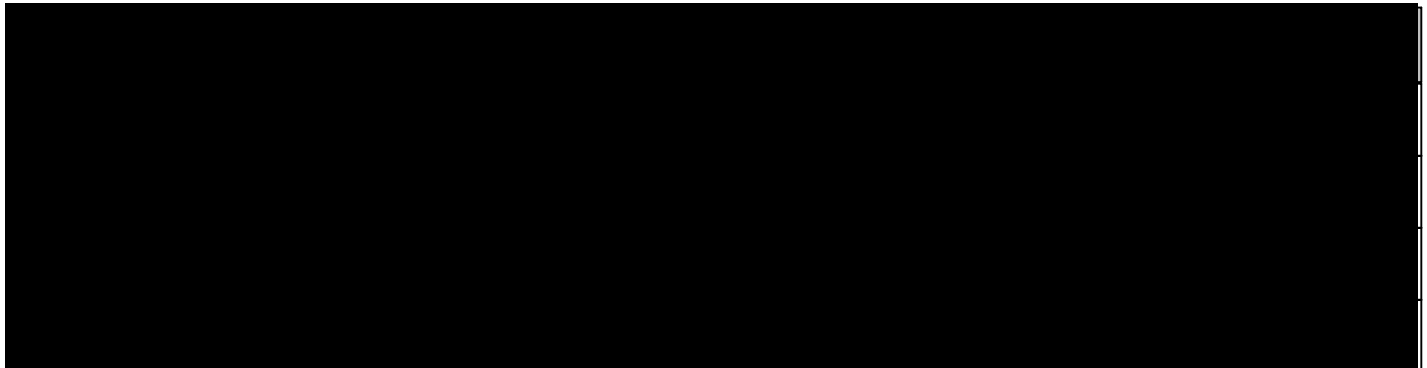

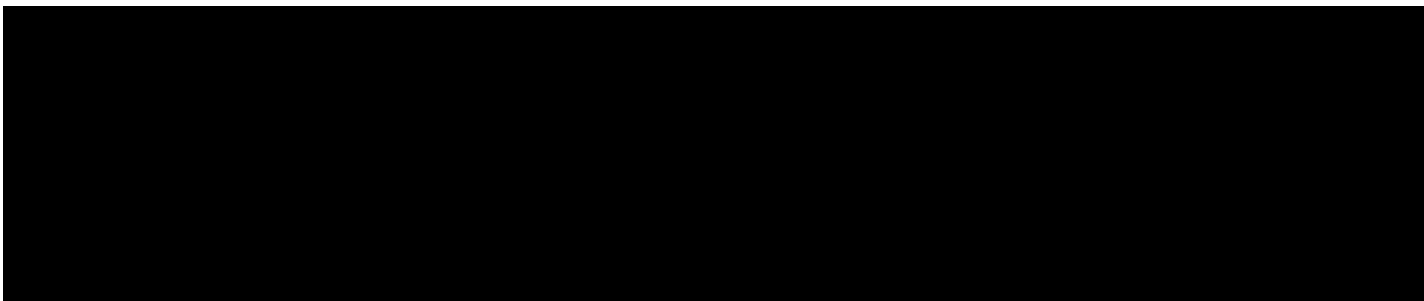

On 10-28-15, I was informed by [REDACTED] that a parent was going to bring me an ipod that she found in her daughter`s bedroom. This parent, [REDACTED] that her daughter [REDACTED] is not suppose to have any electronic devices because they have been taken away from her.

On 10-29-15 [REDACTED] brought the ipod to my office. The ipod is blue and the serial number is [REDACTED] I remembered that I had a female student report to me back in September that someone stole her ipod and it was blue. I called this student, [REDACTED] to my office and she brought the original box and receipt. The serial number on the phone matched that on the original box.

I notified [REDACTED] on 10-29-15 that the ipod she found in [REDACTED] possession was in fact stolen. [REDACTED] was able to unlock the ipod and reset it. She made the ipod her own. She added her own apps, pictures, and apple information. [REDACTED] gave me the password to unlock the phone and I attempted to reset and wipe the phone but she is not giving me the correct Apple ID password. I have two students that have overheard her talking about how she knows the password for her Apple account.

I spoke to [REDACTED] in my office and she claims that another student gave her this ipod. I checked on her story and I cannot validate it. At this time I am going to charge [REDACTED] with possession of stolen property. [REDACTED] has already been through diversion.
