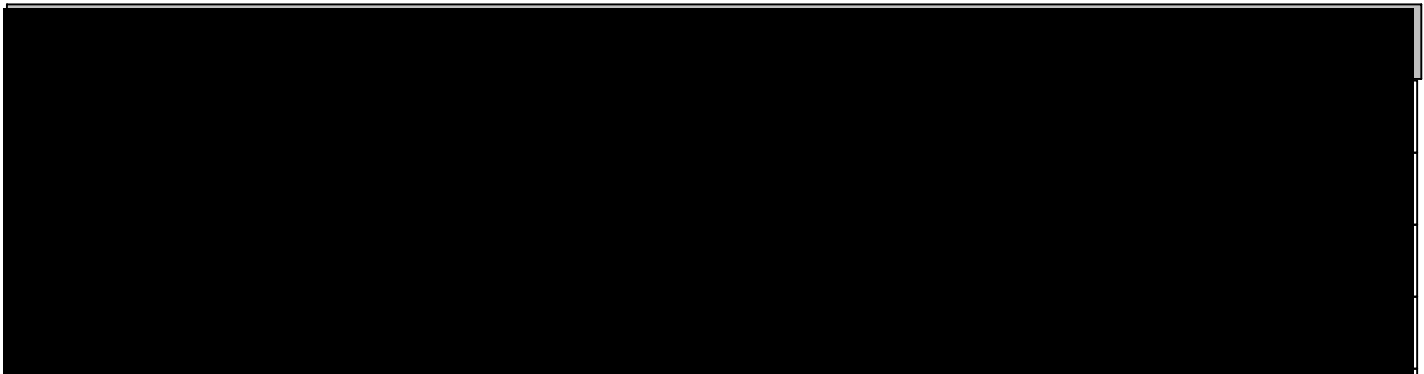

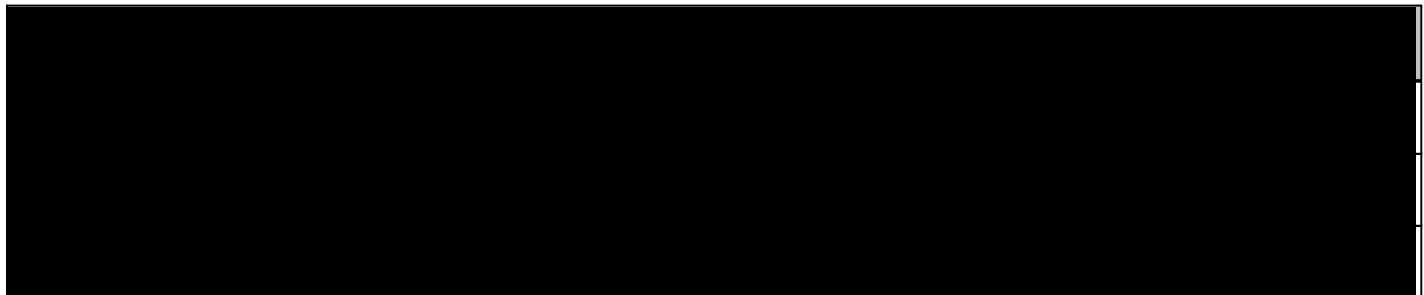

On 12-17-15, [REDACTED] called this unit to report a theft in her class. [REDACTED] stated that it occurred during her 7th period class on 12-16-15. This unit and School Security went to her classroom [REDACTED] at the beginning of 7th period at 1241 hours. After talking with several students, it was discovered that [REDACTED] was the one who stole a bag of balloons off [REDACTED] desk. [REDACTED] admitted this to myself, School Security, and [REDACTED] that he stole the bag of balloons. [REDACTED] said that after class he passed them around to several students and they used them in 8th period or in the hallways playing around and popping them.
