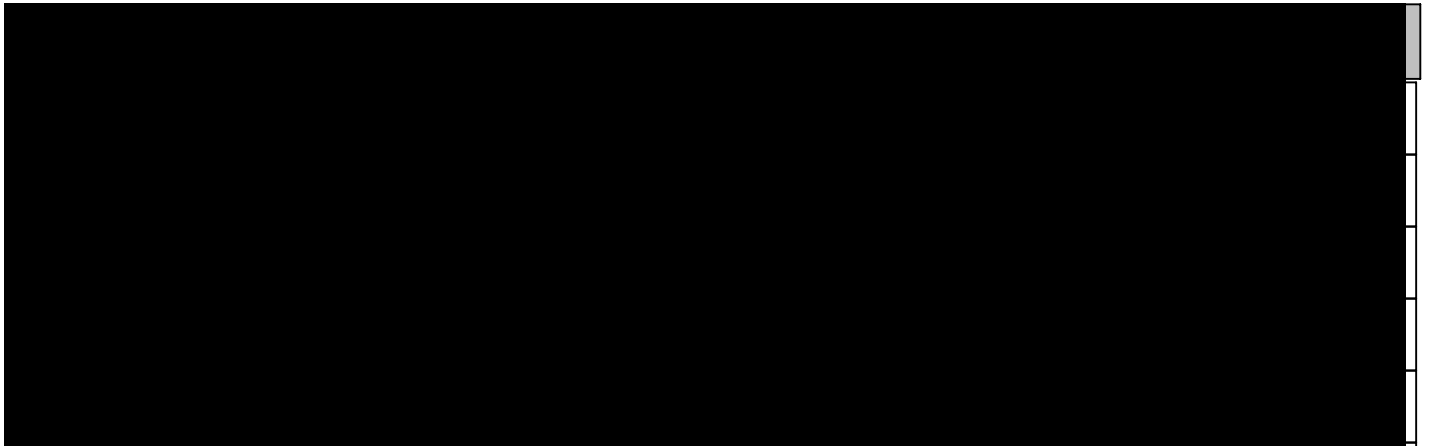

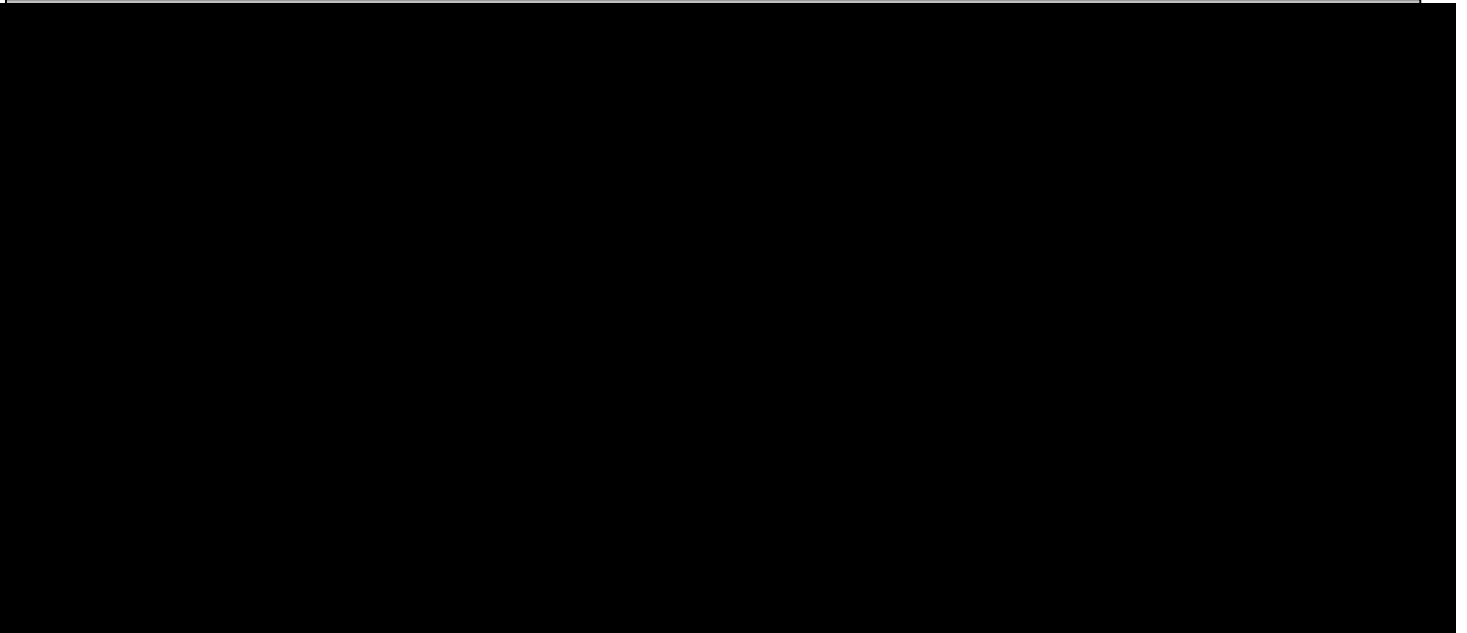

Notes/Narratives

On 1-7-16, I was contacted by [REDACTED] (Assistant Principal) about a sexual assault case involving two Sandburg students. I was advised that the victim, [REDACTED] told her school counselor [REDACTED] that a male student has been touching her on her buttocks, breasts, and vagina since October 2015. [REDACTED] identified this male student as [REDACTED] At school he goes by [REDACTED] and I have been told that he is possibly in a gang.

[REDACTED] about the situation and based on [REDACTED] last name [REDACTED] is his assigned administrator, therefore [REDACTED] was notified of the incident.

I was told that this started back in October 2015 and has happened about 5-6 times during the school day. One time (unknown exact date) [REDACTED] touched her buttocks and [REDACTED] slapped him and told him to stop. [REDACTED] then pushed her up against a locker. Another incident (I believe took place on 1-6-16 in a classroom) [REDACTED] around her neck and touched her boobs. [REDACTED] has also walked up to [REDACTED] and said, "Hey slut, you need to stay after school."

As of today, I was told there is one witness (maybe more) and her name is [REDACTED]. I contacted CIB and spoke to Detective [REDACTED] and she asked that I write up the initial report and not to talk to any of the students in this case. This case will be TOT-CIB for follow-up.

CIB sent the case back to this unit for follow-up.

I spoke with [REDACTED] and she told me that back in October 2015 her 7th period class went to the library and while she was walking to the library [REDACTED]. Then as the class was leaving the library [REDACTED] slapped her buttocks again and touched her breasts. [REDACTED] told him to stop. There was a female student [REDACTED] that witnessed this sexual assault. In January, at the end of 8th period (right before the bell rang) [REDACTED] came up behind her and hugged her around her neck and he grabbed her breasts. [REDACTED] has told him to stop. There was another time when all the Civic classes were in the Auditorim and [REDACTED] touched her vagina. On this occassion a student [REDACTED] witnessed this unwanted touching.

[REDACTED] mom wants to press charges. [REDACTED] first reported this to her [REDACTED] and administrator at school what was going on. [REDACTED] immediately contacted [REDACTED] parents and he was suspended and has a meeting with the Hearings Office (2-1-16). Since this unit was originally told CIB would handle the follow-up, this unit did not speak to [REDACTED]. On 1-12-16 around 1305hours, [REDACTED] and his mom came to school to pick up his school work. This unit informed mom that the victim is pressing charges and this unit wanted to talk to [REDACTED]. This unit informed his mom that he doesn't have to talk to me if he does not want to. [REDACTED] and his mom agreed to come to the principal's conference room to talk. During the entire interview, [REDACTED] slouched in the chair, kept his hat on, and mumbled with his hand over or near his mouth. He had to repeat statements several times becuase this unit and the Parent Liasion (who had to translate for mom) could not hear his response. [REDACTED] told this unit twice during the interview that I was wasting his time. [REDACTED] claims [REDACTED] is the one who slapped his buttocks but could not be anymore specific. This unit asked [REDACTED] multiple times if he had any witnesses and he kept saying no. [REDACTED] made several posts on Instagram about the incident but would not talk to this unit about the posts. He also stated that he is not afraid of being charged (he laughed as he said this) and going to JDC becuase he has friends there. This unit asked [REDACTED] about MS-13 since he has made several references to his "gang" on Instagram and he also drew possible gang signs on a science lab book. [REDACTED] laughed at this unit and said "that is not MS-13, it is another gang." This unit then asked him which one and he laughed and said that it was none of my business. [REDACTED] mom told this unit that [REDACTED] never goes out. [REDACTED] laughed at his mom and said, "she is lying, I go out all the time." [REDACTED] had nothing more to say.

I will send this report to Intake for a petition.

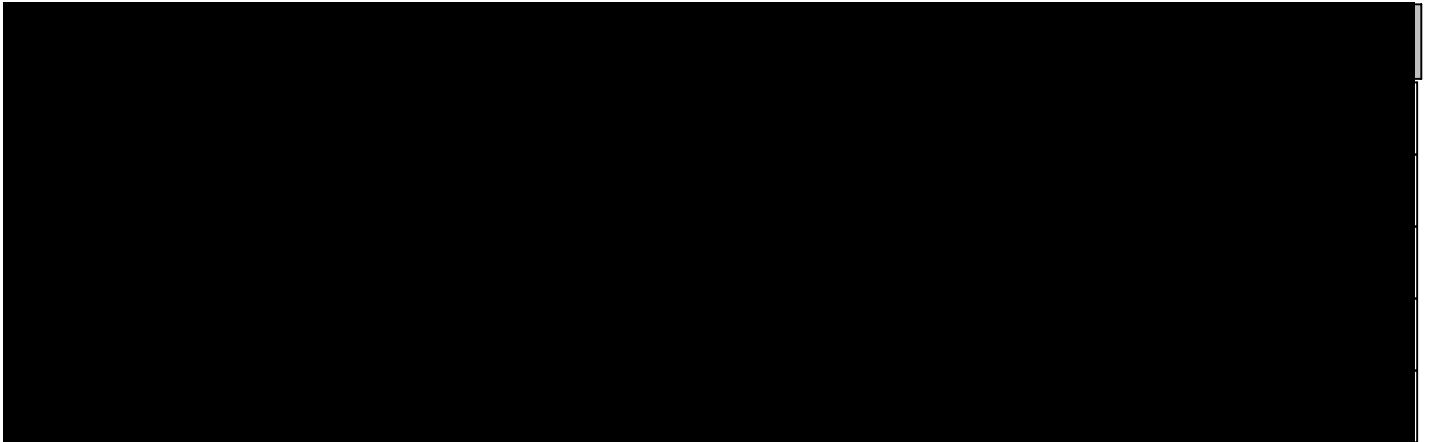

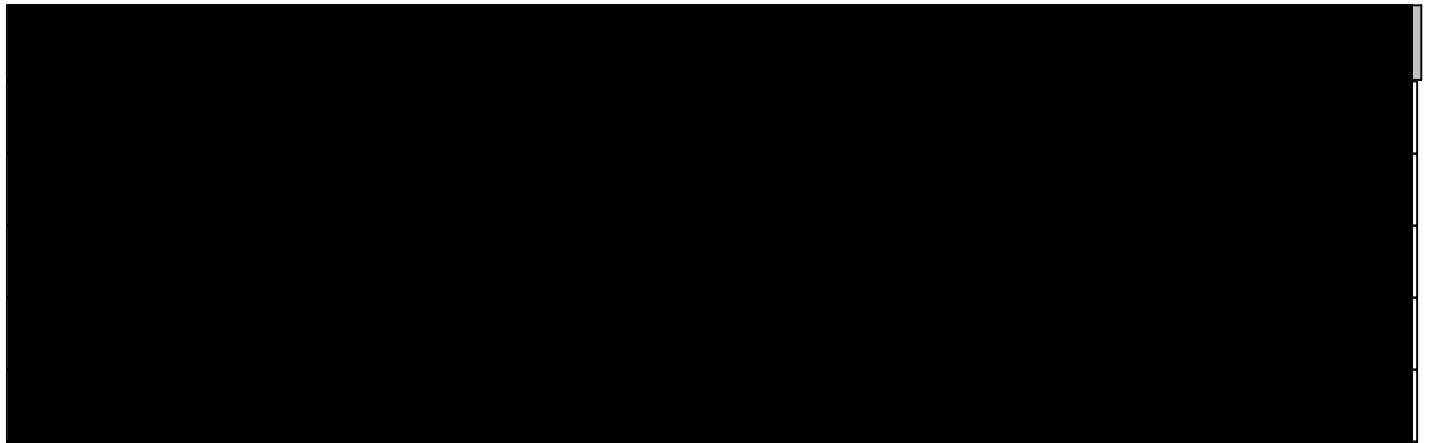
