On 1-8-16 around 1240 hours a 7th grade student, was upstairs play fighting with another male student during the class exchange.
This behavior caused a major commotion in the hallway which prevented other students from getting to class. There were a few teachers in the
hallway that observed this and attempted to get the two boys to class so they could clear up the hallway and let other students get to class. One
teacher, approached and the other male student and asked the boys to stop. Both boys ignored the teacher all five times she
asked them to stop. They continued to play fight down the hallway putting others safety at risk.
began cursing at her. face saying, "Fuck you. Γm going to fucking push you. Γm gonna fuck you up!" Another
teacher had to step in, attempted to redirect however then got in her face and yelled, "Get the fuck away from me. Y'all
keep playing with me and I'll slap the shit out of y'all. I will fuck you all up."
After he got in both teacher's faces and refused to follow directions, he began walking off still cursing. walked by another teacher, and refused to listen to him. Finally an administrator, had to get involved so could get back to their classrooms to teach.
This caused a major disruption upstairs, put student's and teacher's safety at risk, and prevented the teacher's from teaching their classes.
