Notes/Narratives

On 1-7-16, [REDACTED] came to my office to see if anyone turned in his ipod. He told me that he is pretty sure that he lost his ipod on 12-17-15 while walking up the stairs to his 3rd period class. [REDACTED] said his ipod was in his sweater pocket. Towards the end of 3rd period he went to look for his ipod and realized it was missing. He checked the classroom and school lost & found but was not able to locate his ipod. [REDACTED] notified Security on 12-18-15.

During Winter Break on either Wednesday the 23rd or Thursday the 24th [REDACTED] happened to check the "find my iphone/ipod" app and it showed that his ipod was at [REDACTED]. [REDACTED] looked in the student directory and found that a Sandburg student, [REDACTED] lived at that address. His parents did not contact that family or call the police because they were not sure what to do. School Security talked to [REDACTED] who said she had no idea about a stolen ipod but mentioned that her brother might have some information. I contacted the SRO at West Potomac to talk to [REDACTED]. [REDACTED] also mentioned that there is a rumor going around that [REDACTED] is the one who stole the ipod.

I notified [REDACTED] Administrator [REDACTED] of the situation. [REDACTED] talked to [REDACTED] told him he did not know anything about a stolen ipod. Security talked to [REDACTED] on 1-11-16 and [REDACTED] admitted to Security that he took the ipod but claims that [REDACTED] brother took it from him while there were at the [REDACTED] over Winter Break.

I then talked to [REDACTED] and he told me that while he was walking up the stairs to his 3rd period class with [REDACTED], he saw [REDACTED] pick up the ipod and put it in his pocket. [REDACTED] then stated he had no idea what [REDACTED] did with the ipod. Then friday (12-18-15) afternoon when [REDACTED] was at home, he claimed that he received a text message from [REDACTED] that said " I forgot that I put the ipod in your bookbag." [REDACTED] had no proof of that text. He said that he deleted it. [REDACTED] then went on to say that he put the ipod in his pants pocket and tossed both the pants and the ipod into his closet. [REDACTED] said he went to look for the ipod monday and it was not in his closet. He had no explanation as to where the ipod went.

The ipod is the 5th Generation, grey, 32GB, the circle button is broken, and [REDACTED] did not have the serial number. The ipod was valued at \$250. The dark blue rubber case was valued at \$40.

[REDACTED] told me on 1-13-16 that his mother took him to a Pawn Shop (unknow which one) and they bought another ipod. [REDACTED] could not provide anymore details. Parent Liaison [REDACTED] to verify the story, but she too was vague. [REDACTED] was also notified of the pending larceny charges and did not have any further questions.

I plan to send the report and Intake form to JDC in order to obtain a petition for larceny.
