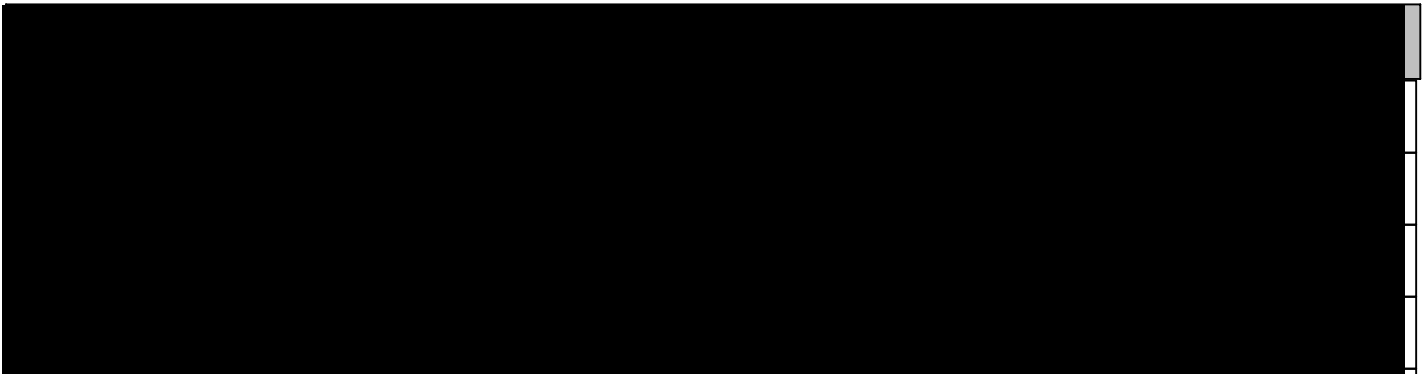

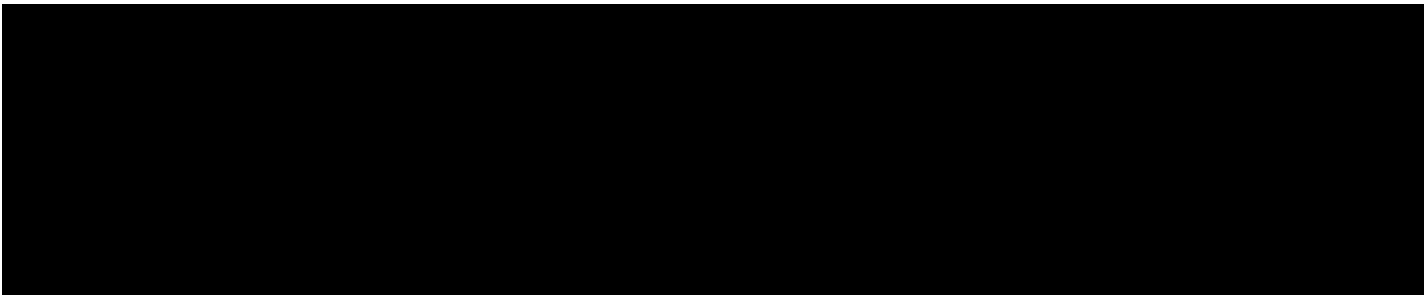

Notes/Narratives

On 1-20-16 a student came up to me and told me about a fight that took place on 1-15-16. This student showed me a video of this fight. The fight took place outside by the buses around 1415hours. I was able to identify the students: [REDACTED] I went to [REDACTED] with this information and the video of the fight. [REDACTED] suspended both girls for 4 days. This fight caused a huge crowd to form around the girls blocking other students from getting onto their buses safely. There were about 40 students that gathered around to watch and video tape this fight.

I was finally able to talk to both of the students on 2-1-16, after the Blizzard which caused school to be closed for 7 days.

Both girls told me that that fight was over a boy. Each student thought the other one was talking about them. School Security attempted to talk to both girls earlier in the week about their "issues".

[REDACTED] and I have contacted her P.O. and her legal guardian.
