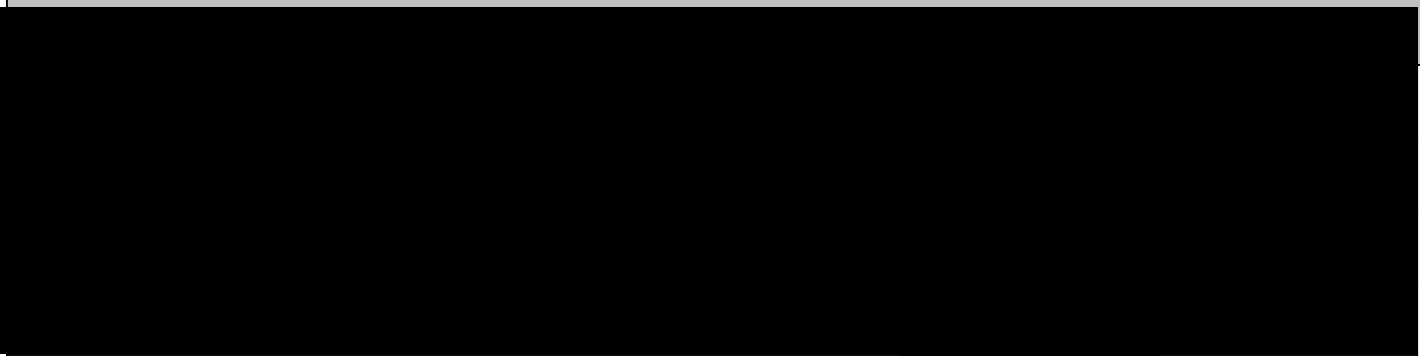

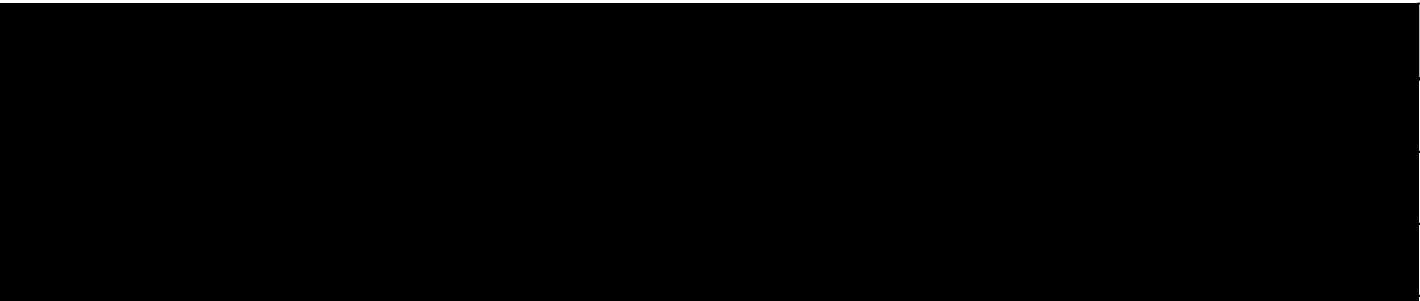

Notes/Narratives

On 1-14-16, [REDACTED] came to my office to report that one of the microphones that was assigned to his classroom was stolen. All teachers are given a set of 2 microphones. [REDACTED] was on leave on 1-13-16 and when he returned the next day he discovered one of the microphones was missing. School Security and I talked to several kids in the classroom. Our lead suspect was [REDACTED]. [REDACTED] gave us several stories as to what happened. Finally he admitted that he took the microphone. [REDACTED] claims that the day after we talked to him he returned it. [REDACTED] has never located that microphone.

School Security made several attempts to contact [REDACTED] parents but has had no success. I also tried all the phone numbers in SIS. They were either disconnected or not inservice. I also tried to send an email but it was returned to me. I left a voicemail for [REDACTED] but I am not sure if he will get the message.
