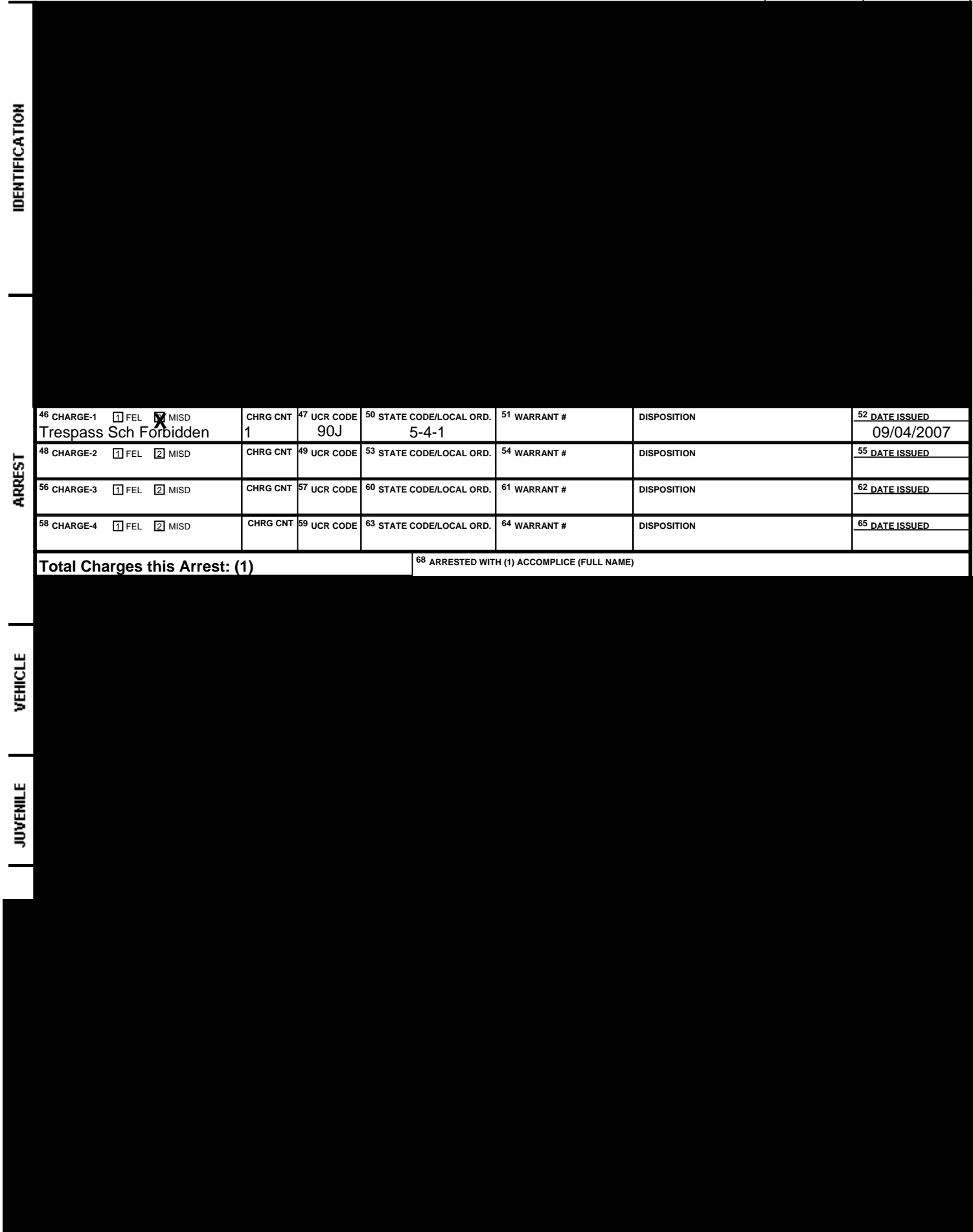

On 12/13/2016 I was on patrol southbound Fort Hunt Road when I observed a white four door Honda [REDACTED] pull in to Carl Sandburg Middle School at approximately 2320 hours. Shortly after, I observed the vehicle attempt to leave the school. I conducted a stop on the vehicle for trespassing and identified the driver to be [REDACTED], who was also the only occupant. I requested a form of identification from [REDACTED] who stated that he had a learners permit, but not with him. His identification was confirmed via dmv.

I asked him if he was aware of the rules that follow having a learners permit. He advised that he was limited on passengers and that he needed a licensed driver in the car, which he did not. I then asked why he was at the school after dark. His response was that he used to attend the school and was taking a trip "down memory lane" and said "I know I shouldn't be here." [REDACTED] was cited without incident for trespassing and no ol. He could not contact a licensed driver to move the car, so it was towed by Redmans. Tow form will be scanned to this report. [REDACTED] refused to relinquish the car keys to anyone and said to just have the tow truck driver drag it. No further action taken.
