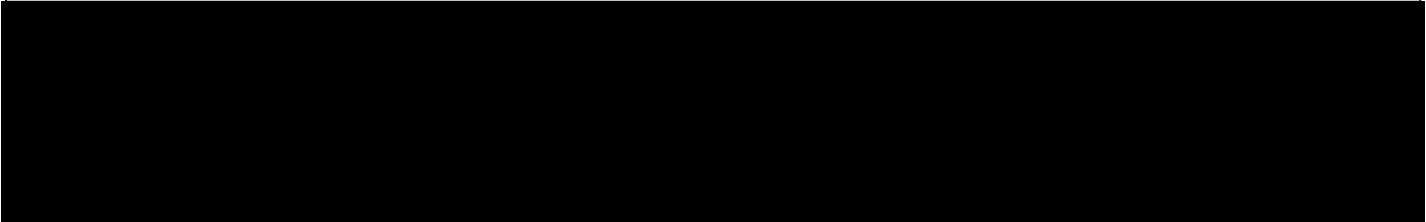

Notes/Narratives

On 2-24-16, I was notified by School Security that a female student, [REDACTED] smoked some marijuana on the bus ride to school on 2-23-16. Several students reported this to School Security. School Security [REDACTED] searched [REDACTED] bookbag and locker. During the search [REDACTED] located a green leafy substance that was rolled up in white paper. This green leafy substance was in her bookbag.

Pictures were taken of the green leafy substance. On 2-24-16 around 1235 hours a field test was conducted and it tested positive for marijuana. The marijuana was packed and stored at Station 2.

I contacted [REDACTED] mom on 2-24-16 around 0940 hours and then I interviewed [REDACTED] claims she did not know what the substance was and said she got it from her grandmother's house back in November or December 2015. [REDACTED] said it was just sitting in the ashtray at her grandmother's house. [REDACTED] said that she forgot it was in her bookbag. [REDACTED] and another student, [REDACTED] made plans the night before to meet at the bus stop to smoke. There were several conversations on [REDACTED] where the two students made plans. [REDACTED] provided the lighter and [REDACTED] smoke the marijuana on the bus. They tried to roll down the bus windows but the smell was too strong.

The report and Intake form was sent to JDC Intake for a petition: possession of marijuana.
