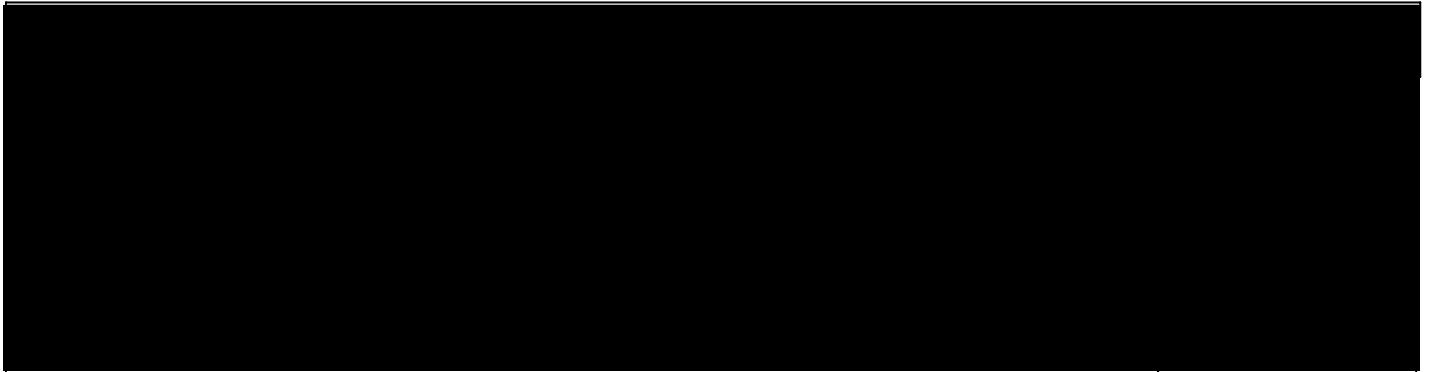

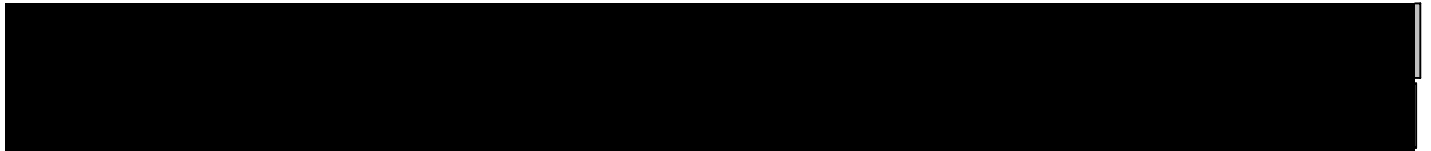

## Notes/Narratives

On 2-29-16, an [REDACTED] [REDACTED] came to my office to report that she was assaulted earlier in the day. [REDACTED] was in [REDACTED] classroom during 4th period ([REDACTED]). Around 1105 hours, [REDACTED] (8th grader), threw a small soft ball at [REDACTED] and it hit her in the face. [REDACTED] was absent this day but there was a substitute teacher in the classroom. The class had finished their work for the day and the students had some time to make up other work or do their homework. Earlier in class [REDACTED] asked [REDACTED], "What would you do if someone threw a ball at your?" [REDACTED] did not respond. [REDACTED] then proceeded to throw the ball. [REDACTED] admitted to throwing the ball and laughed aout it. [REDACTED] to step out in the hallway. [REDACTED] did not want to talk to him in front of the class. [REDACTED] asked him, "what were you thinking?" He said he was playing around and continued to laugh about it. [REDACTED] took him to room 221 and called for School Security.
