

Notes/Narratives

On 3-9-16, [REDACTED] (teacher) was standing in the hallway during class exchange time making sure students were walking to class and behaving appropriately. There was an 8th grade student, [REDACTED], who ran as fast as he could down the 400 hallway between 7th and 8th period. [REDACTED] was outside his classroom (441) when he observed [REDACTED] run past three teachers and completely ignore the teachers telling [REDACTED] to stop. [REDACTED] stepped in front of [REDACTED] to get him to stop before he hurt another student because he completely ignored directions from three other teachers. [REDACTED] then pushed [REDACTED] and said, "Get the fuck off me before I kick your fucking ass."

[REDACTED] immediately wrote a referral and sent it to [REDACTED]

[REDACTED] was allowed to come back to school on 3-10-16. On 3-10-16, [REDACTED] was wondering the halls with some friends while the pledge of allegiance started. [REDACTED] asked the group to be quiet but they continued to talk and be disrespectful. Then there was the moment of silence and the group continued to talk even after being asked to be quiet. [REDACTED] then tells [REDACTED], "Shut up before I tear your fat ass up."

[REDACTED] wants to press charges for assault. I will send this report and the Intake form for processing. Nothing further at this time.
