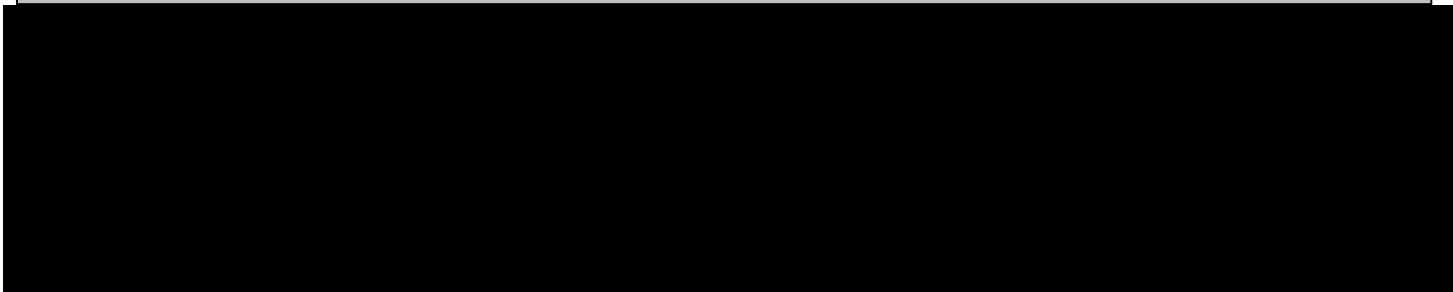

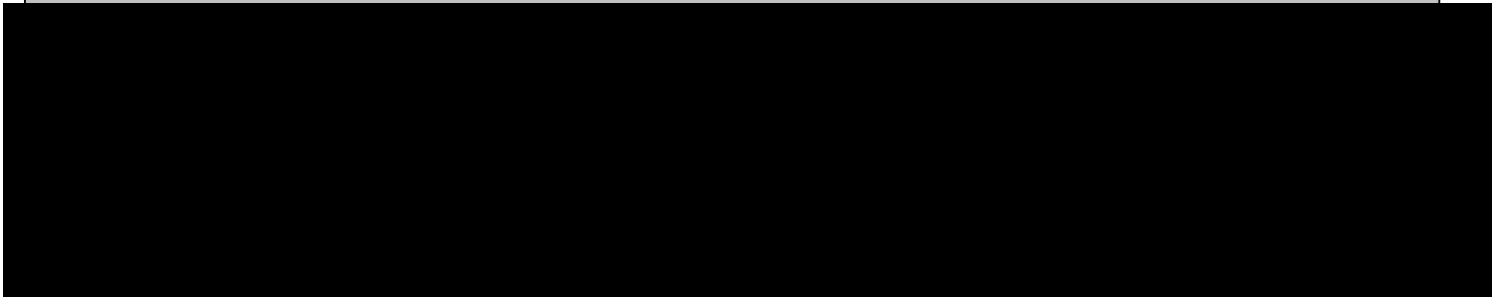

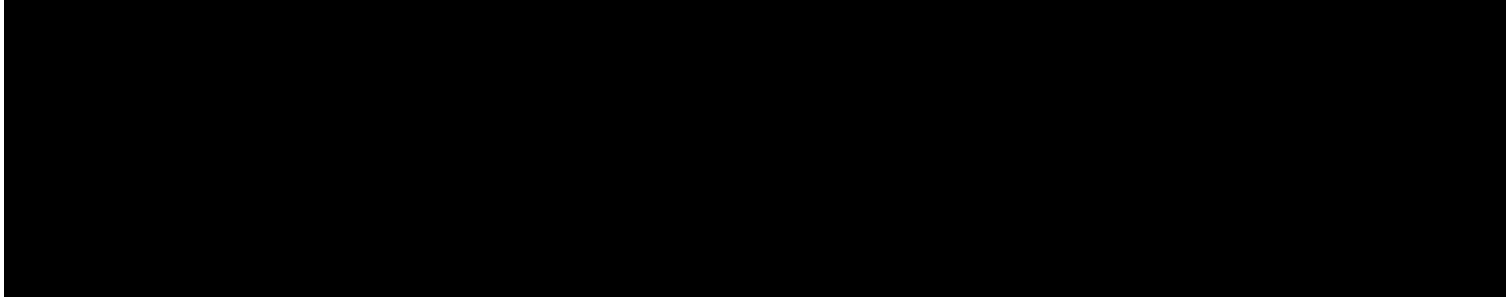

## Notes/Narratives

On 3-18-16, [REDACTED] (8th grader) came to my office to report that two female students logged onto in personal Instagram account and posted a fabricated personal bio page for everyone to view without his permission or knowlegde. The female students [REDACTED] - 8th graders) posted the following: "I m gay and am staying out of the closet (emoji smiley face) yes I m gay & I have a girlfriend...Got a problem??! Fight me! Locker 1738 (two emoji pictues of a knife) combination 35 \* 45 \* 11."

[REDACTED] immediately began receiveing text messages from other students in the school and students came up to him asking him about his bio page. [REDACTED] did not know what those girls did until other students began coming up to him.

[REDACTED] both wrote inappropriate responses to comments that his real friends had written about this fabricated bio. They also sent this fabricated post out to a sports team chat that [REDACTED] is a part of, which is a big part of his life.

After I talked to [REDACTED] and notified the parents either by email or phone I told all three of the students to not confront each other, try to apologize, etc. I told them they need to let things calm down and let the system do what it is intended to do. I was later informed that the girls went up to [REDACTED] in English class and gave him a hard time about moving forward legally.

[REDACTED] parents wish to press charges for computer harassment. I have sent the report and Intake form to Juvenile Intake for processing for a Diversion Hearing. Nothing further at this time.
